#### FIRST DAY.

#### SENATE CHAMBER, BISMARCK, NORTH DAKOTA, June 1, 1892.

#### A JOINT RESOLUTION

In relation to the speedy passage by the Congress of the United States of the so-called Dolph Land bill for relief of certain settlers in the Red River valley, State of North Dakota.

WHEREAS, The St. Paul, Minneapolis & Manitoba Railway company, a corporation organized under the laws of Minnesota, acquired title to certain lands in the valley of the Red River of the North in the then territory of Minnesota, now State of North Dakota, by the timely construction of certain lines of railway, in accordance with the provisions of certain acts of congress, approved March 3, 1857 (11 U.S. Statutes at Large, 195) and March 3, 1865 (13 U. preme Court of the United States, filed December 22, 1890; and, WHEREAS, Subsequent to the acquisition of such title and prior to its confirmation, a large and meritorious class of citizens, now residents of this

State, settled upon, improved and paid for said lands the government price charged for lands under the pre-emption and homestead laws of the United States, in good faith, supposing said lands to be unappropriated public domains, subject to acquisition under said laws, and received patents therefor from the government, and,

WHEREAS, The bill now pending before congress (Senate Bill No. 3134) will, if passed and carried into effect, allow said St. Paul, Minneapolis & Manitoba Railway company to relinquish all its claim and title to said lands, and to select in lieu thereof other lands, vacant and unappropriated, and situated in states or territories along the lines of said railway, and will render such settlers secure in the enjoyment of their homes and their property, and prevent the institution of legal proceedings for their ejectment from lands upon which they have erected homestead improvements costing many hun-

dreds of thousands of dollars; now, therefore, Resolved, By the Senate, the House concurring, That our Senators and Representatives in Congress be earnestly requested to use their utmost endeavors to effect the speedy passage and approval of said bill. Resolved. That the Governor be and is requested to forward copies of

these resolutions to our Senators and Representatives in Congress.

STATE OF NORTH DAKOTA, TREASURER'S OFFICE.

BISMARCK, June 1, 1892.

To the Senate of the State of North Dakota:

In reply to your inquiry as to the condition of the general fund of the State at this time, and asking for an estimate of the condition of same on the first day of January, 1893, I have the honor to submit for your consideration, the following:

In round numbers the present amount in the general fund is one hundred forty-four thousand dollars (\$144,000). In making an estimate of the receipts and expenditures from now until January 1, it seems that the only basis we can make our calculations from, is from the records of the past. The collections in the general fund for the corresponding period for the

The collections in the general fund for the corresponding period for the year 1891, from May 1 to January 1, were in round numbers, one hundred forty-seven thousand dollars (\$147,000). The expenditures of the State for the past six months have been one hundred sixty-two thousand dollars (\$162,-000) or twenty-seven thousand (\$27,000) a month, and taking this as an average our expenses until January 1, 1893, will be one hundred eighty-nine thousand dollars (\$189,000); add to this twenty-three thousand dollars (\$23,000) of the unexpended World's Fair appropriation, ten thousand (\$10,-000) school for deaf mutes, ten thousand (\$10,000) for the soldiers' home and the probable cost of this special session ten thousand (\$10,000), we find our total expenditures to be two hundred forty-two thousand dollars (\$242,000).

Our balance at the present time, together with our probable receipts from now until January I, will be two hundred ninety-one thousand dollars (\$291,000), thus leaving an estimated surplus of forty-nine thousand dollars (\$49,000) in the general fund on January 1, 1893.
