The organization of both houses was effected promptly at noon and the members were sworn in by Chief Justice Shannon. As the preliminaries of the organization had been arranged the night previous, there was little else than routine work to go through with. By one o'clock each body was in working

George H. Walsh, of Grand Forks, elected president of the council, occupied the same position at the last session nd as he then performed his duties to the entire satisfaction of those over whom he presided, it is safe to say that he will not be found lacking in this in-

Dr. J. A. Harding, of Lawrence, chosen speaker of the house and he gives evidence of being an individual who fill the position admirably. He starts off in a business like manner and is credited with possessing good staying

COUNCIL.

Tuesday, Jan. 11.-The members of the council assembled at their chamber in the court house at 12 m., and were called to order by Dr. J. A. Martin. member from the Black Hills district.

On motion of Mr. Gamble, John L. Jolley, of Clay county, was requested to call the roll of members and perform the duties of chief clerk until that office should be filled by election.

After the administration of the oath and the signing of the same by the m bers, prayer was offered by Rev. J. W. Trimble, rector of Christ's Episcopal church.

The president pro tem. then ann ed that nominations for the position of president of the council were in order.

Mr. Fisher, of Cass county, nominated Geo. H. Walsh, of Grand Forks county. Mr. Wilson, of Lawrence county, nom-inated M. H. Day, of Bon Homme

Mr. Walsh was declared duly elected president of the council, and upon being conducted to the chair the oath of office was administered to him by Chief Justice Shannon.

On motion of Mr. Shaw a committee of three members was appointed to act with a like committee on the part of the house to prepare joint rules for the gov-ernment of the two houses when in joint

Messrs. Shaw, Smith and Scoby were ppointed as such committee on the part of the conneil.

On motion of Mr. Day the rules of the last council were declared in force until new rules are adopted.

On motion of Mr. Gamble the chief clerk was directed to inform the house of the organization of the council.

On motion of mr, Doy the council adjourned until to-morrow at 10 o'clock.

The house was called to order at noon by E. P. Wells, of Stutsman county. in the absence of the chief clerk of the last house.

Upon motion of Mr. McBratney, of Lawrence county, S. A. Boyles, of Yankton county was made temporary chairman and G. H. Dickey, of Barnes county, temporary clerk.

Prayer was offered by Rev. E. J. Brownson, of Yankton.

On motion of Mr. Wells, the roll furnished by the secretary of the territory was adopted and read as the roll of the house.

Chief Justice Shannon, having been duly notified that the house was organized, administered the oath to the mem bers thereof and after the oath had been igned, business was proceeded with.

The temporary chairman announced that the house was now ready for the election of a speaker and Dr. J. A. Harding, of Lawrence county, was put in nomination by L. B. French, of Yankton county. Dr. Harding was elected by a ous vote, the democrats having no candidate in the field.

The newly elected speake ducted to the chair by Mr. French and Mr. Warner, and the oath of office was administered by Chief Justice Shannon

At this juncture the missing members Isaac Moore, of Union county, and W. H. Donaldson, of Deuel county, announced their presence upon the floor of the house, having just arrived upon the one o'clock train. They were sworn in

Speaker Harding took occasion to thank the house for conferring upon him the distinguished honor of its choice for a presiding officer. He promised to be perfectly fair in all his committee appointments and to be perfectly impartial so far as his judgment permitted him to be. He then announced that the house was ready for business.

The election of a chief clerk was next in order. Frank J. Mead, of Burleigh county, was the nomince of the republican caucus and his election was a fore gone conclusion. Mr. Donaldson, of the eighth district, having just arrived on the train, and there being no opportunity to inform him regarding the action of the caucus, presented the name of T. A. Kingsbury, of Codington county, as candidate for the chief clerkship. The vote stood: Meade, 18; Kingsbury. Mr. Mead was declared elected and was sworn in in due form.
