Fourteenth Session-Ninth Day.

Session Notes IN THE COUNCIL.

The council committee on elections has under consideration the contested case from the eleventh district, wherein J. F. Wallace, republican, makes application for the seat occupied by P. R. Smith, democrat. The committee held its first session yesterday afternoon and was again in session this afternoon. A large amount of testimony has been prepared for consideration. Bartlett Tripp appears before the committee as attorney for Mr. Smith and F. J. Cramer for the contestant.

Mr. Scobey gaye notice in the council to-day that he would introduce a bill to create a board of immigration for the territory. We will give a synopsis of the bill as soon as it is introduced.

The council this morning sat down very hard on the house resolution authorizing the chief clerk of that body to subscribe for five copies of a daily paper or their equivalent in weeklies for each member, the cost thereof to be paid out of the territorial treasury. Nine members of the council, by their votes this morning, indicated that they were in favor of giving the house members the privelege of buying their own papers

Councilman Shaw's penitentiary bill psssed the council this mornrng, and was sent to the house for the concurrence of that body. It locates the institution at Sionx Falls.

## Conneil.

Wednesday, January 19-The council met at 10 o'clock a. m., and was called to order by the president.

REPORTS OF COMMITTEES.

Mr. Jolley, from the committee on engrossed and enrolled bills, reported that council bill No. 1, relating to the employment of assistant clerks, had been presented to the governor.

The same gentleman, reporting the house joint resolution in regard to newspapers for the members, recommended that the same be not passed.

Mr. Shaw, from the committee on charitable and penal institutions, reported back council bill No. 8, providing for the location and construction of a territorial penitentiary, with amendments and recommending its passage as amended. The amendments reported by the committee were adopted.

Mr. Martin, of the special committee composed of the members from the Black Hills, to whom was referred the bill providing for extra compensation to the judge of the first judicial district, reported the same with amendments and a recommendation that it pass. Report adopted.

### INTRODUCTION OF BILLS.

SECOND READING OF COUNCIL BILLS. Council bill No. 7, authorizing the board of county commissioners of Lincoln county to settle with and accept from George W. Nayler, ex-county treasurer of said county, such sum as they may deem advisable. The bill was referred, after certain amendments moved by Mr. Kennedy, to the committee on enrollment and engrossment.

## RECESS.

On motion of Mr. Van Osdel the house took a recess for twenty minutes.

## AFTER RECESS

Moved that Hon J P Kidder who was on the floor of the house, be invited to a seat with the speaker of the house. Motion carried and Mr. Boyles and Mr. Inman as a committee introduced Mr. Kidder to the chair, and the speaker introduced him to the members of the house.

COMMITTEE REFERENCE.

The committee on ways and means, to whom house bill No. 8 was referred, reported certain amendments and Mr. Boyles moved that the bill be referred to a commrttee of the whole house.

Mr. Baynes made an effective speech, in favor of the passage of this bill without delay. He had proceeded to some length with his argument when Mr. Wells called Mr. Baynes to order, on the ground that he was speaking on the original question instead of the amendment. The speaker ruled that Mr. Baynes was out

But, on motion of Mr. LaMoure, it was shown to be the choice of the house that Mr. Baynes be allowed to proceed with his remarks, which he did, and on closing, Mr. Dickey moved that the bill be referred to committee of the whole and considered one week from to-day.

After remarks from Mr. Inman, oppcs ing the motion of Mr. Dickey, and remarks of Mr. Wells and Mr. Boyles in favor of such motion, the motion was lost as amended by Mr. Dickey-nays 14; ayes 10.

Mr. French presented on argument in favor of further deliberation on this bill and some further remarks pro and con followed.

The motion of Mr. Boyles, referring the whole to be taken up and considered in its regular order, was carried-ayes 17; nays 7.

SECOND READING OF HOUSE BILLS House file No. 10.-More definitely defining the boundaries of Lawrence county, read and referred to the committee on towns and counties.

House file No. 11-Read and referred to the committee on corporations.

House file No. 12-Read and referred to the committee on judiciary.

House bill No.15-Read and referred to the committee on judiciary.

## UNTINISHED BUSINESS.

Under a suspension of the rules the reort of the committee on penal and charitable institutions, recommending the passage of the bill providing for the construction and erection of a jail for Lincoln county, was adopted.

A motion to suspend rules and send the bill to its third reading and final passage, was moved and seconded, and a motion to lay this on the table was lost -15 nays; 8 ayes.

After further argument the motion to suspend rules was lost, by 20 navs and 4
