The amounts referred to in this section shall not be used for any purpose other than to fund noncontributory retirement programs for state employees. If the forty-seventh legislative assembly does not provide by statute for noncontributory retirement programs for state employees, such amounts shall remain in each salaries and wages line item until such line item is canceled on July 30, 1983.

SECTION 8. APPROPRIATION. There is hereby appropriated out of any moneys in the general fund in the state treasury the sum of \$200,000, or so much thereof as may be necessary, to the main experiment station during the biennium beginning July 1, 1981, and ending June 30, 1983, for the purpose of defraying the expenses of research in the areas of edible bean breeding and calf scours. General fund moneys are to be used only in the event of a reduction and only to the extent of such reduction in the receipt of federal funds by the main experiment station. The main experiment station shall not expend funds pursuant to this appropriation without the approval of the legislative council's committee on budget.

SECTION 9. APPROPRIATION. There is hereby

#### STATEMENT OF PURPOSE OF AMENDMENT:

#### Extension Division

Salaries and wages of the Extension Division are increased by \$561,847 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. The salaries and wages line item amount of \$14,198,048 includes \$74,000 for the state to fund a conversion to a noncontributory retirement plan for employees. The estimated income line item is reduced \$249,678 to reflect a correction in the funding for salaries and wages. The reduction made to the salaries and wages line item in the executive budget should have been offset by reductions to the general fund and estimated income, rather than a reduction entirely from the general fund.

#### Main Experiment Station

salaries and wages of the Main Experiment Station are increased by \$1,110,444, of which \$473,777 is from other funds and \$636,667 is from the general fund, to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. The salaries and wages line item amount of \$23,136,304 includes \$764,541 for the state to fund a conversion to a noncontributory retirement plan for employees. Operating expenses are increased by \$139,182 from the general fund to reflect a correction of the executive budget. The estimated income line item is decreased by a total of \$860,211, which is arrived at as follows: a reduction of \$1,333,988 is to reflect a correction in the funding for salaries and wages, as the reduction to the salaries and wages line item in the executive budget should have been offset by reductions to the general fund and estimated income, rather than a reduction entirely from the general fund; and an increase of \$473,777 is to reflect the additional income available for the addition to salaries and wages for the salary increases mentioned earlier.

It is the intent of the Legislative Assembly that the funds appropriated in the new section for calf scours research be utilized in the study of nutrition and environmental problems as they relate to calf scours problems.

It is also the intent of the Legislative Assembly that the Main Experiment Station place greater emphasis on research efforts regarding false chamomile.

#### Dickinson Experiment Station

Salaries and wages of the Dickinson Experiment Station are increased by \$27,421 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. Salaries and wages are also increased by \$9,871 from the general fund to reflect a correction in the calculation of temporary and part-time salaries. The salaries and wages line item amount of \$572,387 includes \$16,052 for the state to fund a conversion to a noncontributory retirement plan for employees.

#### Hettinger Experiment Station

Salaries and wages of the Hettinger Experiment Station are increased by \$8,539 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium. Salaries and wages are also increased by \$2,745 from the general fund to reflect a correction in the calculation of temporary and part-time salaries. The salaries and wages line item amount of \$178,073 includes \$5,003 for the state to fund a conversion to a noncontributory retirement plan for employees. Operating expenses are increased \$12,029 from the general fund to reflect a correction of the executive budget.

#### Langdon Experiment Station

Salaries and wages of the Langdon Experiment Station are increased by \$10,096 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium. Salaries and wages are also increased by \$6,671 from the general fund to reflect a correction in the calculation of temporary and part-time salaries. The salaries and wages line item amount of \$210,667 includes \$5,817 for the state to fund a conversion to a noncontributory retirement plan for employees. Operating expenses are increased \$11,684 from the general fund to reflect a correction of the executive budget.

#### North Central Experiment Station

Salaries and wages of the North Central Experiment Station are increased by \$14,588 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. Salaries and wages are also increased by \$4,707 from the general fund to reflect a correction in the calculation of temporary and part-time salaries. The salaries and wages line item amount of \$304,433 includes \$8,554 for the state to fund a conversion to a noncontributory retirement plan for employees.

### Williston Experiment Station

Salaries and wages of the Williston Experiment Station are increased by \$16,201 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium. Salaries and wages are also increased by \$814 from the general fund to reflect a correction in the calculation of temporary and part-time salaries. The salaries and wages line item amount of \$338,181 includes \$9,635 for the state to fund a conversion to a noncontributory retirement plan for employees. Carrington Experiment Station

Salaries and wages of the Carrington Experiment Station are increased by \$25,822 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. Salaries and wages are also increased by \$3,795 from the general fund to reflect a correction in the calculation of temporary and part-time salaries. The salaries and wages line item amount of \$556,504 includes \$15,806 for the state to fund a conversion to a noncontributory retirement plan for employees. Operating expenses are increased by \$45,800 from the general fund to reflect a correction of the executive budget. The executive budget did not take into consideration the emergency commission action of the 1979-81 biennium which increased operating expenses due to increased costs of energy, fertilizer, and leases for off-station sites.

#### Agronomy Seed Farm

Salaries and wages of the Agronomy Seed Farm are increased by \$8,768 to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. Salaries and wages are also increased by \$1,492 to reflect a correction in the and wages line item amount of \$182,931 includes \$5,180 for the state to fund a conversion to a noncontributory retirement plan for employees.

### Central Grassland Research Station

Salaries and wages of the Central Grassland Research Station are increased by \$9,677 from the general fund to provide funds for the continuation of the 10 percent emergency salary increase and for salary increases of nine percent for the first year of the biennium and eight percent for the second year of the biennium. The salaries and wages line item amount of \$201,920 includes \$5,767 for the state to fund a conversion to a noncontributory retirement plan for employees.

The aggregate amount of such borrowings at any time shall not exceed the amount of uncollected taxes which have been levied during the year in which the borrowing is made, plus uncollected taxes remaining upon the tax lists of the four preceding years, exclusive of levies for the purpose of retiring bond issues and the interest thereon, plus funds to be received under currently existing bureau of Indian affairs contracts. In the case of townships, the aggregate amount of borrowing is as provided above and also the total amount levied or to be levied for the total number of years authorized under section 57-15-20.1. For the purpose of borrowing, all such taxing districts may issue certificates of indebtedness. A certificate of indebtedness shall consist of an agreement on the part of the taxing district to pay a stated sum on a specified date, or on or before a specified date not more than twenty-four months in the future, or in the case of townships issuing certificates of indebtedness payable from amounts levied under section

of indebtedness payable from amounts levied under section 57-15-20.1 on or before a specified date not more than five years in the future, together with interest thereon at a rate or rates resulting in an average annual net interest cost not exceeding eight percent per annum if they are sold privately, which may be made payable semiannually. Such certificate shall be signed on behalf of the taxing district by its president or chairman and also by its auditor or secretary, and shall be payable out of funds derived from uncollected taxes levied for the current tax year and four previous years which have not been set aside for the payment of other certificates of indebtedness pursuant to sections 21-02-07, 21-02-08, and 21-02-09 and from funds received under bureau of Indian affairs contracts currently existing and from funds to be received from taxes collected under section 57-15-20.1. However, a certificate of indebtedness shall be the general obligation of the issuing taxing district.

SECTION 2. AMENDMENT. Section 21-02-03 of the 1979 Supplement to the North Dakota Century Code is hereby amended and reenacted to read as follows:

21-02-03. CERTIFICATE OF COUNTY AUDITOR CERTIFICATE OF INDEBTEDNESS - WHEN INCONTESTABLE. A tax shall be deemed to have been levied when it has been voted by the tax levying board and certified to the county auditor. Each certificate of indebtedness shall bear the certificate of the county auditor to the effect that it, together with all other outstanding certificates, is within the amount of uncollected taxes which have been levied lawfully in the then present year, plus uncollected taxes of the four preceding years, plus amounts to be received under currently existing bureau of Indian affairs contracts and in the case of a township, plus the amount to be levied for the number of years authorized under section 57-15-20.1. Such certificate of indebtedness shall possess no validity unless it bears such certificate of the county auditor. The county auditor shall make such certificate according to the facts. When so executed with the prescribed certificate signed by the county auditor, a certificate of indebtedness shall be fully negotiable and shall be incontestable, except upon the ground of fraud on the part of the holder or original payee or connivance between the holder or the original payee and an officer or officers of the taxing district concerned. In the hands of a holder in due course, the execution of a certificate of indebtedness by the proper officials shall be conclusive evidence that the issuance thereof was duly authorized by the governing board of the taxing district.

SECTION 3. Section 21-02-06 of the 1979 Supplement

to the North Dakota Century Code is hereby amended and reenacted to read as follows:

CERTIFYING AMOUNT OF UNCOLLECTED TAXES 21-02-06. AND MONEYS UNDER BUREAU OF INDIAN AFFAIRS CONTRACTS. The county auditor at any time, upon request of the officers of any taxing district, shall certify to them the amount of uncollected taxes remaining upon the tax lists to the credit of such district and the amount still owed to the county under currently existing bureau of Indian affairs contracts on the last day of the preceding month and the amount to be collected by a township under section 57-15-20.1, and annually shall certify such information to the clerk of each township on February fifteenth, to the auditor of each city on September tenth, and to the clerk of each school board on June tenth. The county auditor also shall certify to the clerk, auditor, or secretary of each such taxing district monthly, at the time of making the monthly apportionment of funds, the

amount of cash collections apportioned for that month to such taxing district and the amount derived from levies of each tax year."
