Rep. Gerl requested that his remarks be printed in the Journal, which request was granted.

Rep. Gerl: "Mr. Speaker and Members of the Assembly: I rise on a point of personal privilege and request that my remarks be printed in the Journal:

"By now I am sure that most of you know that I am involved in the labor movement. I take great pride in the AFL-CIO and the fact that I am the State president. And I take greater pride that the Governor of this state has proclaimed the week of November 15 as "Labor's Centennial Week" in recognition of the American labor movement and the AFL-CIO

"In part, Governor Olson's proclamation reads:

'The desire of union members for the opportunity to enjoy the fruits of their labor led to community rejection of the exploitation of women and children, the lowering of discriminatory bars, the establishment of workers compensation and unemployment compensation programs, pension and retirement plans, occupational safety and health laws, and

other benefits: and

'This continuing responsible advancement of its members' interests and progressive involvement in the democratic concerns of our society have contributed much to the progress of our state, its social vigor and its quality of life.'

"The proclamation also states that:

'From its beginning, the unified American union movement has been guided by the ideals enunciated by Samuel Gompers, the first president of the AFL -

"The goals and ideals of Mr. Gompers are the same that we have today. When asked in 1893, what does labor want?, Mr. Gompers

replied:

We want more school houses and less jails; more books and less arsenals; more learning and less vice; more constant work and less crime; more leisure and less greed; more justice and less revenge; in fact, more of the opportunities to cultivate our better natures...

"As I mentioned before, these were our goals in the early years and they are the same today, regardless of some of the sensationalism that you see in the press today. I want to thank the Governor for this proclamation and my colleagues in this Assembly for their attention and understanding."
