POINT OF PERSONAL PRIVILEGE

REP. BACKES: Madam Speaker: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

Madam Speaker, Members of this assembly ...

Recent Court actions regarding the validity of an election contest in district 42 forces us to reexamine the decision of this body to seat Michael Hamerlik as State Representative of the 42nd district.

The validity of the election was challenged due to an administrative error of the Grand Forks county auditor which resulted in the votes of 526 District 42 residents not being counted.

The auditor's error was to place one voting machine guidebook intended for another precinct in the Winship precinct.

As a result, the location of the names of candidates in five of the guidebooks was opposite the order on the sixth machine. As these ballots became punched by the voter and deposited and commingled in the ballot box, it became impossible to determine which candidates these individuals had intended to vote for.

Before going further, I want to state loud and clear that the Democratic-NPL majority in this House shares the outrage experienced by those voters who, for no fault of their own, had their ballots thrown out. The fact that an administrative error has effectively disenfranchised 526 voters is a very sorry statement on the election laws and procedures of this state.

I believe each member of this assembly recognizes the right to vote as one of the most important rights an individual has under our system of government. It falls upon all of us as members of the 48th Legislative Assembly to address this crucial failure of the election laws as they are presently constituted. We simply cannot continue to allow the incompetent mistakes of our election officials to take away the votes of conscientious constituents.

However, the ruling of the District Judge in the challenge to district 42 presents this body with several complex questions.

The judge's order declared that the election certificate issued for Mike Hamerlik be annulled and set aside and the seat declared vacant. It is important to note that the Court's ruling came after Mr. Hamerlik was seated as a member of this legislative assembly during the presession.

To my knowledge, this is the first time a North Dakota Court has ordered a seated member of the North Dakota legislature to be removed from the assembly. Each house of the state legislature is responsible for the ultimate decision of the seating of its members. Any judicial involvement in questions involving legislative elections must recognize this basic fact.

It is clearly provided in the state constitution which states, "Each house shall be the judge of election returns and qualifications of its members." This authority is at the foundation of the separation of powers and has never been questioned by any ruling of the North Dakota Supreme Court.

However, this assembly chooses to address this troubling situation in district 42, we cannot recognize the portion of the District Court order which declares the seat of Hamerlik vacant after he has been seated by this assembly. It is the position of the House that Mr. Hamerlik will remain a seated member of this assembly until such time as his seat is declared vacant by a vote of this assembly.

These statements should not be interpreted as meaning the Courts do not have a proper function in ruling on election issues. I have said many times that the legislature has shown itself to be a poor judge of who shall be seated. When we were the minority party, there were times when the resolution of election contests was decided on political grounds rather than the merit of each particular case.

We have fashioned our recount statutes to involve the judicial branch in interpreting questions of fact and law in extremely close elections. The distinct feature of this process, however, is that the legislative assembly still has the final say over which members are seated.

In the matter before us, we will look to the order of the Court for guidance as to the legal questions presented by the unfortunate facts of this election.

There are several legal questions raised by the ruling of the District Court. The resolution of these questions by the Supreme Court would be of great assistance to this assembly in determining whether the problem can be effectively addressed.

These questions include the following:

- May election officials and canvassing boards determine who a winning candidate is when an administrative error prevents the board from counting X number of ballots and that number is greater than the margin of victory between the candidates?
- 2. Does the governor have the authority to issue a special writ of election providing for the county auditor to administer an election of only the 526 voters whose ballots were not counted?
- 3. If so, does the legislature have the authority to compel the governor to issue a special writ to provide a remedy for the voters who were wrongfully disenfranchised?

The most apparent alternative to leaving Mr. Hamerlik provisionally seated pending the ruling of the Supreme Court on the action of the District Court is to vote to unseat Mr. Hamerlik. While this may be justified due to the fact that the margin of victory was less than the number of uncounted ballots, this option has serious shortcomings. If we should take this step, by operation of statute, the seat would be declared vacant and a special election would have to be called by the governor. Under the statute, this would be a districtwide election.

All the people in district 42 who voted in the general election would be effectively disenfranchised by this action, in that district 42 would be under-represented in the assembly which would conduct much, if not all of the business of this session, before an election could be completed and the seat filled.

It is, therefore, the intention of the House to withhold any action on this matter at this time. We have the right to reexamine this matter in the future. As Representative Strinden stated in the presession of the 1977 session, "We do reserve the right to judge qualifications of our members...every one of us is provisionally seated."

It is our hope the Supreme Court action will be instructive as to the legal issue raised by this contest. We hope that this ruling is rendered as quickly as possible so that we may consider its implications as early in this session as possible.

It is also the hope of the majority caucus that in resolving this appeal the Court will carefully consider and actively seek to provide meaningful remedies for the 526 disenfranchised voters. Although we have areas of difference with the ruling of the district court as outlined earlier, we applaud his attempt to protect the right to vote for all who choose to exercise it in district 42. It is our hope that the resolution of the judicial questions will assist this House in arriving at a means to correct the unacceptable loss of vote for 526 individuals at Winship precinct.

To deny Mike Hamerlik this seat because of the disenfranchised voters in this election would mean that we would have to hold elections all over the state. There were several disenfranchised voters and specifically in the Senate seat in Williams County where they threw out many, many votes. Regardless of the eventual outcome of the district 42 case, obviously we must change our election laws regarding the training of election officials. That is the biggest problem. We've got to do something about it because we're going to be faced with it every time if we don't. So, I hope that part of the pledge of this assembly is to change the training of election officials.

Now, obviously we need changes in our election laws regarding uniformity of ballots. Right now I don't believe there's any law stating what kind of form the ballot has to have, but every county seems to be picking a new type of ballot. At least we've got punch ballots in one place and we've got a different type in Ward County, and paper ballots in some rural districts. Somehow this legislative assembly must examine the election laws and solve the problems which exist.

Thank you, Madam Speaker.

REP. STRINDEN: Madam Speaker, ladies and gentlemen of this assembly: I compliment and commend Representative Backes for the position that he and the members of the majority party are taking on this matter.

I do believe that we must, as members of the legislative branch, always be very jealous and very protective of our constitutional rights and responsibilities as a separate and equal branch of government. Representative Backes has outlined that very well. We should never make decisions of a momentary nature on matters such as this because precedents are established. What may help one party in one election may turn around to hurt that same party in the next election because of the precedent that was set.

Mike Hamerlik is a fine individual who was an innocent victim. He did nothing wrong. The errors were made by someone else. Five hundred twenty-six voters were disenfranchised but it behooves us always to think of the many thousands who did vote and whose votes were counted and who would be disenfranchised if we should seek another course. I share with Representative Backes completely the need to legislate during this session such changes in our statutes which will prevent this type of thing from happening ever in the future.

REQUEST

REP. STRINDEN REQUESTED that his remarks in response to Rep. Backes be printed in the Journal, which request was granted.

REP. BACKES MOVED that the House stand in recess until 1:45 p.m., which motion prevailed.

JOINT SESSION

The Joint Session of the House and Senate convened at 2:00 p.m. with Speaker Kelly calling the Session to order.

MOTIONS

REP. BACKES MOVED that the Speaker appoint a committee of two to escort Lt. Governor Ernest Sands to the rostrum, which motion prevailed.

SPEAKER KELLY APPOINTED Reps. C. Anderson and Watne to such committee, and the Lt. Governor was escorted to the rostrum.

Speaker Kelly presented Lt. Governor Sands to the Assembly and turned the gavel over to him.

REP. HILL MOVED that a committee of two be appointed to escort Bishop Roy Gilbertson and Bishop Hilary Hacker to the rostrum, which motion prevailed.

PRESIDENT SANDS APPOINTED Rep. Conmy and Sen. Miller Heinrich to such committee, and Bishops Gilbertson and Hacker were escorted to the rostrum.

SEN. LEE MOVED that a committee of two be appointed to escort Mrs. Barbara Olson to a special reserved seat in the Assembly, which motion prevailed.

PRESIDENT SANDS APPOINTED Sen. Lodoen and Rep. R. Meiers to such committee, and Mrs. Olson was escorted into the Assembly.

SEN. REDLIN MOVED that a committee of four be appointed to escort the State Officials to the rostrum, which motion prevailed.

PRESIDENT SANDS APPOINTED Sens. Wenstrom, Heigaard, and Reps. Kretschmar and Mushik to such committee, and the State Officials were escorted into the Assembly.

REP. RILEY MOVED that a committee of four be appointed to escort Justices Paulson, Pederson, Sand, and VandeWalle to the rostrum, which motion prevailed.

PRESIDENT SANDS APPOINTED Reps. Unhjem, G. Pomeroy, and Sens. Lashkowitz and Stenehjem to such committee, and the Justices were escorted into the Assembly.

SEN. TODD MOVED that a committee of two be appointed to escort Chief Justice Ralph J. Erickstad to the rostrum, which motion prevailed.

PRESIDENT SANDS APPOINTED Sen. Nelson and Rep. B. Larson to such committee, and Chief Justice Erickstad was escorted to the rostrum.

SEN. ADAMS MOVED that a committee of two be appointed to escort Governor Allen I. Olson to the rostrum, which motion prevailed.

PRESIDENT SANDS APPOINTED Sen. Nething and Rep. Strinden to such committee, and Governor Olson was escorted to the rostrum.

The Program was called to order with Lt. Governor Ernest Sands presiding.

The colors were presented by the Northern Lights Council Boy Scout Troop 11.

Wade Tschaekofske of the Northern Lights Council led the Assembly in the Pledge of Allegiance.

The invocation was offered by Bishop Roy Gilbertson.

Our heavenly Father, we are very thankful for the privilege of serving the State of North Dakota in this very special way. Help us to exercise this privilege in a responsible manner.

Lord, give us faith. Faith that your hand of benediction will rest over all that we do. Faith that our partners on both sides of the aisle are as dedicated and sincere as ourselves. Faith that somehow through our human limitations we may accomplish good things together. Faith that our legislative, judicial and executive branches of government can work together for the good of all.

Lord, give us hope. Hope that justice may prevail for all of our people. Justice for the farmer and rancher, the teacher and the student, the Indian and the White, the rich and the poor, management and labor, young and old, whole and handicapped, plaintiff and prosecutor, buyer and seller.

Above all, give us love. Love for all the people in the world. Love for our heritage. Love for those in authority. Love for our State of North Dakota and what it has given us. A deep love of God and His creation. Love that expresses itself in service to others. Love that is patient and kind, not jealous or boastful, not arrogant or rude, not irritable or resentful. Love that never ends.

Faith, hope and love, may these three abide throughout this session of the Legislature so that those who follow us in the years yet to come will look back at our work here and say, 'Well done, good and faithful servants!'

In the name of Christ, our Lord, Amen.

Governor Allen I. Olson was introduced, and he then presented his State of the State Address to the Session.

MESSAGE TO THE LEGISLATURE BY ALLEN I. OLSON Governor of North Dakota

Ladies and gentlemen of the 48th Legislative Assembly, officers of the executive and judicial branches of state government, citizens, friends and family:

It is my constitutional responsibility to inform you of the condition of the state. I will also offer specific measures for your consideration which I believe, if enacted, will benefit the people of our state.

As elected officials we share temporary custody of government. None of us take this responsibility lightly. While it is in our custody we are duty-bound to respond as best we can to the needs of our citizens.

Our response this session will be measured by the wisdom we apply, the bipartisan cooperation we establish, and the commitment we make to the people of North Dakota to meet difficult problems head-on.

The full text of my message to you presents the state's condition under five broad categories of responsibility. Fiscal responsibility affects all other areas and in most cases provides the basis for resolution to our problems.

Contraction rather than expansion of our fiscal reserves is the reality of today. Providing the basic services reasonably expected of a state government has never been easy in a large yet sparsely populated state like North Dakota. But we have managed before and we will again. Throughout our history we have dealt with economic cycles and their consequences. This time, there is a difference. Over the past decade the federal government has invested heavily in social and economic programs administered through state government. We are now being gradually but clearly weaned from these programs, the process of which will be difficult to all concerned. The budget I have delivered to you reflects my initial judgments on fiscal priorities. I am confident that with your involvement and assistance, basic programs will continue at an acceptable level.

This year I drew on the talents and resources of the private sector for a comprehensive review of major agencies and departments of state government. The review produced 200 recommendations over half of which have been wholly or partially implemented. Substantial dollar savings will result. Several of the recommendations require legislative action. I recommend that you give these proposals careful consideration and favorable action.

During the past calendar year reorganization of social and health programs required by the 1981 Legislature was accomplished. Twenty-nine separate service areas were consolidated into eight cohesive regional Human Service Centers. This consolidation will produce by the end of the biennium between 6 - 9 million dollars in general fund savings. Administrative costs in the Highway Department will be reduced by more than 4 million dollars annually through administrative reorganization. Licensing, registration and regulation of motor vehicles has been reorganized and improved. Specific legislation in this area is included for legislative review and action. Your consideration and approval of these proposals is requested. Relocation and reorganization of oil and gas regulation under the Industrial Commission which I proposed and which was accepted by the 1981 Legislature has been completed at considerably less than the budgeted cost.

While much has been done during my administration to improve the efficiency of state government, more can be done. Vehicle registration fees should be simplified and registration dates staggered to provide better service at less cost. Restrictive and unnecessary regulations should be reviewed and revised. Administration of personnel management can be improved by consolidating all agency personnel officers under a single authority. I support the legislation consolidating the state's personnel system for two reasons: (1) it represents sound personnel management when our large, diversified workforce is considered, and (2) it will save approximately one million dollars per biennium. I also support the legislation to update and refine the state's personnel system that resulted from the interim budget study. The present personnel system was implemented in 1975. It has received little attention since that time. It is time to expand flexibility and fix accountability managing the state's workforce. Improved personnel for management can be as beneficial to government as it is to private businesses. While it may not be possible or appropriate to run government exactly like a business, there is no doubt that good business practices can save money and improve service.

The revenue shortfall was disruptive. It also provided an opportunity to reflect upon and respond to the proliferation of programs and the increased costs of government. The shortfall offered the opportunity to review, revise and reduce the costs of providing governmental programs and services. State agencies directly accountable to me were required to reduce expenditures an initial 5 percent and subsequently another 10-15 million dollars. State agencies were also required to reduce out-of-state travel and association memberships. The reduction of dues and memberships alone saved nearly 200 thousand dollars.

Hiring of new and replacement state personnel was significantly reduced. Salary increases to state employees were limited to an average 4 percent with special emphasis on performance for those receiving increases. This action is in keeping with my message to the 1981 Legislature which noted that salary increases were not intended to be automatic and that managers would have responsibility to evaluate employee performance and pay levels. Motivated employees are the key to responsible, responsive state government. The basic framework is in place to achieve consistent, improved employee compensation.

Fiscal responsibility required that this budget be less than the previous budget. Even with substantial reductions in both current and constant dollars, expenditures could not be matched to expected revenues. General fund revenues under the present tax structure will remain relatively "flat" at the balanced budget level. In order to fund the necessary aid programs to local governments and individuals, and to meet the costs of other basic state programs, an increase in sales and motor vehicle excise tax by one percent is recommended. Other revenue increases and adjustments determined by this body would generate revenues sufficient to fund the basic state programs and services.

One such adjustment that has received considerable attention since I delivered the budget last month is the acceleration of collection of taxes such as sales and severance taxes. Monthly rather than quarterly collections would recoup two of three month's collections otherwise deferred to the following biennium. An additional amount of approximately 50 million dollars would be available on a <u>one time</u> basis in whichever biennium it is effective. I am favorable to such an adjustment but only if these <u>one time</u> dollars are applied toward the 50 million dollar general fund balance I deem appropriate or to non-recurring expenditures. An appropriation of some of these <u>one time</u> dollars to elevate the per pupil foundation payment for this year to \$1,400 would, in my view, qualify as a non-recurring expenditure. But, I hasten to caution that we not trap ourselves and the taxpayers of North Dakota into spending these one-time dollars for new or expanded programs that will then demand more future spending.

Economic growth and diversification is another major responsibility. Such growth has not been an easy accomplishment during these difficult economic times. We are, nevertheless, making every effort to enhance North Dakota's economic position and visibility, while providing for long-term, stable growth. Economic development is important because it provides jobs for North Dakota people and expands our tax base.

Agriculture is and always will be the backbone of North Dakota's economy. The depressed state of the farm economy affects this state disproportionately in view of the fact that most North Dakotans are relatively dependent on the agriculture economy. The situation we face is partly a result of world economic conditions. There is a worldwide recession. The demand for our food and fiber has been eroded by this recession. Since our quality of life is dependent upon and most directly affected by agriculture, actions and programs that will help promote the sale of our products should be stressed by both of our respective branches of state government. We must press for the long-term grain agreements with the Soviet Union and others. Imposition of reasonable quotas on imported agricultural products such as sugar, which keep prices for our products low should be encouraged.

My agricultural policy is grounded on three principles marketing, research and soil conservation. I firmly believe that we must be creative and initiate our own trade opportunities. Stepped up agricultural research is important if we are to capitalize on our agricultural resources. To the extent possible under difficult fiscal circumstances I have included funding in the Executive Budget Recommendation for continued and new research capabilities. Our soil is the nation's treasure. My budget recommendation proposes state financial support to soil districts for soil technicians to assist farmers in putting conservation practices on the land.

In order to stabilize agricultural production and place claim on water to which North Dakota is entitled, we must also actively pursue irrigation development. Aggressive development of water distribution systems is essential to the future stabilization of North Dakota agriculture and the growth and well-being of our farms and cities.

Total dedication to the survival of North Dakota's farm and ranch families must be a high priority for all of us. In all programs that I influence or control as Governor, every opportunity for economic survival will be given whether in the form of loan programs or assistance in marketing and processing the products of our farms and ranches. At the national level I will continue to speak out for agriculture and those programs which will ensure the continuation of the most prolific food producing system the world has ever known.

Neither the world nor this country can afford to allow the deterioration and decline of American agriculture. That is the message that must penetrate. The politicians in Washington and consumers must ultimately come to this realization and act accordingly. I know that the legislature and people of North Dakota will join me in this crusade.

High interest rates and an uncertain economic future have caused business expansion activity to decline. We can, however, point to 70 new plants and plant expansions in the last two years. These new plants and expansions represent 84.8 million dollars in capital expenditures and have created more than 800 jobs.

These totals do not reflect the huge Great Plains Coal Gasification Project now under construction near Beulah. This 2.2 billion dollar project is the largest single development project now under construction in the entire nation. It employs over 3,000 workers during the construction phase and will provide permanent employment for more than 500 when completed.

In addition to the Great Plains Project, other plants have been constructed to process our natural resources. Two gas processing facilities have been built, two are in the permitting process and eight others are being considered by interested firms. Plants have been constructed to process agricultural products here at the point of production saving transportation and other costs. North Dakota now hosts major sunflower plants, two of which reuse steam produced in electric generation to conserve energy and save on related costs. Confection sunflower seeds are being processed and flax processing has been added to one of the large sunflower processing plants.

North Dakota has achieved results even in these difficult economic times. Continued economic growth will depend on how well we capitalize on our heightened visibility and inherent human and natural resources. To capitalize on these inherent strengths we must continue and expand research related to those strengths; slow outmigration of our talented people; expand existing markets and identify new ones; assist domestic business and industry while we work to attract others to North Dakota; and encourage growth of value-added processing and manufacturing. Continuation of these multi-faceted efforts designed to broaden our economy and the state's tax base is crucial to the economic future of our state.

New concepts such as Foreign Trade Zones which would allow foreign businesses to operate and manufacture products without paying duty on the products until they are sold illustrate areas that should be considered by a state that is determined to progress rather than stagnate. The future course of North Dakota's economy can be influenced. Introspection and planning, optimism, and research, and success and hardwork - all play a part. Especially in this time of economic uncertainty, North Dakota must not lose sight of the future. In the plans and dreams of today lie the future of tomorrow.

A third area of responsibility concerns human resources and needs. Reorganization of Human Service Programs is the centerpiece of the most comprehensive state government reorganization of our state's history. We have restructured and improved the delivery of social and health programs through the new Department of Human Services. The realignment of available professional and fiscal resources, essential in meeting vital human service needs, has resulted in reduced administrative costs and increased efficiency in service delivery. The consolidation will result in general fund savings of between six and nine million dollars this biennium. A major issue facing us in the delivery of human service programs is the deinstitutionalization of the residents of the Grafton State School and the San Haven Hospital. This issue has been influenced by the lawsuit filed by the Association for Retarded Citizens of North Dakota. An Order issued by the U.S. District Court directed changes at both the Grafton State School and the Hospital. It also directed the state to reduce the total institutional population to approximately 250 residents by July 1, 1989. The practical effects of the Order would require the state to construct several new and costly residential buildings at Grafton some of which may not be needed after the resident population is reduced. The ruling by the U.S. District Court is being appealed.

Notwithstanding the ARC litigation, real progress has been made on developing a continuum of community care and service to meet the needs of the developmentally disabled and chronically mentally ill citizens. On July 1, 1981, the resident population of the combined institutions was 1,040. By the end of this biennium, we project the resident population will be approximately 868. To meet the legislatively established 1987 goal, an additional 305 residents must be integrated into community programs by July 1, 1985. If successful, the combined population of Grafton and San Haven will be 550 to 600 by July, 1985. The unexpected economic conditions require that we accomplish these objectives with restricted resources. In light of current revenue limitations, my proposed budget makes available those resources necessary to the accomplishment of appropriate objectives.

A fourth area of state responsibility falls under the broad category of natural resources. We are a state with bountiful natural resources. Productive soil, clean air and water, open spaces, plant and animal life, mineral and energy resources, all are and will continue to be available if treated with respect. North Dakotans understand their special relationships to the land, air and water around them.

Through adequate planning and sound management, we can strike that balance needed to make intelligent use of our natural resources while safeguarding those resources for future generations.

Many of the uses of fresh water are key components in our economy. It is therefore critical that North Dakota establish and vest our legitimate claims to Missouri River water. We must ensure that changing attitudes of downstream users do not pirate our share of that water.

We must be firm in our position that a compact exists among the Missouri River Basin states - it has existed for nearly 40 years - in the form of the Congressionally approved and mandated Missouri Basin Program which resulted in a major allocation of the waters of the Missouri. Included in this compact is a commitment to the development of a comprehensive water

distribution system for North Dakota's farms and cities. The Garrison Project remains the single most important means for establishing our priority right to Missouri River water. Real progress has been made toward resolving long standing issues including mitigation and Canadian concerns. Phased construction and a new mitigation plan brings our state closer to realizing benefits promised 40 years ago.

The preliminary design study for pipeline delivery of water from Lake Sakakawea to southwestern North Dakota, as authorized by the 1981 Legislative Assembly, has been completed under my supervision. As a result of this study, design alternatives and financing options are now available for legislative review. I have included 6 million dollars in my Executive Budget for final design and land acquisition costs for the selected alternative. I encourage the legislature to authorize the initiation of these preconstruction activities. Considerations for the generation of additional revenues will be necessary for project continuation beyond the preconstruction stage.

The national initiative for decreasing this country's dependency on foreign energy sources has and will continue to have a significant impact on the State of North Dakota. Development of our oil, coal, and natural gas resources is continuing, although at a slower pace than previous years. As supported by the people of North Dakota and by previous administrations, I will maintain a comprehensive natural resources policy, including cautious, orderly development.

North Dakota is a leader in land reclamation research and air, water and land quality standards. A recent example is North Dakota being the only state in full compliance with federal clean air standards. We can be proud of this accomplishment and I am committed to continuation of this tradition. I fully support further research into site specific reclamation plans, which consider local soil characteristics, topographic features, and water availability. It is essential that our reclamation needs continue to be met even with anticipated reduction in federal funds. Consolidation and monitoring of these programs can offset reduced funding. A reasonable level of funding for continued reclamation research is included in my budget recommendations.

Issuance of the first North Dakota Habitat Stamp for national sale will likely generate over a half million dollars. The opening of state school lands to walking access by sportsmen will provide expanded recreational opportunity for the public and may lessen the pressure for private land access.

The last area of responsibility to be discussed is basic services. This area of responsibility includes education, law enforcement and our highway system. Education traditionally generates vigorous discussion and some controversy among the interested parties. This year has been no exception. Our educational system has fulfilled traditional North Dakota goals while successfully relating to a changing, dynamic society. I pledge my continued support to this educational system which has provided North Dakotans with the basic foundation for careers of leadership throughout the nation and the world. To keep pace with our elementary and secondary needs and with rising costs, an increase in the per pupil foundation payment at least to \$1,400 for this biennium is recommended. A 10 percent increase is included in my budget recommendation for special education services because these programs mean so much to citizens who have few other sources of assistance.

Quality education must continue to be made available to North Dakotans during this period of fiscal constraints. It is important, therefore, that we develop and implement approaches that address real needs. Identifying those approaches will require patience and careful deliberation. In the process we should identify and eliminate duplicate programs and services where they may exist. In this way, we can ensure that available funds will be channeled in the direction most beneficial to the people of North Dakota.

North Dakota has developed and is maintaining one of the best highway systems in the nation for a state of our size and population. Our present system represents a 4.5 billion dollar public investment. Maintaining this investment is vital to the economic well-being of our state. Aging of the highway system and the escalation of highway maintenance costs, causes a deterioration in the system that exceeds the state's ability to adequately maintain and preserve the system. During this legislative session we must respond to this problem and provide for a significant increase in highway maintenance and preservation efforts.

Deterioration is not limited to state highways. Units of local governments are also faced with the need for a major reinvestment in roads, streets and bridges. Funding for highway maintenance and preservation is a major priority. I therefore urge that the level and sources of funding provided for in my budget recommendation be given favorable consideration. While I remain an advocate of direct funding for township road needs under normal economic circumstances, the difficult fiscal situation indicated that such assistance could not be available for the 1983-85 biennium.

Railroad branch line abandonment has become a problem which threatens the very existence of many country elevators. We will continue to oppose <u>all</u> proposed abandonments to ensure that all legal and procedural protections are available to preserve an adequate, comprehensive transportation system for North Dakotans.

A primary responsibility of government is the safety and security of our citizens. Traffic fatalities are one of our major problems. Alcohol has been determined to be a major contributor to this problem. Our enforcement program called RAID has been

very effective and the Governor's Task Force on Drinking and Driving has identified specific areas where strengthening the law could deter some problems. I ask that you carefully review the proposed legislation and give it favorable action.

Regulation of the gambling industry is a major task. The Attorney General has established a strict enforcement policy of the gambling laws. In order to police the gaming operations statewide, the Attorney General requires both the authority and resources to supervise this industry. I request favorable consideration be given to the gaming enforcement appropriation level I have requested in my budget recommendation.

An extensive remodeling program, authorized by the 1981 Legislature has been initiated at the State Penitentiary. This program of capital improvements is needed. I have proposed in my budget recommendations that the program be continued. Improvements in the penitentiary facilities are needed to avoid future litigation which could force actions that would not necessarily be in the interest of North Dakota.

To be an effective tool for the people of North Dakota, state government must adapt itself to a continually changing world and environment. It is important that the occupants of public office change periodically. This is particularly true of the executive branch of state government. I propose an amendment to the State Constitution be presented to the voters which would limit the governor and lieutenant governor and all executive branch state constitutional officers to two successive terms in office. This amendment should be presented to the voters at the 1984 general election and that the amendment affect the 1988 election. In addition the voters should decide through a Constitutional Amendment whether the office of State Treasurer is necessary for the effective conduct of state government.

As I close I cannot help being a bit philosophical. This biennium many difficulties were encountered in meeting the responsibilities of state government. These difficulties were addressed with timely and decisive action which mitigated the adverse impacts. Real progress has been made toward increasing the efficiency and effectiveness of state government in the delivery of basic services. As the trustees of government we must continue to provide for the delivery of essential services in the most effective manner.

Good management is not glamorous - it requires tough decisions and a commitment by the people that they do in fact want efficient government but not a proliferation of government.

Our decisions will be increasingly difficult as we continue to face fiscal and political pressures. We will be functioning in an environment of scarce fiscal resources. We cannot rely on the federal government for financial assistance as we have in the past. It just isn't going to be there.

JOURNAL OF THE HOUSE

To meet the challenges of the future we must be prepared to make difficult choices. We will be forced to set aside our personal options and side with the realities of the issues. We must decide now if we are for the well-being of the people, or for the well-being of ourselves. There is no way that we can accommodate everyone. Let's make sure that we render decisions that benefit the majority of North Dakotans.
