MADAM SPEAKER: Your Committee on Agriculture to which was referred HB 1223 has had the same under consideration and recommends by a vote of 17 YEAS, 0 NAYS, 0 ABSENT AND NOT VOTING that the same BE AMENDED AS FOLLOWS and when so amended, recommends the same DO PASS:

- On page 1, line 1, after the word "Act" insert "to create and enact subsection 12 of section 63-01.1-02 of the North Dakota Century Code, relating to the definition of township road; and"

 - 12. "Township road" means a public road which is an improved road, constructed, maintained, graded, and drained by the township, or county in the case of an unorganized township. A township road includes a street in an unincorporated township and does not necessarily have to be surfaced. A sodded road is not a township road. In order for a section line to be a township road it must be graded and drained and be an improved maintained road. A township road is a public road which is not designated as part of a county, state, or federal aid road system and is not located in an incorporated city."

 - "SECTION 2. AMENDMENT. Subsection 1 of section 63-01.1-06 of the 1981 Supplement to the North Dakota Century Code is hereby amended and reenacted to read as follows:
 - 1. The board of county commissioners may pay expenses from the general fund in any one year in furtherance of this chapter, including weed control along public highways in the county. The county weed board may certify annually to the board of county commissioners a tax, not to exceed two mills on the net assessed valuation of all taxable property in the county, to carry out the provisions of this chapter.

However, the tax shall not be levied on property within the corporate limits of a city which establishes a program under section 63-01.1-10.1. The tax shall be the board of county levied by commissioners. All taxes levied and collected shall be remitted to the county weed beard for held by the county treasurer in a separate fund to be known as the weed control fund, which shall be used only to carry out the provisions of this chapter. The levy shall be made to cover the salary and expenses of the county weed board, county weed control officer, the expense of weed control along public highways in the county, and other expenses incurred in the operation of an effective weed control program in the county. The tax may be levied in excess of the mill levy limit prescribed by law for general purposes."

POINT OF PERSONAL PRIVILEGE

REP. GORDER: Madam Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal:

Madam Speaker: I wish to explain my NO vote on the appropriation for the Association of Retarded Citizens lawsuit against the state of North Dakota.

- The amount is excessive.
- I, and many of my constituents, feel the suit was not necessary; for the state was moving rapidly to correct deficiencies in our care of the mentally retarded.
- I resent the incursion of the courts into what I felt was a legislative matter.
- If no opposition is given to this appropriation, who is to say that another class of North Dakota citizens may not attempt a similar action.
- In these difficult times a two-tenths million dollar appropriation needs to be questioned.

Fellow House Members, this appropriation has been a familiar conversation piece over coffee cups in my district and my constituents are not at all pleased with it.

The court systems of our state and nation sometimes question the actions of our legislative branches. I see no harm in questioning the court's actions at certain times.

It is my hope that some of you will vote NO, even though the Appropriations Committee has given this bill a DO PASS. Thank you very much for your courteous attention.

HB 1723: A BILL for an Act making an appropriation to the industrial commission to defray the expenses of the North Dakota state grain export subsidy marketing functions of the industrial commission; and declaring an emergency. read the first time and referred to the Committee on

Appropriations.

Reps. Swiontek, Unhjem, Hughes, Lipsiea, R. Anderson introduced: HB 1724: A BILL for an Act to amend and reenact sections 57-51.1-07 and 57-51.1-08 of the North Dakota Century Code, relating to allocation of moneys in the oil extraction tax development fund and to legislative intent; to provide an effective date; and to declare an emergency.

Was read the first time and referred to the Committee on Education.

Rep. Lautenschlager introduced:

HB 1725: A BILL for an Act to provide for administration by the superintendent of public instruction of grants for the operation of teacher centers designed to develop curricula used in public schools in this state and to assist teachers from public and nonpublic schools; and to provide an appropriation.

Was read the first time and referred to the Committee on Education.

FIRST READING OF HOUSE CONCURRENT RESOLUTIONS

Reps. Serenus Hoffner, Black, Gerl and Sens. Matchie, Heinrich, Kusler introduced:

HCR 3018: A concurrent resolution directing the Legislative Council to study current mobile home and mobile home court laws and regulations, especially as they relate to high winds safety precautions.

Was read the first time and referred to the Committee on Political Subdivisions.

Reps. Linderman, Swiontek, E. Pomeroy and Sens. Dotzenrod, Wogsland introduced:

HCR 3019: A concurrent resolution urging Congress to adopt federal tax incentives similar to those available in North Dakota to assist beginning farmers.

Was read the first time and referred to the Committee on Agriculture.

Reps. Kretschmar, Vander Vorst and Sen. Leibhan introduced:

HCR 3020: A concurrent resolution urging the United States Secretary of Agriculture to place a moratorium during 1983 on Farmers Home Administration farm foreclosure actions.

Was read the first time and referred to the ${\color{red}\textbf{Committee}}$ on ${\color{blue}\textbf{Agriculture}}.$

Reps. Gorder, Retzer introduced:

HCR 3021: A concurrent resolution directing the Legislative Council to study North Dakota's beginning farmer programs and to determine the feasibility of requiring loan applicants to participate in the vocational education adult farm management program of supervised recordkeeping and management assistance.

Was read the first time and referred to the Committee on Agriculture.

Reps. L. Hanson, W. Williams introduced:

HCR 3022: A concurrent resolution directing the Legislative Council to conduct a study of the desirability of adopting the model state soil conservation law in North Dakota.

Was read the first time and referred to the ${\bf Committee}$ on ${\bf Agriculture}.$

Reps. Unhjem, A. Williams introduced:

HCR 3023: A concurrent resolution directing a Legislative Council study of the insanity defense.

Was read the first time and referred to the Committee on Judiciary.

SB 2015: A BILL for an Act making an appropriation for defraying expenses of various commissions, departments, and divisions thereof of the state of North Dakota.

Was read the first time and referred to the ${\color{blue}\textbf{Committee}}$ on ${\color{blue}\textbf{Appropriations}}\,.$

SB 2049: A BILL for an Act to amend and reenact subsection 2 of section 57-51-15 of the North Dakota Century Code, relating to maximum allocations of annual revenues to counties from the oil and gas gross production tax.

Was read the first time and referred to the $\operatorname{\mathsf{Committee}}$ on $\operatorname{\mathsf{Finance}}$ and $\operatorname{\mathsf{Taxation}}$.

SB 2101: A BILL for an Act to create and enact a new subsection to section 20.1-03-12 of the North Dakota Century Code, relating to a nonresident husband and wife fishing license; and to amend and reenact subsections 7 and 8 of section 20.1-03-12 of the North Dakota Century Code, relating to the fees for a nonresident fishing license; and declaring an emergency or, in the alternative, to provide an effective date.

Was read the first time and referred to the ${\bf Committee}$ on ${\bf Natural}$ ${\bf Resources}\,.$

SB 2149: A BILL for an Act to amend and reenact section 54-44-11 of the North Dakota Century Code, relating to office's operating funds creation.

Was read the first time and referred to the Committee on Appropriations.

SB 2183: A BILL for an Act to amend and reenact section 26-34-01 of the North Dakota Century Code, relating to the establishment of primary and excess automobile liability coverages in certain instances.

Was read the first time and referred to the Committee on Industry, Business, and Labor.

SB 2190: A BILL for an Act to create and enact a new subsection to section 43-09-15 of the North Dakota Century Code; and to amend and reenact sections 43-09-05, 43-09-14, and 43-09-20 of the North Dakota Century Code, relating to the value of electrical installations requiring inspection in

municipalities, undertaking and liability insurance for electricians contracting for electrical installations, and reasons for nonrenewal of license.

Was read the first time and referred to the Committee on Industry, Business, and Labor.

SB 2283: A BILL for an Act to amend and reenact section 26-08-11.1 of the North Dakota Century Code, or in the alternative to amend and reenact subsection 6 of section 26.1-05-19 of the North Dakota Century Code as created by House Bill No. 1054, relating to investments in a data processing system by domestic insurance companies.

Was read the first time and referred to the Committee on Industry, Business, and Labor.

- SB 2288: A BILL for an Act to amend and reenact section 15-28-09 of the North Dakota Century Code, relating to filing deadlines and the printing of ballots for public school district elections.
- Was read the first time and referred to the Committee on Education.
- SB 2293: A BILL for an Act to amend and reenact section 55-02-07 of the North Dakota Century Code, relating to the handling and protection of prehistoric or historic artifacts or sites.

Was read the first time and referred to the Committee on State and Federal Government.

FIRST READING OF SENATE CONCURRENT RESOLUTIONS

- SCR 4004: A concurrent resolution requesting the Congress of the United States to again propose for ratification by the states an amendment to the federal constitution to provide that equality of rights under the law would not be denied or abridged by the United States or by any state on account of sex, and that the Congress would have the power to enforce, by appropriate legislation, the provisions of such an article.
