# POINT OF PERSONAL PRIVILEGE

REP. STRINDEN: Madam Speaker: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

Madam Speaker, earlier today, House Bill 1539 was on the Sixth order for consideration. It was a division on the question of accepting or not accepting the amendments.

The Speaker, as presiding officer, kept the board open, the tally board for an unusually long time. This is my ninth

session, I believe. I have never witnessed this type of unacceptable practice at any prior sessions. I truly believe the members of this assembly are supposed to vote on the merits of the amendments of the bills before us, not according to how they observed the tally board.

I would suggest, Madam Speaker, that if this practice should be continued, that we exercise the options available to the House of not having the board lighted, if that option is available, until the board is closed and the vote is to be announced.

It was obvious to everyone here that the Speaker was waiting until votes changed and the directions were being given to the Speaker by the Chief Clerk.

If we're going to keep the board open, allowing for this kind of charade to go on, I would suggest then that the people at the Speaker's desk learn to count in twos or fours or a good deal faster than what we observed today.

Earlier today the Executive Director of the Democrat Party was seated at the desk listening to the tapes which are kept by the desk reporter.

I object, and object strenuously to the interjection of partisan politics to the front desk operation of this assembly.

The equipment that is there is for the use of the House and for the employees of the House. The idea that an executive director of a political party would be using that equipment or listening to those tapes for whatever purpose, is not only unacceptable, I consider it unprecedented; I've never known it to happen before.

There are some things that we should not allow to happen for the good of this assembly. The two things I have mentioned fall into that category. I would trust they won't happen again.

# REP. BACKES: Madam Speaker, members of the House:

I've been here; and this is my twelfth session. Never, never, in those twelve sessions, have I seen so many times, and this is the height of them, where the integrity of the employees, and now the integrity of the Speaker, is challenged.

That is something we do not do. We do not challenge the integrity of each other, or the Speaker of this assembly whom we elected as our Speaker. Whatever the reason that the Speaker kept the key open, it was not to count the votes, and was not for me to count the votes, or for anyone

else. I never asked her what the reason was, but it was not a case of playing games, as Earl Strinden says.

I would hope that this assembly would at least recognize our individual right to differ in politics, without challenging one's integrity.

As far as complaining, he has his facts wrong again. He says that the executive secretary was sitting at the desk. The person that was at the desk, whom he is referring to, is an employee of mine who was asked to get my remarks from the debate of yesterday from the tape. That is how simple it is.

All he would have had to do was come and ask me before he made such a charge on the floor.

He can not find anything wrong with the way the House is run. I believe it is nothing more than petty charges.

I do not like it.

I never did it as a minority leader, to the majority, and I would hope it stops soon.

REP. STRINDEN: Madam Speaker: First let me say, if I am wrong on the situation at the front desk, I will gladly admit it. I will make sure one way or another and will publicly admit it.

The idea that is the first time that such a thing has happened, that someone would arise on the floor and take exception. Goodness sakes, in the years that I've served as majority leader and on a Friday afternoon I'd be driving home and I'd be listening to the radio--on the hour I'd hear that Representative Strinden did this wrong, ran roughshod on this, was a dictator on this. No, ladies and gentlemen, this is far from the first time.

When I get up on the floor in a situation like this, pointing out that the board was kept open, and kept open, and kept open, and kept open, and kept open, it's because I think it's a serious matter. It's not nitpicking. All I'm saying is, if the shoe fits, wear it, and if it doesn't, okay.

I dare say for the people who serve here and I've served here for a good long time, they have not seen that type of a situation in any prior sessions, and neither have I.

Funds are not provided for additional state contributions to retirement.
