## MOTION

## REMARKS OF U. S. SENATOR MARK ANDREWS

It's so good of you to extend for a few moments the courtesy of the floor, and let me add that it will be a few moments. I spent a lot more time in the House than I have in the Senate where they use the filibuster type thing and I recognize how busy you are.

Madam Speaker: I think it is typical of North Dakota to come and address the session of our House where the Speaker is one of our outstanding women and where the Dean of the House is one of the other outstanding women in North Dakota.

It certainly goes in the tradition that is North Dakota. Not only has your work in public service been recognized by having you elected to be the Speaker of this great body, but Brynhild Haugland's fantastic longevity is more than just longevity. It is confidence and capable and caring service over all of those years and I think it shows that the spirit that has been North Dakota for so long still lives in these halls.

I feel closely about that because my grandparents came to North Dakota in Territorial days and my grandmother was one of the first, probably, women doctors in the country, and they practiced together in New York City from 1877 to 1879. I am sure there was no ERA at that particular point in time and a woman doctor was not really recognized in New York City, and they came west to Dakota Territory where they settled in Mapleton three years after

Custer got handled by one of our Natives who wasn't too interested in his political aspirations, called Sitting Bull. She had a great and long and a distinguished time here in our home state.

Actually, those of us who serve in the Legislature, as I just told the Senate, I would hesitate to come here and make any suggestions to you because immediately you would quite properly say, "Hey, Mark, you know, given what's happening down in Washington, straighten that mess out, don't give us too many suggestions out here."

Really, I think that in legislative bodies we face challenges day by day. One of the great challenges, of course, that we face in legislative bodies is to learn how to not just to respond to the problems that keep coming up again and again and again, but to devise and initiate programs that will be good for all time, and to use this government of ours to serve the people.

I don't think that those of us who are trusted with representing the great people of our state in a legislative capacity can shrink away and try to say that government is not good, that government is not competent. Government is good and competent and responsive if we make it that way.

Now, of course, our challenge is from both sides of the political aisle. I think we have to inititate programs that do, in fact, work. A moment ago I was talking about the PIK Program in the other body. I won't do that here, and predict how it is going to work, but I will share one thing with you and that's what all of you recognize, that those of us who are legislators live with frustration because we see the programs that should work or we see areas where there should be programs and the problems remain. They are things that ought to be attended to that are not.

I am a farmer from a farm state at a time when we have surplus production that we're desperately trying to cut back in order to get a little bit better price. I realize how many of the Third World powers in this troubled world of ours, and we're trying to attract their attention, how difficult it is to try to point out to them that our system works better than other systems in this fight for world recognition, or at least it's a fight to get people to go along with the open society that we in the Western world represent.

One of the best strengths, of course, of our argument can be the fact that we can produce enough food to feed ourselves and have enough left over; but here we are in this struggle internationally to win admiration of other countries where hunger runs rampant and we're cutting back food production. So the system somehow or another is falling down. It's falling down right here at home as well.

A week ago last Friday I went into a church in the intercity area of Washington to see how the feeding programs were working. They are not government feeding programs; these are volunteer feeding programs where volunteers from the church go out to the Eastern Market and comb through the dumpsters to find the waste food and cull it through to make some soup and to make the products so that they can serve a nutritious meal.

I ate lunch with those people that noon and one of the interesting things that was said to me by the priest in that church, he said "Senator, you're the fifth senator who has come down to see us but you're the first senator who hasn't come with television cameras," and he said "welcome".

He sat me down at a table and the person who was sitting next to me was a man who had worked all his life at Woodward and Lothrop, which is a department store down there and he retired at age sixty-five. He was now sixty-nine. His wife was ill, their Social Security didn't stretch.

The only place they could get an adequate meal was at this church. I ate with about 125 people like that and I went back into the kitchen to see the volunteers doing their best to cull through the waste food and I found, to my surprise and my chagrin, that there are no government commodities available for programs like that. No government flour for bread. No pasta products for the nutrition that they could represent. No potatoes. No eggs. No cheese. Strictly on their own. What a fantastic opportunity to design a program that will fill those needs.

Senator Leahy from Vermont and myself are holding hearings in Vermont on Monday, which is one of the reasons I went down to see what was actually happening. I'm the chairman, he's the ranking member of the Subcommittee on Oversight and Investigations of the Ag Committee, that covers all of our feeding programs. We're holding hearings in Vermont and then we're going to come out into North Dakota and I think we'll change some of those rules and get ourselves some programs that are in fact responsive.

Another program that bothers me, and that's one that comes along from time to time, and has occurred to you. We've had airline deregulation and everybody says, particularly, I guess, those, Madam Speaker, on our side of the aisle, that deregulation is wonderful because it turns everybody loose and everything works just fine after that.

We deregulated the railroads, we deregulated them, over my objections, and we deregulated the airlines with my support. That was one of the mistakes that I have made, and I have made a number of them.

We've been deregulating so many things and we haven't kept any type of control over this deregulation and now we wake up to find ourselves in the small states, in the small towns with airline transportation that's idiotic. It costs 46 cents a mile to fly from Fargo, North Dakota, to Minneapolis, and then it costs 13 cents a mile to fly from Minneapolis to New York City. That's a bunch of baloney.

One of my colleagues in the Congress represents St. Louis, Missouri. He's in the House. He buys an airline ticket from Washington to San Francisco, flies to St. Louis, throws the rest of it away and saves money. Thirty percent of the people in this country who happen to live in favored cities are flying at below net cost and they're getting all kinds of benefits paid by who? By you and me. We're paying through the nose and I think we have to move toward that terrible bug-a-boo of regulation again, not to crimp the style of the airlines necessarily, but to eliminate these predatory pricing tactics that take advantage of the smaller towns that don't have that many choices and I'll introduce legislation that, very simply, again, I think, is practical.

The airlines tell us it costs about nine percent more, Madam Speaker, to fly a short route for a mile than to fly a long route segment. So we say fine, let's triple that allowance and we have the feeling that we're going to take a try. We may be successful, we may not be, with a very simple re-regulation procedure. That no airline can charge more than 30 percent more per mile for transportation on its most expensive route segment than it charges on its shortest route segment.

Let's move back toward reregulation, all that big boogyman of big government. But I think it meets the challenge of the time and I think it points up one concrete example where those of us who have these responsibilities have to make government work. We can't ignore the problems that keep coming up at us.

It's one of these things, of course, that sometimes makes you wonder whether the whole competition business is as wise as it's cracked up to be, but again, competition exists within government as well. Competition exists or you and I wouldn't be here today.

Many of you, I've campaigned side by side with up and down the streets of your hometowns. Many of you have been on the other side and I've campaigned with your opponent up and down the streets of your hometown, but there is a great deal of respect between the individuals who compete and the most basic necessity of our republic, the electing of people to represent everyone in the legislative bodies.

It's one of the key things that we do, and then when we assemble in our respective bodies, the challenges on our shoulders to make sure that we aren't just trying to have knee-jerk reaction to problems as they come along, but that we do design long-term working sensible programs to serve the test of time.

Madam Speaker, I appreciate so much your providing the opportunity to me to come here to say hello, to congratulate you on the great work that you're doing on behalf of our fantastic state of North Dakota and to say to you, Godspeed and good luck in the great work that you are doing. Thanks for giving me the privilege of being with you today.
