A contingent salary increase of two percent in the second year amounting to \$4,178 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement

Operating expenses of the Public Employees Retirement System are increased by \$643,239. This increase included \$583,239 for additional investment counselor fees and \$60,000 for additional master trustee fees.

    - Upon receipt of an application for an 1. official ballot properly filled out and duly signed, or as soon thereafter as the official ballot for the precinct in which the applicant resides has been prepared, the county auditor, auditor of the city, or elerk of the school district, as the case may be, shall send to such absent voter by mail, postage prepaid, one official ballot, or personally deliver said ballot to the applicant or his agent; which agent may not, at that time, be a candidate for any office to be voted upon by the absent voter, Provided, that the agent signs his before receiving the ballot and deposits with the auditor or elerk, as the case may be; authorization in writing from the applicant to receive such ballot or according to requirements hereinafter set forth for signature by mark- When a properly completed and signed application for an official ballot has been received by county auditor, city auditor, or clerk of the school district, and as soon as the official ballot is prepared, one of those persons shall:
      - a. Send one official ballot to the absent voter by mail; or
      - b. Give the ballot to the applicant or the applicant's agent at the office of the county aduitor, city auditor, or clerk of the school district.
    - 2. An agent who receives a ballot for the applicant:

- a. Shall sign the agent's name before the ballot is received; and
- b. Shall deposit with the auditor or clerk written authorization, or authorization as provided in subsection 5, from the applicant to receive the ballot.
- 3. For the purposes of this section, a candidate for any office to be voted upon by the absent voter may not be the agent for the absent voter.
- 4. No person may receive compensation, including money, goods, or services, for acting as an agent for an elector, nor may a person act as an agent for more than four electors in any one election.
- 2. 5. If there is more than one ballot to be voted by an elector of such precinct, one of each kind shall be included and an envelope shall'be enclosed with such ballot or ballots. Such envelope shall bear upon the front thereof the name, official title, and post-office address of the officer supplying the voter with the ballot, and upon the other side a printed statement in substantially the following form:

I, -----, under penalty of possible criminal prosecution for making a false statement, do solemnly swear that I am a resident of the township of -----, or of the ----- precinct of the ----- ward in the city of -----, residing at ----- in said county, county of ----- and state of North Dakota, and entitled to vote in such precinct at the next election; that I expect to be absent from the said county of my residence on the day of holding such election or that by reason of physical disability I am unable to attend at the polling place for such election, and that I will have no opportunity to vote in person on that day.

If such absent voter is unable to sign his name, he shall make his mark (X) in the presence of a disinterested person. Such

disinterested person shall print the name of the person marking his X below the X, and shall sign his own name following the printed name with the notation "witness to his mark"."

to disabled and handicapped citizens must be accomplished on an individual basis, and that great deference should be given to the professional judgment of qualified professionals as to which types of treatment and education should be afforded each individual; and

WHEREAS, Congress has considered the needs of handicapped and disabled persons and has enacted Section 504 of the Rehabilitation Act of 1973 and P.L. 94-142, the Education for all Handicapped Children Act of 1975; and

WHEREAS, Congress has never provided sufficient funding to the states to bring their practices and facilities into compliance with Section 504 of the Rehabilitation Act of 1973, and P.L. 94-142; and

WHEREAS, state and local governments have been made subject to civil suits and often the payment of plaintiffs' attorneys fees by persons alleging deprivation of their constitutional or statutory rights; and

WHEREAS, the state of North Dakota and its political subdivisions have been confronted with significant expenditures mandated by federal courts following decisions based in part upon these federal laws; and

WHEREAS, federal statutes and federal court decisions are mandating requirements for states in terms of numerical ratios and macroscopic statistics and are setting timetables for implementation;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NORTH DAKOTA, THE SENATE CONCURRING THEREIN:

That the Forty-eighth Legislative Assembly urges the Congress to provide sufficient funding to the states to enable such states and their political subdivisions to fairly undertake the fiscal responsibility for providing facilities and services that are reflective of the rights granted under these federal Acts; and

BE IT FURTHER RESOLVED, that the Forty-eighth Legislative Assembly urges the Congress to amend 42 U.S.C. 1983 et seq. to limit the payment of attorneys fees to reasonable and prevailing rates in the states, and to remove the unreasonable provisions

of the law including the doubling of attorneys fees at the courts' discretion; and
