1/ This adjustment includes the effect of the passage of Senate Bill No. 2361. The bill provides capital city legislators a salary of \$90 per day and other legislators a \$40 per day salary and \$50 per day expense reimbursement. These amounts compare to \$85 per day expense reimbursement and \$5 per legislative day salary during the 47th Legislative Assembly. Also, \$49,590 is added to salaries and wages for FICA taxes. In addition, Senate Bill No. 2361 increases mileage reimbursement from 10 to 25 cents per mile for a total estimated cost of \$94,000. The appropriation as amended provides funds for a Forty-ninth Legislative Assembly session of 95 calendar days.

Legislative Council

The salaries and wages line item is reduced by \$72,016 from the general fund. This reduces the amount originally included which was based upon the executive budget recommendation for compensation increases to a four percent salary increase the first year of the biennium with no funds for additional state contributions to retirement. Additional salary increases are to include a two percent salary increase for the second year of the biennium amounting to \$17,342 in a separate appropriation bill.

The members of the state board of higher education shall not be held personally liable for repayment of any loan obtained under this section, and the board shall be liable for repayment only in the manner provided pursuant to this section.

SECTION 4. APPROPRIATION. There is hereby appropriated the loan proceeds from any loan under section 3 of this Act to the state board of higher education for the following purposes:

Soard of Higher Education

The salaries and wages line item is reduced by \$29,190 from the general fund. The reduction will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$8,050 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement.

Operating expenses of the Board of Higher Education are increased by \$14,550 from the general fund. This increase provides \$4,550 of additional travel expenses for the Agricultural Consultation Board due to increased membership and \$10,000 for the Minot State College library space need study. The general fund appropriation is also increased by \$400,000 to provide funds for a tuition assistance program and reduced by \$2,358,000 to delete funds for a computer center at North Dakota State University.

Reciprocal Agreements

The general fund appropriation of reciprocal agreements is increased by \$88,640 to provide \$76,540 for five veterinary medicine positions and \$12,100 for two optometry positions in the second year of the biennium which continues these programs at the current level.

Other amendments to House Bill No. 1004 include a new section authorizing the Board of University and School Lands to invest an additional \$1 million from the permanent fund of the common schools as a loan to the Board of Higher Education for the development of the Dickinson Experiment Station land held for sale. An additional section appropriates the \$1 million to the board for land development and payment of interest on loans.

Funds are not provided for additional state contributions to retirement.

UND Medical Center

The salaries and wages line item is reduced by \$685,338, of which \$548,270 is from the general fund and \$137,068 is from other funds. This reduction will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$238,810 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement. Salaries and wages are also increased by \$95,000, from funds to be provided by the Health Department, for 2 FTE genetic technicians.

The operating expenses line item is increased by \$300,000 from the general fund for lease costs of additional space at the north unit of the Medical School.

North Dakota State University

The salaries and wages line item is reduced by \$1,265,905 from the general fund to allow funds for four percent

salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$446,773 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement.

The operating line item is increased by \$278,696 to provide reasonable increases for such items as library books and periodicals, classroom and office supplies, travel, repairs, and maintenance contracts.

The equipment line item is increased by \$354,046 to restore the equipment budget to the 1983-85 requested level.

North Dakota State School of Science

The salaries and wages line item is reduced by \$541,637 from the general fund. This reduction will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$171,315 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement.

Dickinson State College

The salaries and wages line item is reduced by \$222,776 from the general fund. This reduction will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$70,793 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement.

Mayville State College

The salaries and wages line item is reduced by \$155,606 from the general fund. The reduction will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. Minot State College

The equipment line item is increased by \$60,000 from the general fund to provide the necessary funds for a reconditioned high lift to be used campuswide.

Valley City State College

The salaries and wages line item is reduced by \$200,062 from the general fund to allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$63,405 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement.

NDSU-Bottineau Branch

The salaries and wages line item is reduced by \$59,797 from the general fund. Of the total, \$81,095 is a reduction that will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$25,759 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement. The net reduction to salaries and wages also includes a \$21,298 general fund increase to provide funds for one custodian for operations of the U.S. Shelterbelt Research Station.

The operating expenses line item is increased by \$48,800 from the general fund to provide funds for operation of the U.S. Shelterbelt Research Station.

The capital improvements line item is reduced by \$7,500 to remove funds for greenhouse roof repair and headhouse cooling.

Forest Service

The salaries and wages line item is increased by \$22,936, which includes a \$36,866 general fund increase and a \$13,930 decrease from other funds. Of the total, \$33,380 is a reduction that will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$10,679 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement. The net increases to salaries and wages

also includes a \$56,316 general fund increase to provide funds for 1.25 FTE tree improvement specialist positions.

Experiment Station - Main Station

Of the total, \$2,017,005 is from a reduction that will allow funds for four percent salary increases the first year of the biennium and no salary increases in the second year. A contingent salary increase of two percent in the second year amounting to \$442,977 is to be provided in a separate appropriation bill. Funds are not provided for additional state contributions to retirement. The net reduction to salaries and wages also includes a \$2,591,296 decrease for the transfer of 60 Truck Regulatory positions to the Highway Patrol and seven Truck Regulatory positions to the Motor Vehicle Department; and a \$200,000 increase to correct an error in temporary and overtime fringe benefit calculations.

The State Highway Department operating expenses are reduced by \$542,412, data processing is reduced by \$82,904, equipment is reduced by \$242,700, and capital improvements are reduced by \$40,000. These reductions from other funds all relate to the transfer of the 67 Truck Regulatory positions.

The \$20,000 for the motorcycle safety program is removed. This program will be transferred to the Department of Public Instruction.

The State Highway Department contracts are increased by \$56,997,000 with a corresponding increase in estimated income to reflect the additional availability of federal funds.

Upon adoption by the board of an unfavorable recommendation of a superintendent or chief administrator conducted pursuant to this section, the governing body shall deliver a copy of the evaluation to the superintendent or chief administrator. The superintendent or chief administrator. superintendent or chief administrator, upon receipt of an unfavorable evaluation, may respond in writing to the substance and content of the evaluation, and such a response shall become a permanent attachment
to the superintendent or chief adminstrator's personnel file. The school board shall meet with the superintendent to discuss the unfavorable evaluation no later than April fifteenth of each year.

Throughout the term of a contract between a school district and a superintendent or chief administrator the superintendent or chief administrator shall be subject to discharge for good and just causes, provided however, that the school board may not arbitrarily or capriciously require the superintender to richief administrator's dismissal. In the event that a school district governing body intends to discharge a superintendent or chief administrator, the superintendent or chief administrator shall be served with a detailed and written description of the reasons given by the school board for the proposed dismissal. Following service of the written description of the reasons for

proposed dismissal, the superintendent or chief administrator shall be granted a hearing before the governing body for which reasonable advance notice shall be required. In the event that a superintendent or chief administrator chooses to be accompanied by an attorney, the superintendent or chief administrator's legal expenses attributable to that representation shall be incurred by the superintendent or chief administrator.

If a school district fails to provide notification to a superintendent or chief administrator in writing between February fifteenth and April fifteenth of each year that the school board intends not to renew the superintendent or chief administrator's contract, the district shall be deemed to have renewed the contract for a period of one year extending from the termination date set forth in the existing contract."

The teacher shall be informed in writing of the time, which shall not be later than April seventh, and place of a special school board meeting for the purpose of discussing and acting upon such contemplated nonrenewal. The teacher shall also be informed in writing of the reasons nonrenewal. The reasons shall be sufficient to justify the contemplated action of the board and shall not be frivolous or arbitrary but shall be related to the ability, competence, or qualifications of the teacher as a teacher, or the necessities of the district such as lack of funds calling for a reduction in the teaching staff. At the meeting with the board the teacher may then produce such

evidence as may be necessary to evaluate the reasons for nonrenewal, and either party may produce witnesses to confirm or refute the reasons. The seheel beard shall give an explanation and shall discuss and confirm at the meeting its reasons for the contemplated nonrenewal of the contract-The administrator shall substantiate the reasons with evidence abduced at the meeting with witnesses who are subject to questioning for the purpose of clarification. At the meeting, the board shall discuss the reasons and determine whether or not the administrator has, in fact, substantiated the reasons. If the board finds that the reasons have not been substantiated, the nonrenewal proceedings will be dismissed. The meeting shall be an executive session of the board unless both the school board and the teacher shall agree that it shall be open to other persons or the public. The teacher may be represented at the meeting by any two representatives of his own choosing; and the teacher's spouse, or one other family member of the teacher's choice, may also attend the meeting if the teacher so desires. Final notice of the determination not to renew a contract shall be given in writing by April fifteenth as provided in section 15-47-27."
