SENATE AMENDMENTS TO HB 1400

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE STATE OF NORTH DAKOTA:

SECTION 1. A new section to chapter 47-14 of the North Dakota Century Code is hereby created and enacted to read as follows:

Prepayment of loans - Application of rule of 78's. At any time before maturity, a buyer may pay in full the remaining principal due on a loan and is entitled to a refund of interest as follows:

> For a loan where the principal is not more 1. than fifteen thousand dollars and where the term is less than sixty-one months, the refund must, after deducting an acquisition cost of not more than fifteen dollars, be at least as great a proportion of the interest as the sum of the periodic time balances after the month in which the

prepayment is made bears to the sum of all the periodic time balances under the scheduled installments in the original loan contract.

- 2. For a loan where the principal is greater than fifteen thousand dollars, or where the term is at least sixty-one months, the refund must be at least the interest paid in excess of that computed under the actuarial method, using the annual percentage rate that would be required to be disclosed under the Truth-in-Lending Act regardless of whether that Act applies to the loan to the nearest one-fourth of one percent.
- 3. A refund is not required if it would be less than one dollar.

SECTION 2. REPEAL. Section 51-13-05 of the North Dakota Century Code is hereby repealed.

SECTION 3. EFFECTIVE DATE. Subsection 2 of section 1 of this Act applies to loans made after September 30, 1983."
