STATEMENT OF PURPOSE OF AMENDMENT:

Board of Higher Education

The salaries and wages line item has a net reduction of \$4,796 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$6,489 over the executive budget for health insurance premiums.

The amendment also adds a \$350,000 contingency line item from the general fund to be used by the board, if necessary, to cover the unforeseen expenses at the institutions under the board's control.

The appropriation is reduced by a budget adjustment of \$22,004 (two percent) from the general fund. The commissioner shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$22,004 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

STATEMENT OF PURPOSE OF AMENDMENT:

State Water Commission

The salaries and wages line item is increased by \$84,472 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$21,965 over the executive budget for health insurance premiums.

The general fund appropriation is decreased by \$500,000 with a corresponding increase to the estimated income line item to reflect a \$500,000 increase in funding from the resources trust fund. This provides for a total of \$1 million to be transferred from the resources trust fund to the Water Commission operating fund to be used for the Contracts line item.

The total appropriation is reduced by a budget adjustment of \$102,983 (two percent), of which \$101,065 is from the general fund and \$1,918 from other funds. The Water Commission shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$102,983 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

STATEMENT OF PURPOSE OF AMENDMENT:

Governor's Office

The salaries and wages line item has an increase of \$17,007 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$5,508 over the executive budget for health insurance premiums.

The appropriation is reduced by a budget adjustment of \$21,060 (two percent). The Governor's office shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$21,060 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

Lieutenant Governor's Office

The salaries and wages line item has a net increase of \$3,379 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$1,050 over the executive budget for health insurance premiums.

The appropriation is reduced by a budget adjustment of \$1,349 (two percent) from the general fund. The Lieutenant Governor shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$1,349 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

Secretary of State

The salaries and wages line item has a net increase of \$39,596 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$9,035 over the executive budget for health insurance premiums. The increase to salaries and wages also includes a \$23,364 general fund increase for one clerk-typist position approved by the Emergency Commission.

The operating expenses line item is increased by \$17,900 from the general fund to provide additional operating funds needed for the 1983-85 biennium.

The equipment line item is increased by \$2,000 from the general fund to provide funds for the purchase of equipment including the replacement of typewriters.

The appropriation is reduced by a budget adjustment of \$19,052 (two percent after the above adjustments) from the general fund. The Secretary of State shall take such administrative action as may be necessary to spend less

than the total of the line items in the appropriation to achieve the \$19,052 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

Secretary of State - Public Printing

The appropriation is reduced by a budget adjustment of \$4,362 (two percent). The Secretary of State shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$4,362 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

Records Management/Central Microfilm

The appropriation for the Records Management/Central Microfilm Division is deleted and a new section is added which allows the Office of Management and Budget to carryover to the 1983-85 biennium and transfer funds unspent from the 1981-83 appropriation for the records management and microfilming functions in the Secretary of State's office to OMB to defray expenses of these functions during the 1983-85 biennium. The amendment is consistent with section 22 of the bill which authorizes the transfer of the records management function to OMB.

Attorney General

The salaries and wages line item has a net increase of \$60,662 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$22,769 over the executive budget for health insurance premiums.

The gaming enforcement line item is increased by \$300,000 to provide total enhancements of \$500,000 for gaming enforcement.

The appropriation is reduced by a budget adjustment of \$114,742 (two percent). The Attorney General shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$114,742 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

State Auditor

The salaries and wages line item has a net increase of \$46,240 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$13,699 over the executive budget for health insurance premiums.

The operating expenses line item is increased by \$48,300 to provide additional travel funds for the joint mineral lease audit program.

The data processing line item is increased by \$9,776 to restore data processing to requested level.

The appropriation is reduced by a budget adjustment of \$55,049 (two percent). The State Auditor shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$55,049 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

State Treasurer

The salaries and wages line item has a net increase of \$9,135 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$2,488 over the executive budget for health insurance premiums.

The appropriation is reduced by a budget adjustment of \$11,267 (two percent after the above adjustment) from the general fund. The State Treasurer shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$11,267 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

State Tax Commissioner

The salaries and wages line item has a net increase of \$948,452 from the general fund. An increase of \$65,981 will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1,

1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$37,612 over the executive budget for health insurance premiums. An increase of \$563,159 relates to 16 new positions for the "Auditing Enhancement" program. The new positions are expected to bring in \$10,106,870 of additional revenue during the 1983-85 biennium. An increase of \$168,300 relates to reclassifications of Tax Department audit positions. An additional increase of \$113,400 for one compliance officer, two clerk III, and one data entry operator relates to the administration of House Bill No. 1727 which provides for monthly collections of sales taxes and oil and gas taxes.

The operating expenses line item is increased by \$388,990, which includes \$378,190 for expenses related to the "Auditing Enhancement" program and \$10,800 for expenses related to the administration of House Bill No. 1727.

The data processing line item is increased by \$189,267 for expenses related to the administration of House Bill No. 1727.

The equipment line item is increased by \$34,135, which includes \$19,655 for expenses related to the "Auditing Enhancement" program and \$14,480 for expenses related to the administration of House Bill No. 1727.

The appropriation is reduced by a budget adjustment of \$202,720 (two percent after the above adjustment) from the general fund. The State Tax Commissioner shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$202,720 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

A new section is added which requires the Tax Commissioner to report quarterly to the Legislative Council on the status of the "Auditing Enhancement" program.

Insurance Commissioner

The salaries and wages line item has a net increase of \$91,008 from other funds. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$7,688 over the executive budget for health insurance premiums and \$74,000 for an accountant and clerk for assistance in administering the quarterly collection of the insurance premium tax as required by Senate Bill No. 2493.

In addition, \$42,800 is added to operating expenses and \$800 to equipment relating to administration of the quarterly collections. The increase of \$42,800 to operating expenses includes \$40,000 to be used to microfilm or microfiche records in the least expensive alternative.

The appropriation is reduced by a budget adjustment of \$24,650 (two percent after the above adjustment) from other funds. The Insurance Commissioner shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to

achieve the \$24,650 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

Labor Commissioner

The salaries and wages line item has a net increase of \$5,916 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$784 over the executive budget for health insurance premiums.

The operating expenses line item is increased by \$14,225 from the general fund to provide additional in-state travel funds for the department.

The appropriation is reduced by a budget adjustment of $\$10,216;\ \$8,376$ from the general fund (two percent). The Labor Commissioner shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$10,216 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

Public Service Commission

The salaries and wages line item has a net increase of \$70,167, of which \$58,245 is from the general fund and \$11,922 is from other funds. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$34,694 over the executive budget for health insurance premiums.

The operating expenses line item is increased by \$37,412, of which \$31,792 is from the general fund and \$5,620 is from other funds. This increase is to provide additional funding for travel and vehicle maintenance and operations for several divisions of the commission.

The data processing line item is increased by \$13,518 from other funds for the Abandoned Mine Lands Division of the commission.

The appropriation is reduced by a budget adjustment of \$164,072 (two percent after the above adjustments), of which \$83,284 is from the general fund and \$80,788 is from other funds. The Public Service Commission shall take such

administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$164,072 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

The amendments also revise the composition of the Reclamation Research Advisory Committee which was established in the Senate. The objectives and responsibilities of the committee are also revised.

The amendments also remove a \$500,000 appropriation for coal reclamation research grants from the coal development impact fund which was added by the Senate.

Agriculture Commissioner

The salaries and wages line item of the Agriculture Commissioner has a net increase of \$31,059, of which \$29,406 is from the general fund and \$1,653 is from other funds. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$9,776 over the executive budget for health insurance premiums.

The operating expenses line item is increased by \$16,289 from the general fund for additional funding for laboratory costs for the dairy division.

The amendments also remove \$50,000 from the general fund for marketing activities which was added by the Senate.

The appropriation is reduced by a budget adjustment of \$45,399, of which \$41,488 is from the general fund and \$3,911 is from other funds (two percent). The commissioner shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$45,399 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

The amendments also provide for a new section which appropriates \$1 million from public or private sources for the state waterbank program if funds become available during the biennium.

STATEMENT OF PURPOSE OF AMENDMENT:

Supreme Court

The salaries and wages line item is decreased by \$32,724 from the general fund. Of the total, an increase of \$47,276 will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$16,459 over the executive budget for health insurance premiums. Also, salaries and wages are decreased by \$80,000 to delete funds for one staff attorney position.

The operating expenses line item is decreased by \$34,000 from the general fund. Of this amount, \$30,000 is a decrease in funds for out-of-state travel and \$4,000 is a decrease to reflect in-state mileage at 20 cents a mile rather than 25 cents a mile.

District Courts

The salaries and wages line item is increased by \$21,541 from the general fund. Of the total, an increase of \$144,281 will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$49,902 over the executive budget for health insurance premiums. Also, the salaries and wages line item is decreased by \$122,740 to delete funds for three new positions, including one probation officer, one secretary, and one law clerk.

The operating expenses line item is decreased by \$38,000 from the general fund to reflect in-state mileage reimbursement at 20 cents rather than 25 cents a mile.

The equipment line item is decreased by \$100,000 from the general fund.

After the above adjustments, the appropriation is reduced by a budget adjustment of \$250,000. The district courts shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$250,000 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction. If the amount of the budget adjustment is determined to be unattainable, the district courts are to request a deficiency appropriation from the Forty-ninth Legislative Assembly.

Judicial Qualifications Commission

The salaries and wages line item has a net reduction of \$12,506, of which \$6,253 is from other funds, and \$6,253 from the general fund. Of the total, an increase of \$2,527 will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$1,050 over the executive budget for health insurance premiums. Also, the salaries and wages line item is decreased by \$15,033 to reflect a lower salary for the attorney position. This position was filled by a different person since the original budget was submitted.

The operating expenses line item is decreased by \$5,000, of which \$1,850 is from the general fund and \$3,150 is from other funds, to reflect in-state mileage reimbursement at 20 cents a mile rather than 25 cents a mile.

In addition to these changes, the general fund appropriation is increased by \$42,612 and the estimated income line item is reduced by \$42,612 to reflect an anticipated total level of estimated income of \$75,000.

STATEMENT OF PURPOSE OF AMENDMENT:

Bismarck Junior College

The salaries and wages line item is reduced by \$442,910, of which \$325,224 is from the general fund and \$117,686 is from other funds. The reduction will allow funds equivalent to the contribution to retirement and the medical insurance adjustment provided state employees.

The general fund appropriation is reduced by \$200,000, with a corresponding increase in estimated income, to delete general fund moneys provided by the House for a power plant technology program.

In addition, the general fund appropriation is reduced by \$54,647 (1.5 percent after the above adjustments) with a corresponding increase in estimated income. After this adjustment, estimated income was reduced and the general fund appropriation was increased by \$184,650 for the payment of a portion of retirement and medical insurance benefits from the general fund.

Lake Region Community College

The salaries and wages line item is reduced by \$100,523, which includes a \$110,000 general fund decrease and a \$9,477 increase from other funds. The reduction will allow funds equivalent to the contribution to retirement and the medical insurance adjustment provided state employees.

In addition, the general fund appropriation is reduced by \$23,792 (1.5 percent after the above adjustments) with a corresponding increase in estimated income. After this adjustment, estimated income was reduced by \$62,490 and the general fund appropriation was increased by \$62,490 for the payment of a portion of retirement and medical insurance benefits from the general fund.

UND-Williston

The salaries and wages line item is reduced by \$144,905, of which \$101,986 is from the general fund and \$42,919 is from other funds. The reduction will allows funds equivalent to the contribution to retirement and the medical insurance adjustment provided state employees. In addition, the general fund appropriation is reduced by \$17,783 (1.5 percent after the above adjustments) with a corresponding increase in estimated income. After this adjustment, estimated income was reduced and the general fund appropriation was increased by \$52,860 for the payment of a portion of retirement and medical insurance benefits from the general fund.
