REPORT TO THE 48TH LEGISLATIVE ASSEMBLY OF

NORTH DAKOTA CENTENNIAL COMMISSION

In accordance with Section 6 of Chapter 554, 1981 Session Laws, the North Dakota Centennial Commission hereby presents its report and appropriations request to the 48th Legislative Assembly for the State of North Dakota.

While it may seem that seven years is considerable lead time to begin developing plans for the observance of the centennial, the 47th assembly should be commended for its foresight in establishing the Centennial Commission this early. Much of the activity which will, or should, take place during the year 1989, requires a great deal of advance planning and North Dakota has not begun any too soon. The Centennial Commission was given the task of developing an initial plan and did not feel that it would be proper to develop a plan in such detail that subsequent centennial commission members would feel "locked-in" to matters that were developed by their predecessors. Therefore, we have elected to plan in generalities and outline the steps which must be followed if certain activities are going to take place.

Financing is going to be a major problem for many of the proposed activities. Grants from federal and state agencies and foundations, corporate and private donations, and public subscription will be a necessary part of the funding of the commission. All of these sources will require personal contacts and time-consuming effort by a spokesman for the commission. This work must begin at once. It will require travel and public programs that will need a great deal of administration. This can only be done by an executive director.

HISTORY

The centennial observance should revolve around a factual history. It is noted that the 75th anniversary resulted in the publication of a popular history of North Dakota. A chronological history is not now available and work should begin by qualified historians immediately. Even if a popular history is not completed for publication, there will be considerable need for a history to be furnished to the schools and to others who might need it. This is the foundation work for the development of some of the centennial activities which are felt to be necessary and should be done over the next three years so that it will be available at least four years prior to the observance.

PUBLIC INFORMATION

A T.V. series and centennial minutes on North Dakota history would bring historical awareness in every living room in the state. This would be based on the material developed by the history committee. This material could also then be used as an aid in a course of study in the schools on North Dakota history.

A great deal of the early history of North Dakota should be developed into a popular history to be furnished to the daily and

weekly newspapers as special articles or special supplements. Also, brochures carrying information about the celebration of the centennial should be developed.

COURSE OF STUDY

The teaching of North Dakota history, particularly the history of the development of statehood, should be accelerated. The commission will encourage the use of a textbook and course materials which will also have to be developed from material provided by the history committee and the cooperation of the Department of Public Instruction.

ART

The Centennial Commission will commission a major piece of artwork to be paid for by subscription and placed on the North Dakota capitol grounds. Competition among artists would have to begin quite soon so that the selection could be made no later than 1984. This would then allow four years for the development of the work and it would be ready for placement and dedication during the centennial year. This project requires an immediate start and close supervision.

LOGO

The Centennial Commission should coordinate all memorabilia developed around the centennial theme. This would require the Commission to adopt an official logo, after suitable competition and then restrict the use of that logo to approved items. Such items as belt buckles and desk top objects could be produced and sold featuring the official logo. However, to avoid the development of trash, the use of the logo must be very carefully watched and controlled so that it does not become overused or misused.

TRAVELING EXHIBIT, ETC.

Exhibits of historical significance and memorabilia can be prepared by the North Dakota State Historical Society at the Heritage Center and rotated throughout the state to create a greater awareness of North Dakota history in the centennial year. In the same way, a craft show making items in the manner and with the tools of yesterday. A chautauqua type show could present plays related to our history to the entire state.

LOCAL CELEBRATIONS

The commemoration of the centennial by local homecomings in communities around the state would be encouraged and coordinated by the executive director of the Centennial Commission. It is hoped that a great deal of interest could be created in such local celebrations and that these would constitute much of the activity of the centennial year.

COORDINATION WITH OTHER STATES

South Dakota and Montana were admitted to the Union the same year as North Dakota. It is believed that they will be having centennial events during that same period and it would be

appropriate to coordinate our celebration with theirs and would likely lead to a better celebration if we can exchange ideas with the other states. Plans to coordinate and share activities should begin immediately. North Dakota will work with these states to market the region to international markets and group tax operations.

COORDINATION OF STATE EFFORTS

It would be appropriate for many of the state agencies to emphasize the centennial in agency publications or activities. This would be particularly true for Historical Society and Recreation Department. However, many of the activities of the Highway Department, Game and Fish Department, Agricultural Department and others could be used to emphasize the centennial theme.

EXECUTIVE DIRECTOR

The lead time for many of the activities above is at least four years. Some of it is even greater than that. In order that some of the work which must be done right away can be taken care of on a reasonable schedule, it is recommended that a part-time executive director be engaged beginning July 1, 1983, and that he immediately begin to develop more detailed plans for the celebration of the North Dakota Centennial, under the direction of the Centennial Commission.

It is also recommended that the North Dakota Centennial Commission be continued in its present form with expanded appointive membership and that the Superintendent of the State Historical Board, and Director of North Dakota Tourist Promotion be added to the Centennial Commission as ex-officio members.

All of the above activities will require from two to four years production and, when one adds the two years required to develop the North Dakota history, you see that we are at a point that we must begin immediately.
