## STATEMENT OF INTENT

This amendment places Bismarck junior college, Lake Region community college, and the university of North Dakota - Williston center under the control and administration of the board of higher education. The amendment also makes technical corrections.

# BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

That the following proposed amendments to subsection 1 of section 6 of article VIII and section 12 of article IX of the Constitution of the State of North Dakota are agreed to and shall be submitted to the qualified electors of the State of North Dakota at the general election to be held in 1984, in accordance with the provisions of section 45 of article IV of the Constitution of the State of North Dakota.

SECTION 1. AMENDMENT. Subsection 1 of section 6 of article VIII of the Constitution of the State of North Dakota is hereby amended and reenacted to read as follows:

- A board of higher education, to be officially known as the state board of higher education, is hereby created for the control and administration of the following state educational institutions, to wit:
  - a. The state university and school of mines, at Grand Forks, with their substations.
  - b. The state agricultural college North
    Dakota state university of agriculture
    and applied science and experiment
    station, at Fargo, with their
    substations.
  - c. The school of science, at Wahpeton.
  - d. The state normal schools and teachers colleges, at Valley City, Mayville, Minot, and Dickinson.
  - e. The school of forestry, at Bottineau.
  - f. Bismarck junior college, at Bismarck.

- g. Lake Region community college, at Devils Lake.
- h. The university of North Dakota Williston center, at Williston.
- i. And such other state institutions of higher education as may hereafter be established.
- SECTION 2. AMENDMENT. Section 12 of article IX of the Constitution of the State of North Dakota is hereby amended and reenacted to read as follows:
- Section 12. The following public institutions of the state are permanently located at the places hereinafter named, each to have the lands specifically granted to it by the United States in the Act of Congress approved February 22, 1889, to be disposed of and used in such manner as the legislative assembly may prescribe subject to the limitations provided in the article on school and public lands contained in this constitution this section and section 13 of this article.
  - The seat of government at the city of Bismarck in the county of Burleigh.
  - The state university and the school of mines at the city of Grand Forks, in the county of Grand Forks.
  - The North Dakota state university of agriculture and applied science at the city of Fargo, in the county of Cass.
  - 4. A state nermal school college at the city of Valley City, in the county of Barnes, and the legislative assembly, in apportioning the grant of eighty thousand acres of land for normal schools made in the Act of Congress referred to shall grant to the said normal school at Valley City, as aforementioned, fifty thousand (50,000) acres, and said lands are hereby appropriated to said institution for that purpose.
  - The school for the deaf and dumb of North Dakota at the city of Devils Lake, in the county of Ramsey.

- 6. A state training industrial school at the city of Mandan, in the county of Morton.
- 7. A state nermal seheel college at the city of Mayville, in the county of Traill, and the legislative assembly in apportioning the grant of lands made by Congress in the Act aforesaid for state normal schools shall assign thirty thousand (30,000) acres to the institution hereby located at Mayville, and said lands are hereby appropriated for said purpose.
- 8. A state hospital for the insame mentally <u>ill</u> at the city of Jamestown, in the county of Stutsman. And the legislative assembly shall appropriate twenty thousand acres of the grant of lands made by the Act of Congress aforesaid for other educational and charitable institutions to the benefit and for the endowment of said institution; and there shall be legated.
- 9. An institution for the mentally deficient, on the grounds purchased by the secretary of the interior for a penitentiary building, at or near the city of Grafton, in the county of Walsh, an institution for the feebleminded, on the grounds purchased by the secretary of the interior for a penitentiary building."

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE STATE OF NORTH DAKOTA:

SECTION 1. A new subsection to section 39-21-39 of the North Dakota Century Code is hereby created and enacted to read as follows:

A person may not operate a motor vehicle with any object or any material displayed, affixed, or applied on the front windshield or on any side window where that material alters the color or reduces the light transmittance, or reduces the driver's clear and unobstructed view through the windshield or window. This subsection does not apply to windows behind the driver or to factory installed tinted windows or windshields."
