STATEMENT OF PURPOSE OF AMENDMENT:

Motor Vehicle Department

The salaries and wages line item has a net increase of \$776 from other funds. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$21,448 over the executive budget for health insurance premiums.

The appropriation is reduced by a budget adjustment of \$84,042 (two percent) from other funds. The registrar shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$84,042 budget reduction. Line items other than salaries and wages, operating expenses, data processing, and equipment are not to be affected by the budget reduction.

"SECTION 6. A new section to chapter 10-06 of the North Dakota Century Code is hereby created and enacted to read as follows:

Certain nonprofit organizations or trusts may own or lease land - Certain nonprofit organizations may continue farming or ranching - Restriction on acquisition and ownership of land.

1. A nonprofit organization exempt from taxation under section 501(c)(3) of the

Internal Revenue Code [26 U.S.C. 501(c)(3)] or a trust for the benefit of an individual or a class of individuals related within the degrees of kinship specified in subsection 2 of section 10-06-07 may own or lease farm or ranch land if that land is leased to a person who farms or ranches the land as a sole proprietorship, partnership, or a corporation allowed to engage in farming or ranching under section 10-06-07.

- 2. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code and actively engaged in the business of farming or ranching in this state on January 1, 1983, may continue to engage in the business of farming or ranching without interruption after January 1, 1983.
- 3. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code which owned farm or ranch land for the preservation of unique historical, archaeological, or environmental land prior to January 1, 1983, may continue ownership of such land without interruption after January 1, 1983.
- 4. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code [26 U.S.C. 501(c)(3)] may acquire farm or ranch land only by inter vivos or testamentary gift. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code must dispose of all farm or ranch land acquired in fee after January 1, 1983, not more than fifteen years after the date of acquiring ownership in fee.

SECTION 7. A new section to chapter 10-06 of the North Dakota Century Code is hereby created and enacted to read as follows:

Industrial and business purpose exception. A corporation which is not engaged in the business of farming or ranching may own or lease land used for farming or ranching, only when the land is necessary for residential or commercial development, the siting of buildings, plants, facilities, industrial parks, or similar business or industrial purposes of the corporation, or for uses supportive of or ancillary to adjacent nonagricultural land for the benefit of both land parcels. The farm or ranch land while not being immediately used for any purpose of the corporation must be available to be leased by persons actually engaged in farming or ranching.

SECTION 8. A new section to chapter 10-06 of the North Dakota Century Code is hereby created and enacted to read as follows:

Reports of corporations not engaged in farming or ranching. Any business or nonprofit corporation not engaged in the business of farming or ranching which owns or leases a tract of land used for farming or ranching which is larger than twenty acres [8.09 hectares] in size shall file with the attorney general, prior to July 30, 1983, and within twelve months of any transaction involving the purchase, sale, or surface leasing of such farm or ranch land by that corporation, a report containng all of the following information:

The appropriation is reduced by a budget adjustment of \$38,526 (two percent after the above adjustments), of which \$30,749 is from the general fund and \$7,777 is from other funds. The superintendent shall take such administrative action as may be necessary to spend less than the total of the line items in the appropriation to achieve the \$38,526 budget reduction. STATEMENT OF PURPOSE OF AMENDMENT:

Upper Great Plains Transportation Institute

The salaries and wages line item is reduced by \$30,045. Of the total, a reduction of \$3,000 will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$2,229over the executive budget for health insurance premiums. Also, the salaries and wages line item is reduced by \$27,045 from the general fund to delete funds provided by the House for a half-time clerk-typist and other temporary salaries.

Extension Division

The salaries and wages line item has a net reduction of \$210,543, of which \$142,902 is from the general fund and \$67,641 is from other funds. This will allow funds for the state to provide a two percent contribution to retirement

on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$25,194 over the executive budget for health insurance premiums.

The operating expenses line item is increased by \$111,000 from the general fund to provide for partial restoration of the current service level.

The general fund appropriation is reduced by a budget adjustment of \$244,163 (three percent after the above adjustments). The reduction is to be allocated to individual line items by the Extension Division with the approval of the Board of Higher Education.

Northern Crops Institute

The Northern Crops Institute supplement line item is increased by 60,711 from the general fund to be used at the discretion of the institute for salaries, operating expenses, and equipment.

The general fund appropriation is reduced by a budget adjustment of \$19,348 (three percent after the above adjustments). The reduction is to be allocated to individual line items by the Northern Crops Institute with the approval of the Board of Higher Education.

Main Experiment Station

The salaries and wages line item has a net reduction of \$179,888 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$228,365 over the executive budget for health insurance premiums.

The general fund appropriation is reduced by a budget adjustment of \$589,055 (three percent after the above adjustment). The reduction is to be allocated to individual line items by the Main Experiment Station with the approval of the Board of Higher Education.

Dickinson Experiment Station

The salaries and wages line item has a net reduction of \$2,808 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also

provides \$7,174 over the executive budget for health insurance premiums.

The general fund appropriation is reduced by a budget adjustment of \$30,632 (three percent after the above adjustment). The reduction is to be allocated to individual line items by the Dickinson Experiment Station with the approval of the Board of Higher Education.

Hettinger Experiment Station

The salaries and wages line item has a net increase of \$42 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$3,549 over the executive budget for health insurance premiums.

The general fund appropriation is reduced by a budget adjustment of \$14,224 (three percent after the above adjustment). The reduction is to be allocated to individual line items by the Hettinger Experiment Station with the approval of the Board of Higher Education.

Langdon Experiment Station

The salaries and wages line item has a net reduction of \$587 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$3,862 over the executive budget for health insurance premiums.

The general fund appropriation is reduced by a budget adjustment of \$16,801 (three percent after the above adjustment). The reduction is to be allocated to individual line items by the Langdon Experiment Station with the approval of the Board of Higher Education.

North Central Experiment Station

The salaries and wages line item has a net reduction of \$2,017 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$3,962 over the executive budget for health insurance premiums.

The general fund appropriation is reduced by a budget adjustment of \$20,491 (three percent after the above

adjustment). The reduction is to be allocated to individual line items by the North Central Experiment Station with the approval of the Board of Higher Education.

Williston Experiment Station

The salaries and wages line item has a net reduction of \$1,254 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$4,360 over the executive budget for health insurance premiums.

The general fund appropriation is reduced by a budget adjustment of \$14,360 (three percent after the above adjustment). The reduction is to be allocated to individual line items by the Williston Experiment Station with the approval of the Board of Higher Education.

Carrington Experiment Station

The salaries and wages line item has a net reduction of \$3,467 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$7,302 over the executive budget for health insurance premiums.

The operating expenses line item is reduced by \$135,000 from the general fund to correct an error in the calculation of utility expenditures.

The general fund appropriation is reduced by a budget adjustment of \$20,585 (three percent after the above adjustments). The reduction is to be allocated to individual line items by the Carrington Experiment Station with the approval of the Board of Higher Education.

Agronomy Seed Farm

The salaries and wages line item has a net reduction of \$976 from other funds. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$2,420 over the executive budget for health insurance premiums.

Central Grassland Experiment Station

The salaries and wages line item has a net reduction of \$906 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. With the demonstrated support of this Legislature, and with the continued support of North Dakota's citizens, we are confident that impaired driving will come to be seen for what it is -- a crime against life and a behavior which is directly contradictory to North Dakota's tradition of respect and concern for all citizens and neighbors. POINT OF PERSONAL PRIVILEGE

SEN. MAIXNER: Mr. President: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

When this bill was considered on final passage April 7, I did not speak to the bill. I did not do so because the issues involved are so close to me that I find it difficult to address them objectively and without emotion. Frequently those emotional appeals are rejected in this body as shallow and partisan.

It is difficult for me, because even though it has been ten years since those of us who fought in Vietnam returned to this country, the divisiveness and the lack of acceptance that made that war unique in American history are still with us.

It is also difficult for those of us who served in Vietnam to understand why some organizations which are recognized by the Veterans Administration as veterans' service organizations should be a part of the administrative committee on veterans' affairs, while others, similarly recognized, should not. This is actually the point being addressed in this bill: That each organization should be represented--not each conflict. The fact that Vietnam veterans believed that their problems were unique enough and serious enough to form their own organization, the Vietnam Veterans of America, is the very reason why that organization should receive the support of this body in their efforts to attain membership on the committee.

JOURNAL OF THE SENATE

A second organization which would be included under this bill is the Amvets. Any individual who served in the military between World War II and the end of Vietnam, including those who served during peacetime and are not eligible for membership in any of the other veterans' organizations, are eligible for membership in Amvets.

The North Dakota Veterans Coordinating Council, composed of the commander, adjutant, and one other member from the American Legion, the Veterans of Foreign Wars, and the Disabled American Veterans, voted unanimously to support this legislation on March 2, and they confirmed that position on March 28, 1983. These organizations represent fifty-two thousand veterans in this state.

I would plead with this body not to add an additional straw of rejection to the camel's back of ingratitude that has greeted the Vietnam veteran since his return. I would urge the Senate to reconsider our action and then pass Senate Bill No. 2121.
