POINT OF PERSONAL PRIVILEGE

REP. O. HANSON: Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal, which request was granted.

Mr. Speaker and members of this assembly:

Last Thursday this body passed a bill which would rescind the approval for the MANDAN power line to cross North Dakota from Manitoba to the south. This approval had been granted during the 1981 Session and was due to come into effect in 1989-90. This action was taken because of Manitoba's opposition to the Garrison Diversion Project as it was proposed in North Dakota. During the debate, the general agreement was that Manitoba was solely responsible for the scaled down revised version of the Garrison plan. This was not true, as it was the commission doing the study that was responsible for the final decision and that decision was made partly as a result of one of our own members who was not supporting the original plan.

Be as it may, the action we took was a spiteful, futile revenge action that can only hurt us in the long run. This was the umpteenth chapter in a long list of chapters to a fictional book, which could probably be titled "Idiotic Bureaucratic Shenanigans" or "You Did This To Me Last Time So Now I'm Going To Do It To You."

This past weekend the Canadians wrote the next umpteenth chapter as reported in the Bismarck Tribune dateline, Winnipeg, Manitoba.

Manitoba's New Democrats passed a resolution urging the province to continue its opposition to construction of the Garrison Diversion Project. The resolution calls on the government to try to stop North Dakota from using the MANDAN power line as a bargaining tool for construction of Garrison.

Former natural resources minister urged delegates not to overreact to North Dakota's behavior because he said he didn't think it represented the thinking of all residents

of that state. I'm glad someone is using some common sense.

A former member of Parliament, Terry Sargeant, called the actions blackmail and said such behavior won't help relations between the province and North Dakota.

That ends the quotes from this article, but I can assure this body that this will most assuredly be true. I've been working for two years to bring about a change in attitude of that government towards North Dakota. Just as recent as last November, the Souris River Water Commission, which is composed of 12 rural municipalities in southwest Manitoba, passed a resolution, at my request, supporting the full Garrison concept, including Lone Tree Reservoir. I've been having discussions with their government over establishing a Manitoba-North Dakota Boundary Advisory Commission such as we have with Saskatchewan.

This type of dialogue could be very beneficial to us all and might have resolved this Garrison issue a long time ago, if it was a reality. Now all this work by myself and others is down the drain unless we stop it in the Senate. If we just sit back and wait for the umpteenth chapter to be written to this book without doing something to stop it, all mankind and especially the people of North Dakota and Manitoba will most assuredly be the losers.

REMARKS

By Honorable Byron L. Dorgan United States Congressman

Last Wednesday night I was seated in the U.S. House chambers listening to President Reagan's State of the Union message. He described an America that stands for hope, compassion, opportunity, and courage. He described an America where dreams can come true if you work hard. He was describing values which I believe set us apart from the rest of the world.

The President also told us some good news about the state of the union; that the economy is growing and the people feel better about America. And all of that is true. But this is a big country, and all is not well everywhere. As public officials, you and I are really mechanics who are working in the engine room of this big ship of state. It's our responsibility to work hard polishing what works and trying to fix what's wrong. Any we've got some things which need fixing America.

Farmers work hard, but the dreams they dream for their children are no longer coming true. Inflation is down, interest rates have fallen somewhat, Wall Street is bullish, unemployment is dropping - and America's farmers are going broke. That's a state of the union that we've got to fix.

Newstands are filled with magazine stories about the newest fad diet and the latest pill to help overweight Americans reduce yet two-thirds of the world are hungry and the sub Saharan African is starving. At the same time, America has a farm program that tries to make less productive its most productive assets - its family farmers. That's a state of the union that we have to fix.

The U.S. economy is enjoying an unexpected boom. The Gross National Product is rising 7.6 percent. Unemployment is down from 10.7 percent to 7.5 percent. Inflation has stabilized. Yet, the wealthiest, the most robust nation on earth is deep in debt. We have an annual deficit of \$200 billion and a trade deficit of \$125 billion. By fiscal year 1986 the national debt will be \$1.7 trillion. That's a state of the union we have to fix.

You know, a hundred years from now when people look back at our generation, they're going to be able to tell an awful lot about us by how we spent our money. It is my belief that we need a good old fashioned debate on the President's budget; one in which we take a good, hard look at where we want those precious tax dollars to go. So that future generations will look back and say that in 1985, the American people wrestled with their fiscal problems in a way that was fair to all.

On Monday, the President sent his budget to Capitol Hill. That budget calls for a \$180 billion deficit. It also calls for a 13 percent increase in budget authority for the Defense Department. It cuts the farm program, cuts student aid, eliminates revenue sharing for the states; it cuts Medicare and cuts five percent from programs for the poor. It eliminates the Rural Electrification Program, the Economic Development Administration and Urban Development Action Grants.

It's an awful tough thing to try and put together a budget that requires painful decisions on where to cut and where to increase. I know that you're going through that very process now.

And that's why you and I know that the budget process requires leadership. In the case of the federal budget, that leadership must come from the President, and from Democrats and Republicans in both Houses of Congress. It also requires a commitment to equality of sacrifice. I would like to see a budget freeze across the board - in defense spending as well as non-defense spending. But that won't happen without the leadership and cooperation of the President and both political parties. An across the board freeze has bi-partisan support in both Houses of Congress, but it's just not going to happen.

I'd like to share with you today what I believe we can realistically expect in the federal budget after the great American debate on spending increases and cuts is finally done. Brace yourself. We will be making deep cuts in spending that will greatly affect North Dakota. But we will also make a tough stand on farm programs and other critical domestic programs. I know that there's no more important job for me in Congress this year than to fight as hard as I can to hold onto our farm programs and to withstand pressure to make cuts in so important a program as Medicare. But we will have to expect cuts in revenue sharing, EDA, rural water and sewer programs and Urban Development Action Grants.

Central to the debate over this budget is whether America is more secure when we adjust our spending priorities in such a way that Pentagon spending experiences no sacrifice while the rest of America agonizes over the deficit. Secretary of Defense Caspar Weinberger is missing a very valuable point - that security is not just Pentagon security. Security for America also means a good educational system. Security for America also means promoting American agriculture, opening new markets, sharing our huge food surpluses with a hungry world. And security for America means assuring that those who are poor and elderly have a right to adequate health care.

At the same time we bring that message to Mr. Weinberger, those of us from farm states will be bringing this message to the President and to our colleagues in the House and Senate: We wouldn't cut defense in time of war. We wouldn't think of cutting health care programs during a medical catastrophe. We simply cannot eliminate farm programs during a farm crisis. Т will tell my colleagues how farm scenes in North Dakota are beginning to look like a grainy film clip from the 1930s. I will tell them about young farmers putting their homes and farm machinery on the auction block. I will tell them about men choked with emotion, fighting back tears at meetings of farm survival groups. We've got to make people understand that for fifty years the federal government has been a partner to agriculture and that in this time of crisis farmers must look to Washington to help straighten out this mess. And the mess today is, in large part, the result of rising interest rates coming at a time when U.S. export earnings have been falling. The result has been catastrophic and it's why American farmers now owe more money than Brazil and Mexico combined. I will tell the President and my colleagues that if we don't solve this farm problem, my state alone will become 70,000 square miles of ghost town. The situation is that dramatic, and it's that important.

It's clear that any meaningful help to farmers requires two steps. First, a comprehensive credit bill that will provide immediate capital to farmers in the form of advanced payment of 50 percent of the loan rate, along with long-term loan guarantees. The second step must include continuation of price supports. I would like to see the 1985 farm bill target benefits to small and medium sized farms, where they do the most good. You and I both know that the destiny of American agriculture lies with the 1985 farm bill, and we've got to do it right.

A budget that asks for sacrifice requires that we make tough choices - and the choices we make today will tell future generations about the state of American values in 1985. Will we choose more and more weapons - will we choose poorer medical care for the elderly? Will our choices reflect the compassion and wisdom that has set America apart?

It's these kinds of issues that brought us - you and me to choose public service. And as we debate the budget of this nation, and as we contemplate the future of our family farmers, I keep remembering what Adlai Stevenson said about the way democracy works:

"Trust the people, trust their good sense, Their decency, their fortitude, their faith. Trust them with the facts. Trust them with great decisions. And fix as their guiding star the passion to create a society where people can fulfill their own best selves."

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE STATE OF NORTH DAKOTA:

SECTION 1. Definitions. In sections 1 through 11 of this Act, unless the context or subject matter otherwise requires:

1. "Claimant" means any seller who has sold edible beans to a public warehouseman who becomes insolvent as defined by section 60-04-02, and who

has not received the full payment for the edible beans under the sales contract.

- 2. "Commission" means the public service commission.
- 3. "Council" means the North Dakota edible bean council.
- "Edible beans" means any and all varieties of edible beans, excluding soybeans.
- 5. "Fund" means the edible bean indemnity fund.
- 6. "Seller" means a person selling edible beans to a public warehouseman.
- 7. "Public warehouseman" means a public warehouseman as defined in section 60-02-01.

SECTION 2. Powers of the council. The council has powers on behalf of the fund to:

- 1. Borrow funds from the Bank of North Dakota if necessary to pay claims or the costs of administering the fund. The Bank shall take adequate guarantees necessary to ensure the repayment of the loan and may charge interest not to exceed the Bank's base rate.
- 2. Purchase insurance to cover payment of claims against the fund in amounts it determines appropriate.
- 3. Seek the collection of assigned claims from the public warehouseman or any other source of potential recovery.
- Institute actions for the collection of assigned claims.
- Receive payments from the fund for the costs incurred in administering the fund, including the cost of collecting assigned claims.
- 6. Authorize reimbursements for the commission for costs incurred in the collection and determination of claims.

SECTION 3. Assessments. Every public warehouseman shall collect two and one-half cents per hundredweight [45.36 kilograms] of edible beans from each seller of edible beans. The public warehouseman shall match each dollar of assessment collected from a seller, with a dollar. All funds must be deposited with the council on a monthly basis, pursuant to rules adopted by the council.

SECTION 4. Edible bean indemnity fund -Administration. The council shall deposit the assessments received pursuant to section 3 of this Act to the state treasurer, who must deposit the assessments in a fund, to be maintained at the Bank of North Dakota. The council shall administer the fund in a manner so as to provide prompt compensation for claimants. The state treasurer shall pay money from the fund to the commission for reimbursement of claimants. Any interest generated by the fund must be transferred to the fund.

SECTION 5. Suspension of assessments. The council shall suspend assessments if the amount of uncommitted money in the fund is at least one million dollars. The council shall reinstitute assessments if the amount of uncommitted money credited to the fund drops below one million dollars. When reinstituting assessments, the council shall assess only on sales made after the assessment was reinstituted.

SECTION 6. Disbursements from the fund - Claims.

- 1. A claimant may make a claim under sections 1 through 11 of this Act upon the insolvency of a designated handler or warehouse. A claim must be submitted with proof of loss, as required by the commission. Upon the determination by the commission that the claimant has the right to receive money from the fund, the commission shall apply to the state treasurer for moneys from the fund to pay the amount of the claimant's provable loss.
- 2. A claimant is entitled to recover from the fund an amount equal to the unpaid balance under the sales contract with interest at the weighted average base rate charged by the Bank of North Dakota since the date payment under the sales contract was due.

SECTION 7. Appeals. Any appeal from a determination by the commission of the amount of a claim must be made within thirty days of the determination of the claim amount to be paid.

SECTION 8. Proration of payments - Insolvency of the fund. The state treasurer shall prorate the payments from the fund to the commission if the total amount of uncommitted money credited to the fund is not sufficient to pay all claims against the fund. The state is not liable for nonpayment of claims against the fund due to the insolvency of the fund.

SECTION 9. Assignment of claim for relief to council. Any claimant receiving a payment from the fund shall assign to the council any claim for relief against the public warehouseman or any other source of recovery, to the extent of the recovery from the fund. The council shall take all action necessary to reimburse the fund for disbursements made from the fund.

SECTION 10. Refunds. Any seller subject to the assessment provided in section 3 of this Act may, within thirty days following the assessment, make application by personal letter to the council for a refund application blank. Upon the return of the refund application blank, properly executed by the seller and accompanied by a record of the assessment by the public warehouseman, and received not later than ten days after it was mailed to the seller, the council shall refund the net amount of the assessment collected from the seller. No assessment collected from a public warehouseman may be refunded. No refund may be granted to a seller who has received a claim from the fund during the previous twelve months. Any seller requesting a refund from the council under this section may not receive any disbursement from the fund based on any claim under section 6 of this Act for any edible beans sold during the following twelve-month period or until the seller has paid assessments for which a refund has not been requested, whichever occurs later.

SECTION 11. Penalty - License revocation. Any public warehouseman who violates sections 1 through 11 of this Act or any rule adopted pursuant to sections 1 through 11 of this Act is guilty of an infraction. Violation of sections 1 through 11 of this Act or any rule adopted pursuant to sections 1 through 11 of this Act by a public warehouseman constitutes cause for suspension or revocation of the public warehouseman's license in accordance with section 60-02-10.1.

SECTION 12. AMENDMENT. Section 60-04-02 of the 1985 Supplement to the North Dakota Century Code is hereby amended and reenacted to read as follows:

60-04-02. Insolvency of warehouseman. Whenever any warehouseman, by reason of the destruction of his the warehouseman's warehouse or for any other cause, shall refuse, neglect, or be unable, upon proper demand, to redeem any receipt issued by him, make payment through redelivery or cash payment, such in accordance with the terms of the sales contract with the seller, the warehouseman shall be is deemed to be insolvent within the meaning of this chapter."
