- WHEREAS, tuition reciprocity agreements for vocational education programs have recently been entered into by the State Board of Higher Education;
- NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NORTH DAKOTA, THE SENATE CONCURRING THEREIN:
- That the Legislative Council study the positive and adverse impacts of current tuition reciprocity agreements on postsecondary educational institutions, the communities where such institutions are located, postsecondary students, and state government; and
- BE IT FURTHER RESOLVED, that the Legislative Council report its findings and recommendations, together with any legislation required to implement the recommendations, to the Fiftieth Legislative Assembly.

POINT OF PERSONAL PRIVILEGE

REP. KRETSCHMAR: Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

Representative Vander Vorst and I wish to congratulate the Linton Lions boys' basketball team from Legislative District 30 and Class B District 20 for winning the State Class B Championship in 1984 and 1985.

The "Big B" is the premier annual sporting event in North Dakota and attracts students and fans from the entire state.

Mr. Speaker, I am sure you will agree that the 1985 tournament in Bismarck this past weekend, especially the conclusion of the championship game, was the stuff from which legends are born.

If I were a betting man, Mr. Speaker, I might have made a small wager on the Lions. Unfortunately, I did not.

The Linton Lions came to town to defend their state crown. And defend it they did.

All who saw the games at the Civic Center, or watched on television, will agree that Linton played superbly.

Most coaches, Mr. Speaker, would rather have a Jon Richter with one good leg, than most ballplayers with two. The courage of a Richter, the poise of a Rohrich, the coolness of a Petrick, the reliability of a Beck, the hustle of a Horner, the bench strength of Holzer, Jahner, and the rest, together with the outstanding leadership of the Coach of the Year--Dan Carr--could not be denied, and the Lions are again champions.

And, Mr. Speaker, the abilities and attitudes these players show on the basketball court will bode them well in their future endeavors and careers.

These young men exemplify the spirit that built our state and nation, and all that is good about today's youth.

Linton is only the sixth team in the history of the State Class B tournaments to win consecutive championships.

Minot Model High was one of those schools, and they accomplished this twice, and one of those times with Representative Jim Peterson on the team.

Linton earned its way to the State Class B in both 1984 and 1985 by defeating a strong team of Ashley Aces, another Legislative District 30 school.

Lest you think, Mr. Speaker, that the Lions are invincible, I will remind you that their only loss to a Class B school this season was to the Lehr Leopards, also of District 30.

Mr. Speaker, if Linton can repeat in 1986, it will have its third consecutive championship, a feat that has not yet been accomplished in Class B.

But the Ashleys, Lehrs, and others will be out there doing all they can to prevent it.

And that, Mr. Speaker, is as it should be. Competition in sports and academics is a very good thing, and the High School Activities Association is to be commended for fostering both.

No person shall may purchase, or attempt to purchase, a hunting, trapping, or fishing license or permit during a suspension period. If the court so ordered, no person who has had a hunting license suspended may purchase or attempt to purchase a hunting license nor may the commissioner return a valid hunting license until the person has successfully completed the course of instruction provided for in section 20.1-03-01.1 and as prescribed by the proper state or provincial natural resources or wildlife management agency. A certificate of completion for a similar course issued by any other state or province of Canada is sufficient to meet this requirement. The person shall file proof of that completion with the court.

For the purpose of this section, the term "conviction" includes an admission or adjudication of a noncriminal violation."

Commingling of production - Central production facility - Metering of production - Testing of meters. A producer may not commingle production from two or more wells for oil or gas in a storage facility without prior approval of the commission. If the commingling of production is for the express purpose of separating, metering, holding, and marketing for production, the owner of the wells shall apply to the commission for approval of the proposed commingling of production at a storage facility. If wells producing into a centralized storage facility have diverse ownership, the production from each well must be measured by meters approved by the department of weights and measures or by some other method the department of weights and measures has approved after notice and hearing. If wells producing into a centralized storage facility have common ownership, including the common ownership of the working interest, the common ownership of the royalty ownership, and the common ownership of any overriding royalty owners, the production from each well need not be measured on meters approved by the department of weights and measures if the owner of the wells demonstrates to that department that the production from each well can be accurately determined at reasonable intervals by other means.

SECTION 2. A new section to chapter 64-02 of the North Dakota Century Code is hereby created and enacted to read as follows:

Duty of department to test accuracy of oil production meters. At least quarterly, the department shall test and calibrate the accuracy of meters used to measure oil production under section 1 of this Act. The department shall contract for the testing of meters. A contract made by the department to test meters may provide that the owner of the wells shall pay a fee for testing a meter and the costs incurred in testing the meter. The owner of a well shall replace or repair any meter that has a variance in excess of one percent. The department shall, in accordance with chapter 28-32, determine the fee to be charged for testing meters.

- On page 1, line 9, delete the word "blackjack" and insert in lieu thereof the word "twenty-one"
- On page 2, line 10, immediately after the comma insert the words "the level of gaming tax assessed by the state and its purpose, the extent to which charitable gaming proceeds are returned to the state or the communities in which they are generated,"
- On page 2, line 13, immediately after the word "Council" insert the words "seek the input of private citizens in this state, both proponents and opponents of gaming expansion, who have expertise and knowledge of the many facets of charitable gaming, and"
