- 1. For property other than mobile homes subject to tax under chapter 57-55, all taxes levied upon the property must be paid in full.
- 2. For mobile homes subject to tax under chapter 57-55, the tax levied upon the property for the current year and the most recent preceding year must be paid in full.
- SECTION 2. AMENDMENT. Section 57-22-18 of the North Dakota Century Code is hereby amended and reenacted to read as follows:
- 57-22-18. Conditional sales Taxes payable before change of possession. If personal property has been sold or transferred under a conditional sale contract, the owner, holder, or assignee of such contract shall not attach nor repossess such property nor acquire it by bill of sale, on account of the cancellation or foreclosure of such contract, until the taxes levied upon the said property have been paid in full as follows:
 - 1. For property other than mobile homes subject to tax under chapter 57-55, all taxes levied upon the property must be paid in full.
 - 2. For mobile homes subject to tax under chapter 57-55, the tax levied upon the property for the current year and the most recent preceding year must be paid in full."
- On page 3 of the engrossed bill, delete lines 9 and 10
- On page 3 of the engrossed bill, line 31, remove the overstrike over the words "for the preceding year"
- On page 5 of the engrossed bill, line 31, delete the word "and" and insert in lieu thereof the word "or"
- On page 5 of the engrossed bill, line 34, after the period insert the following sentence: "While the mobile home is being transported, a permit must be displayed on the mobile home or the owner must provide the mover with a current tax release statement."

MESSAGE FROM THE SENATE SENATE CHAMBER

MR. SPEAKER: I have the honor to return herewith HB 1638 and HCR 3096 which the Senate has amended as follows:

SENATE AMENDMENTS TO ENGROSSED HB 1638

On page 1 of the engrossed bill, line 1, after the words "A BILL" delete the remainder of the bill and insert in lieu thereof the following: "for an Act to amend and reenact section 57-61-01 of the North Dakota Century Code, to make permanent the rate of the coal severance tax in effect on July 1, 1987.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE STATE OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 57-61-01 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

- 57-61-01. Severance tax upon coal Imposition Computation of increases In lieu of sales and use taxes Payment to the tax commissioner. There is hereby imposed upon all coal severed for sale or for industrial purposes by coal mines within the state a tax in an amount to be determined as follows:
 - Eighty-five cents per ton of two thousand pounds [907.18 kilograms]; and
 - For every four point increase in the index of wholesale prices for all commodities prepared by the United States department of labor, bureau of labor statistics, the amount of the severance tax provided in subsection 1 shall be increased one cent per ton of two thousand pounds [907.18 For the purposes of this kilograms). computation, a fractional point increase shall be disregarded if less than one-half point and treated as one full point if one-half point or more. The state tax commissioner shall determine such increases based upon increases in the wholesale price index from the level of such index as of June 1979 to the level of such index as of December 1979 and of May and November of each year thereafter, and any increases based upon the level of the index in May shall be effective on and after the following July first and any increases based upon the level of the index in November shall be effective on and after the following January first. At no time shall the amount of the severance tax be reduced. If the wholesale price index declines, the severance tax shall remain at the highest level determined prior to such decline, and shall remain at such level until further increases are warranted because of further increases in the wholesale price index beyond the point at which the last increase was determined. Notwithstanding the other provisions of this section, the rate of the severance tax as determined pursuant to this section which is effective on July 1, 1987, shall remain the rate in effect for all coal severed after July 1, 1987.

Such severance tax shall be in lieu of any sales or use taxes imposed by law. Each coal mine owner or operator shall remit such tax for each month within twenty-five days after the end of each month, to the state tax commissioner upon such reports and forms as the tax commissioner shall deem necessary. If the method of determining increases in the amount of the severance tax provided in subsection 2 is for any reason held to be invalid, such decision shall not affect the validity of the amount of the tax provided in subsection 1."

REMARKS OF GOVERNOR GEORGE A. SINNER

My distinguished friends: As I look around I remembered that twenty-two years ago I came here as a young legislator. There were here at that time Representative Haugland, Representative Oscar Solberg, and former Governor Art Link and others I remember well. I hope I didn't miss anyone. But you know as well as I, and better than I, what distinguished servants of this state these people have been through these twenty-two years. And one of the great honors of my life is to have served with them because they are such remarkable people who have given such an amazing part of their life to public service. In many ways they put into human form the comments that Dr. Robinson who passed away this week made about North Dakota politics. He characterized North Dakota politics, among other things, as being affected by several things: our remoteness; interestingly enough, he highlighted our independence; also very interestingly, our radicalism; and he also talked about our economic disadvantage.

I remember an article that was in the Saturday Evening Post a number of years ago about Bill Langer; it was entitled Wild Bill Langer of North Dakota. The writer talked also of this radicalism from the Plains and said a line that has always struck me as rather interesting—it was a lady writer and I can't recall her name—but the opening sentence was: Bill Langer typifies North Dakota politics. On domestic issues he's a little to the left of the New Deal; on international issues, he's a little to the right of the Chicago Tribune. There was in the article an interesting analysis of the independence, the fierce fighting nature of North Dakota politicians. And I thought in many ways that it was an honor to North Dakota that North Dakota people didn't back away from anybody, over anything, but fought for their ground and usually held it.

Today, a hundred years into the history of legislative action in this state, I think, for me, it's important to realize that what has passed is really only a prologue and that we must go on enriching our experience in legislation and legislative policy and action and, that I must see more clearly than ever before, the policy nature of this body.

While I don't think that we can haphazardly call special sessions, and I don't want to call special sessions unless we have to, and I think we should do everything we can to avoid it, I am perfectly willing to do so and I feel sufficiently comfortable with the leadership of this body on both sides of the

aisle, to know that if I need a special session to deal with whatever the issue, I need not hesitate to call it, and believe me I will not.

We are clearly, as has been said too many times probably, in troubled times, but we must face the future together and we must do it with the least amount of rancor possible. We must present for our state a working team. I'm delighted to be with you on this hundredth anniversary celebration and, believe me, it's a pleasure to work with you. Thank you very much.

REMARKS OF JOHN PAULSON

Governor Sinner, Governor Guy, members of the House, the Supreme Court, and fellow North Dakotans. It's taken me fifty years, but finally Cass County got even: George Sinner from Casselton, Bill Guy from Amenia, and me from Fargo.

The Legislature is where all of North Dakota comes together. You come from every county, well, not every county, multicounties, every section of the state, representing all the constituents. For many years, when I was out here, I figured you came from the four corners of the state to pick on imperial Cass. Well, we survived and you survived. Now, a former Speaker of this House, Stan Saugstad, asked me, as a member of the North Dakota Centennial Commission, to give to you a little briefing of what we hope to do in 1989, the Centennial year of North Dakota's statehood. Stan is stranded by snow up in Minot, which does happen in North Dakota springtime.

The story of legislative sessions in North Dakota, or in what is now North Dakota, started one hundred years ago when a new Capitol had been built for the Dakota Territory. It seems that a Burleigh County sheriff, Alexander McKenzie, went down to Yankton and connived, or at least met with the legislature and the governor, and they set up a capital removal commission in 1883 to take the territorial capital from Yankton, which is on the Nebraska border, to some more central location.

There were a majority of South Dakotans on that commission, but it finally voted five to four to move it to Bismarck. I guess it was a mixture of clout and persuasion and Mr. McKenzie apparently had them both.

But the fight wasn't over. Bismarck had to put up 160 acres of land and \$100,000. The Capitol was built. Just two years ago the representatives of that Capitol building commission turned over the minutes of the capitol building commission to the State Historical Society; Mr. Spaulding of Fargo had kept them in the grand Masonic library in Fargo and the Masons have delivered them

to the state, so the record is now safely in Bismarck. But, in 1885, if we had to leave it to the Legislature, there probably would never have been a North Dakota. The southerners were outraged at the way the capitol was moved all the way from Yankton to Bismarck, and they were determined to pass a bill to move the Capitol from Bismarck to Pierre. Well, they had the votes. It took them awhile, but in the waning days of the 1885 session the bill was passed to pick up the new Capitol, or at least the offices, leave the building as something for Bismarck to worry about, and go to Pierre for the next session. Unfortunately for the southerners, shortly before the bill was passed, Sheriff McKenzie of Burleigh County and others arrested three representatives of the main South Dakota railway and charged them with bribery. They not only had the witnesses, they had the \$1,000 that was handed to the member of the legislature and it looked as though the southerners were caught red-handed.

Well, the bill went to the territorial governor, Gilbert Pierce. He vetoed it - not on the basis of fraud or bribery, but on the basis that a legislature could not impinge on the sanctity of a contract and that the Capitol removal commission, as an agency of the territory, had made a contract with Bismarck to establish the Capitol here. Whether it was the bribe or the ability of the territorial governor, I don't know, the veto was sustained and the Capitol remained in Bismarck.

The southerners had no luck in court and so they went the statehood route. They had constitutional conventions in 1883 and 1885, they were traveling to Washington continuously, the northern section was content to remain a territory, but with the pressure of the southerners and other states, we were dragged into statehood in 1889. That is an event of government and that is the event we will celebrate in 1989.

We are asking you, as representatives of all sections of the state, to carry the word back to your homes that we want everybody to participate at the local level and at the state level. Of course, the main show will have to be in Bismarck because statehood is a governmental affair. We want it to be more than just another birthday party. We hope it will be a year-long salute, a vote of thanks to you legislators, to our elected officials at the state, county, school, township, and city levels, as well as to our judges and justices. These are the men and women who over the years have had the courage and intestinal fortitude to present themselves to the voters and say, in effect, "Elect me--I am the person best qualified to run your government, your schools, your colleges, and courts, and to decide what taxes you must pay. It takes tough-minded individuals to put themselves in that position and North Dakota has needed that kind of elected officials over the years.

I came to my admiration of the politicians and the officeholders through a long love affair with North Dakota. Both my parents were born in Dakota Territory. My mother would have been one

hundred years old just last October. Dad came along a couple years later, but at age twenty-one he was in Bismarck as a legislative correspondent, in 1909, for the Grand Forks Herald. He kept at his trade even after he'd switched to the Forum. I came to Bismarck as a legislative correspondent the same year as one of your House members arrived - Representative Brynhild Haugland and I are of the class of 1939. She has greater staying power. For the last four years I've been in that position of looking, but, as a former editor, not being able to tell you people how to run your business. Now I'm here asking for your help.

Dad became friends with Alexander McKenzie when he was out here in 1909, and so the family connection goes back a long way.

When statehood came, the railroads no longer dominated state government. The farmers who had been imported to till the land and raise the crops that gave the railroads a cash cargo wanted to run their own government and through the years they did.

The ups and downs of government are too great to mention in this brief talk, so we'll jump to 1935, when this Capitol replaced the one that was nearly vacated in 1885. That old structure was destroyed by fire December 28, 1930. I got my first taste of North Dakota politics that day. My dad put me in his car and we drove out to Bismarck and that evening I sat quietly in the corner of Governor George Shafer's den in the old Governor's Mansion as he and Dad talked about the problems of getting a legislature to work one week after the fire. Well, that was done and the planning was made for a new Capitol.

Of course, Bismarck had to defend its status as a capital city against Jamestown. Jamestown initiated a constitutional amendment to move the capital from here to there. Well, for some reason, Bismarck prevailed by a rather lopsided vote--170,000 to 24,000--and they put up a Capitol that I'm sure will never be moved.

The events of the 1930's did center around the Capitol because drought and depression ruled the day and they ruled politics. Many, or a majority of, North Dakotans were looking for public welfare--a new brand of help to the citizens, something that hadn't been necessary before. The state was not collecting taxes in 1933, during Governor William Langer's first term, the legislature passed a two-percent sales tax, but it was referred and soundly defeated by a three-to-one margin. People didn't want taxes, they wanted the money to come from somewhere else.

So there were a few other things going on, Governor Langer was removed from office because of troubles with the federal government, he couldn't run for reelection in 1934, and the new Capitol opened in January 1935, with a Democrat, Tom Moodie, as Chief Executive. He was a reporter-editor from Williston, but, unfortunately, he had failed to maintain a continuous residence

in the state for five years before taking office, and the proof was displayed, and he was removed from office within six weeks. The Chief Executive became Walter Welford, a former member of the Senate, and by that time an anti-Langer leaguer.

But like all legislative sessions, or almost all, they recognized a problem. You can't operate the government without money. They passed the sales tax again, but this time they earmarked it for schools and public welfare and the sales tax has stayed on the books. So has the state aid to schools, we've still got the equalization bond. So has the public welfare agency, they call it social welfare now, but it's all there and you, I know, are concerned about whether the sales tax stays at four percent or goes to five. That's not too bad--it's only doubled in 50 years as compared to taxes in some other states.

There were other individuals in that 1935 session: Representative Franklin Page is still alive and well up in Pembina County. I talked to him the other day about the time he, with the help of Democrat Rosie O'Brien, organized a new coalition in the 1953 Senate to take control away from the old Republican organizing committee. It was something he fondly remembers. A member of the House in 1935 was one Axel Olson, who left his own legacy, a personal legacy, Lieutenant Governor Ruth Meiers.

So, in 1935, we were beginning to approach our modern level of politics. One of the members was Senator Young, who ten years later went to Washington for thirty-five years. One of the outstanding resolutions of that 1935 session was one asking the federal government to build a dam on the Missouri River near Garrison in order to divert water to the parched acres of central and eastern North Dakota. Well, the dam was built, I've been deeply involved in trying to get diversion, and hopefully we will get it before the Centennial comes.

We have persevered. The Centennial Commission has asked the House and Senate to name two members each to our commission so we can get fully organized by 1987 to do all the work necessary to put on a grand celebration so that we will recognize that 100 years for a human is fairly old, for a government it's just coming into maturity. You can give a great start on this celebration by helping us through the next four years. As I have said, the Legislature is the engineer and the director of the locomotive of change that takes place in our state and local government. Thank you very much.
