The proceeds resulting from the sale of bonds authorized under section 11, or so much thereof as may be necessary, plus any available funds received from federal or private sources, are hereby appropriated for the construction and the equipment of the facility authorized in section 11. Any unexpended balances from the sale of bonds shall be placed in sinking funds for the retirement of the authorized bonds.

SECTION 13. Board of higher education - Bond issuance - Purposes. The state board of higher education, in accordance with chapter 15-55, is hereby authorized to issue and sell self-liquidating, tax-exempt bonds in any amount up to but not exceeding two hundred fifty thousand dollars for the purpose of constructing a revenue-producing addition to the auxiliary services building at North Dakota state university. Bonds issued under the provisions of this Act shall not become a general obligation of the state of North Dakota.

SECTION 14. USE OF PROCEEDS - APPROPRIATION. The proceeds resulting from the sale of bonds authorized under section 13, or so much thereof as may be necessary, plus any available funds received from federal or private sources, are hereby appropriated for the construction and the equipment of the facility authorized in section 13. Any unexpended balances from the sale of bonds shall be placed in sinking funds for the retirement of the authorized bonds.

SECTION 15. Board of higher education - Bond issuance - Purposes. The state board of higher education, in accordance with chapter 15-55, is hereby authorized to issue and sell self-liquidating, tax-exempt bonds in any amount up to but not exceeding one million dollars for the purpose of remodeling of revenue-producing airport facilities and consolidation of existing revenue aviation facility debt at the university of North Dakota. Bonds issued under the provisions of this Act shall not become a general obligation of the state of North Dakota.

SECTION 16. USE OF PROCEEDS - APPROPRIATION. The proceeds resulting from the sale of bonds authorized under section 15, or so much thereof as may be necessary, plus any available funds received from federal or private sources, are hereby appropriated for the purpose of remodeling of revenue-producing airport facilities and consolidation of existing revenue aviation facility debt authorized in section 15. Any unexpended balances from the

sale of bonds shall be placed in sinking funds for the retirement of the authorized bonds."
