SEN. REITEN ANNOUNCED that Colonel Christopher Branch of the 91st Strategic Missile Wing at Minot Air Force Base, who is the Strategic Wing Commander, is in the chamber.

SEN. NELSON MOVED that the President appoint a committee of two to escort Colonel Branch to the rostrum, which motion prevailed. The President appointed as such committee Senators Holmberg and Redlin. Colonel Branch was escorted to the rostrum and addressed the Assembly.

SEN. NELSON MOVED that the remarks of Colonel Branch be printed in the Journal, which motion prevailed.

Madam President, Senator Reiten, and distinguished Senators, ladies and gentlemen: It is a privilege and an honor to appear before this august body. I, too, share your pride in the efficiency and openness with which you conduct the state government. In reviewing with you how you do your business, I wish the federal government could deport themselves in as efficient and businesslike manner.

I want to assure you that we are responsible stewards of your and my taxpayer dollars. We represent the military, and I am proud to stand here from both the Air Force and Strategic Air Command and the two strategic bases that are located in the great state of North Dakota. We have highly trained, highly motivated and dedicated men and women who take care of the business of national defense. There are three, what are called, dual-wing bases in Strategic Air Command. Two of those dual-wing bases which contain both Minuteman ICBM's and strategic bombers are located in the state of North Dakota. That means that there are two wings of B-52 bombers, two wings of KC-135 tankers, two detachments of helicopters for support, and two wings of Minuteman missiles over a hundred and fifty at each base, three hundred - almost one-third of our strategic ICBM inventories is located in North Dakota.

At Minot Air Force Base, I represent over fifteen thousand men and women; about seven thousand active duty military and civilian and about eight thousand dependents and families - over fifteen thousand people who are proud to live in North Dakota.

We're pleased and honored to be accepted as members of your community, and we are very impressed with all we have seen here today. In Minot Air Force Base, we have the Fifth Bombardment Wing, which has the B-52 H-model and a worldwide force projection capability. It is the largest far alert force in Strategic Air Command. It is the second oldest bombardment wing in Strategic Air Command. We also have the modern F-15 fighter plane which we're converting to for the Fifth Fighter Interceptor Squadron. And we also have the Minuteman 3 intercontinental ballistic missile with command data buffer which has an ability to instantaneously retarget its missiles, and the latest reentry system. So we are the most modern assemblage of strategic and tactical forces in the Air Force inventory right in Minot. Together, we comprise an extremely effective and capable strategic deterrent force.

We have been very impressed with all that we have seen here today in looking at the way you run your business, and it's been a privilege for us to be here with you. I want to extend personally to all of you the invitation this summer to come visit either Minot or Grand Forks, and we will be sending those invitations out to all of you. Thank you very much for the privilege and honor of appearing before you today, and we are proud to serve in this great state of North Dakota. Thank you, ladies and gentlemen.
