I would say that my position is postured largely on the belief that the most important area of concern of this state should be primary and secondary education of the children of this state. Total funding for the project is \$20 million, of which \$18\$ million is from the resources trust fund, \$1.5\$ million is from the lands and minerals trust fund, and \$500,000\$ is from the general fund.
