- All funds heretofore appropriated or hereafter 2. appropriated or transferred to the department, whether earmarked or designated for special projects or special purposes or not, shall be placed or transferred into a single state highway fund in the office of the state treasurer and any claims for money expended by the department upon warrants prepared and issued by the department of accounts and purchases office of management and budget and signed by the state auditor under the provisions of this title shall be paid out of the state highway fund by the state treasurer; provided, however, that the commissioner shall keep and maintain complete and accurate records showing that all expenditures have been made in accordance with legislative appropriations and authorizations.

The state treasurer shall invest the moneys in the state highway fund and shall deposit any income derived from the investment of that fund in a special fund which may be used, within the limits of legislative appropriation, exclusively for the construction and maintenance of access roads to and roads within outdoor recreation areas as designated by the parks and recreation department in consultation with the state outdoor recreation interagency council."
