#### POINT OF PERSONAL PRIVILEGE

**REP. STRINDEN:** Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

We have just considered two bills, HB 1448 and HB 1602, which are of significant importance to the state of North Dakota and to our citizens. We will be considering a resolution which will place a study committee to work with the nursing home industry, the health providers, and the Department of Human Services, to hopefully reconcile the differences which exist at the present time as well as to recommend to the next legislative session, changes which may be needed in HB 1448.

In my opinion the Legislature, the House of Representatives, made the right decision in passing HB 1448 and in rejecting HB 1602. As much as we respect the home care industry, the nursing home industry, and the providers and the excellent people we have working in this industry on behalf of many who need help and assistance, we would be wrong to place in our statute the type of requirements that only should be set by administrative decision and administrative control.

**REP. R. BERG REQUESTED** that the question of the final passage of HB 1639 be divided to have the sections voted on separately in the following manner, which request was granted.

#### DIVISION A

On page 1, line 1, after the words "A BILL" delete the remainder of the bill and insert in lieu thereof the following: "for an Act to authorize the industrial commission to issue evidences of indebtedness for the construction of various buildings and facilities at state agencies, departments, and institutions; to create and enact a new section to chapter 54-17.2 of the North Dakota Century Code, relating to evidences of indebtedness issued by the industrial commission and continued authority of the commission as the North Dakota building authority; to amend and reenact section 22 of chapter 571 of the 1985 Session Laws of North Dakota, relating to the continuing appropriation of moneys related to the projects; and to repeal section 21 of chapter 571 of the 1985 Session Laws of North Dakota, relating to projects authorized by the forty-ninth legislative assembly.

# BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE STATE OF NORTH DAKOTA:

**SECTION 1.** A new section to chapter 54-17.2 of the North Dakota Century Code is hereby created and enacted to read as follows:

Although the authority to issue evidences of in	debtedness
for specific projects may terminate, the

commission under this chapter and may comply with any covenants entered into before the applicable termination date.

SECTION 2. AMENDMENT. Section 22 of chapter 571 of the 1985 Session Laws of North Dakota is hereby amended and reenacted to read as follows:

SECTION 22. CONTINUING APPROPRIATION. The moneys received by the commission and the state agencies and institutions from the sale of evidences of indebtedness, lease rental payments, and from revenue generated by projects authorized under section 21 of this Act by the legislative assembly are hereby appropriated as a continuing appropriation for the acquisition of these authorized projects and the payment of lease rentals for these projects.

That portion of Section 3 that reads as follows:

SECTION 3. AUTHORITY TO ISSUE EVIDENCES OF INDEBTEDNESS. The industrial commission may issue, until June 30, 1989, evidences of indebtedness under North Dakota Century Code chapter 54-17.2 to defray that portion of the project costs associated with the acquisition or construction of the following projects hereby declared to be in the public interest:

Provided, however, that the industrial commission shall first offer the evidences of indebtedness authorized under this section for sale to the Bank of North Dakota at a price that is as representative as possible of the current market interest rates for comparable securities purchased by the Bank of North Dakota, taking into consideration in the determination of price the costs of issuance including future administrative and other costs associated with credit enhancements. If the price at which the evidences of indebtedness are offered for sale to the Bank of North Dakota including the consideration of all costs of issuance including future administrative fees and other costs associated with any credit enhancements is higher than the price available for the sale of evidences of indebtedness offered for sale with the same terms and conditions at public sale or through private negotiated sale under prevailing market conditions for comparable evidences of indebtedness, the industrial commission shall not sell the evidences of indebtedness to the Bank of North Dakota, but shall sell the evidences of indebtedness at either public sale or a private negotiated sale under whatever terms and conditions are authorized for the sale of evidences of indebtedness under North Dakota Century Code chapter 54-17.2.

SECTION 5. APPROPRIATION - ADDITIONAL FUNDS. In addition to the appropriations and authorizations set forth in this Act, there is hereby appropriated to the state institutions listed herein, any moneys available from federal or other sources to purchase, construct, or renovate the buildings and facilities set forth in this Act for the biennium beginning July 1, 1987, and ending June 30, 1989.

SECTION 6. REPEAL. Section 21 of chapter 571 of the 1985 Session Laws of North Dakota is hereby repealed."
