## **REMARKS**

by Honorable Byron L. Dorgan United States Congressman

Mr. Speaker and members of the House, I am pleased to be able to appear here today at your invitation and visit with you just a few moments about what's happening in Washington, D.C., or probably more importantly what's not happening in Washington, D.C. At any rate, I recall fondly the many years that I spent discussing with some, and perhaps the majority, on a lot of public policy issues, sometimes strenuously and vigorously, Representative Strinden, always, however, with good cheer and I do recall, after seven statewide campaigns, putting a lot of miles on across North Dakota, that if there is one impression left with North Dakota citizens about Republicans and Democrats who are North Dakota's legislators, it's that they are hard working and honest and have served North Dakota well and faithfully. I am pleased to be a part of that process and want to commend you for all the work you are doing.

This is not an easy session. I don't have to tell you that but I've watched what's going on here and it's a tough, tough situation you're involved in but, somehow, over the years, North Dakota's Legislative Assembly has always made the tough choices and, in most cases, made the right choices and for that I think North Dakotans owe you a debt of gratitude.

All of us who are in politics understand that, while some might admire what we do, there are others who have different opinions of what we do. We are subject sometimes to moments of humor, lighter moments. In the Cannon Building, right near the elevator, the Internal Revenue Service, attempting to be helpful, apparently, to members of Congress, recently put up a sign that said the IRS will provide tax help to the disabled, the illiterate, and members of Congress and someone had written on bottom of that, as they were waiting for the elevator that the last two are redundant.

I'd like to just mention today a few things that are happening in Washington. First, I guess you couldn't talk about what's going

on in Washington without talking about the Iranian arms situation and, I think it is safe to say, it has virtually paralyzed the administration for the moment. I think it's also safe to say the appointment of Howard Baker is going to go a long way towards restoring some confidence in what's going on. He's a savvy, smart politician who knows what he's doing and I think that's a step forward.

The Tower Commission Report is a very sobering document. I encourage all of you to read it. It suggests that we had some folks who disserved this President, who conducted scary foreign policy without adult supervision. I think it's something we all ought to take a look at and learn from. I think that the appointment of Howard Baker is a major step forward and hopefully will remove us beyond this issue.

Some North Dakota issues I wanted to mention today:

Garrison Diversion: Garrison Diversion is a project that has been the subject of a lot of controversy over the years. We finally passed a reformulation of the Garrison Diversion Project. We appropriated 33 million dollars for it in this fiscal year. The interior secretary was attempting to take three million dollars in reprogramming and move it to a water project in Wyoming. We think we now have that stopped. The administration has recommended the funding for next year be two and one-half million dollars, from 33 to two and one-half. That virtually would shut down the project. We could not keep the engineers working and current staff with two and one-half million dollars. It's my judgment that the administration will not succeed and that we will attempt to get the same 33 million dollars that we had this year. I don't happen to think we should fight for the capacity that is being exhibited. They say that there's capacity for 45 million dollars. I think it ill-serves us if we say that we support a freeze in spending, for us to say that we support a freeze in everything else, but, on Garrison, we want you to go from 33 to 45. I am going to be fighting for retaining the 33-million-dollar level and I think there's some hope that we can do that in the House and the Senate.

ANG: The coal gasification plant, I think, is critically important to this state, to its economy. The secretary of energy, Harrington, has been pretty forthright with us. He has worked with us, has indicated that he wants to keep that plant operating, has done so through the Department of Energy, has now found an investment banking firm which is attempting to market this project. It is our hope that that will be successfully accomplished so that the project can continue operating and employing people and producing gas.

It's a marvelous feat of engineering, operating at above 100 percent of capacity, believe it or not, not costing the government money at this point. I think what we ought to do is make certain that either this gets marketed through the

investment banking firm or, if not, continue to see it operated by the Department of Energy. I think there is some hope in both instances and I think it's going to take a lot of hard work from all of us to accomplish it, but we must accomplish it because it's that important to the state.

Revenue sharing - Grants-in-Aid - EDA - CDA: I think it's safe to say that there's been a dramatic change because of the country's fiscal policy problems and I think that most of you understand that revenue sharing has been zeroed out. The President recommended that for a couple of budgets and finally Congress did it. Most of the other programs are not going to see increases, some of them are going to see decreases, and, some of them, fairly substantial decreases.

Farm Bill: Not everyone's unhappy with the farm bill. The peanut folks think it's fine, rice folks love it, cotton folks are happy, but, in the middle part of this country, in a strip up and down this farm belt where wheat and feed grains are the predominant crops, we're in a deep and abiding and serious recession and, in my judgment, those of us, and I count myself as one who will fight to open up the wheat and feed grain section of the farm bill, will likely succeed in doing so. The new Speaker of the House has pledged his commitment to doing something about the recession in the farm belt and I think the chances are that the wheat and feed grain section will be opened up this year.

Let me mention briefly that my service on the Ways and Means: Committee has taught me what I'm sure all of you already know. I just was standing in the back of the room and saw a vote go up on the board and I suppose a few of you might have been puzzled about the way somebody else votes. It took me a while in Congress to learn about that. I didn't have the legislative experience here, I was up in the executive branch in the tower, but had I had the legislative experience, I would have learned more quickly. A friend of mine from a southern state about four years ago when we had a Garrison vote, one in which we lost incidentally, and then came back and won the vote a little later, a friend of mine as he left the chambers during the middle of that vote put his arm on mine and said, "Byron, I voted with you;" I said, "Thank you." That night I looked at the vote and I saw he voted against me. The next day I said, "John, you said you voted with me, you didn't vote with me, you voted no on Garrison." "Well, sure," he said, "I voted no when it was clear you'd lost, but I put a yes vote up first." Then I realized that I'd better start learning how this stuff operates down here. I watched the chairman of the Ways and Means Committee who was watched the chairman of the ways and means committee who was implored by one of our members to go along with him and help him get this done and Rostenkowski said, "Ray, I'm going to be with you to the end, count on it." About five hours later, long, arduous hearings, controversial as heck, Chairman Rostenkowski came over to Ray and said, "Ray, this is the end." It took me that long to learn what most of you know in this legislative process, count your votes, then count them again and make sure you have twice as many as you need to make sure you get the majority.

Let me just mention briefly what's going on in the Ways and Means Committee and the projects that we're working on because they encompass the major projects of the 100th Congress. First of all, we're going to write a catastrophic health insurance bill soon. Second, we're going to do welfare reform, both of them in the Ways and Means Committee, and, third, we're going to do a trade bill between now and the end of March. Let me talk catastrophic health insurance and welfare reform. The Reagan administration has supported catastrophic health insurance and I think, for that reason, one is going to be written, passed, and signed by the President and it's long overdue. The Boeing Bill introduced by Secretary Boeing or proposed by Secretary Boeing, is probably not the bill. In that bill, if you live, you lose. That's probably not the right signal we ought to send. We will probably retool that bill to make it more acceptable, but I think, clearly, there will be a catastrophic health insurance bill passed in this session of the 100th Congress.

Welfare reform: We have so many programs to deal with welfare and many of them operated at cross-purposes of one another and we're going to streamline the welfare system so that it works better. Mostly, so that it works. Last week, we had a young woman named Nancy, from St. Louis, who testified before a committee and tears streamed down her eyes as she told us of the cycle of poverty she was trapped in and could not escape from: Saving money, five dollars at a time, on three hundred and twenty dollars a month total income with three children. Five dollars at a time, saving five dollars to try and get a deposit for an apartment so that she could move out of a shelter, but every time she saved money, the AFDC people would reduce her AFDC because now she had savings. Can't get into low income housing, there's a three-year wait so she saves money for a deposit on a rental system: they take money away on the AFDC.

A young woman in low-income housing at the University of North Dakota said when she got a Pell Grant to help pay for her tuition and books, they increased her rent at low-income housing. We have to do better on welfare reform and I'm convinced that the 100th session of Congress will pass welfare reform and this administration has pledged it's cooperation and support, I think that's going to happen.

Finally, we're going to work on trade. Trade and competitiveness is the issue in 1987. There are times when these issues run in cycles and competitiveness is the word these days. Let me say to you, in my judgment, competitiveness not only necessitates a trade bill to straighten out trade inequities, but it especially necessitates all of us to look once again at education. Competitiveness, in the long term, has its roots in education. Secretary Baker testified before us recently and he said the root of our competitiveness problem is in the education system and we

have to do something about it. I asked him why, then, would you propose cutting 28, nearly 30 percent, out of the federal commitment to education. He said because state and local governments pick up the tab for education, but our retreat, as suggested by this administration on the small federal commitment to education, is ill-advised and I don't think Congress will buy it. If you look at the numbers, they are sobering. Japanese high school students are studying math at American college levels. We are one of the few industrial nations left where our classrooms are dark over half the year, 180-days-a-year school; the Japanese kids are going 240 days a year. One-half of the Ph.D.'s educated in this country are foreigners. We produce fewer scientists and engineers on a real basis than Japan, with our population. The study of physics, than half engineering, calculus, etc., is measured in months in the American school system and years in the Soviet and Japanese school systems. I'm saying I think the root of competitiveness once again is education and you and those of us on the state and federal level have to renew our commitment to the education Strengthening the foundation of this country is strengthening its education system. Trade, yes, we have to change the trade rules and you're going to hear a howl in this chamber, I'm sure, in the next weeks when we start deciding what we're going to do because folks say, if you touch the trade problem, you're going to be in big trouble. Japan will buy less from America. Well, that's nonsense.

The Speaker of the House talked the other day about what's going out of our ports in New York and New Jersey. Let me just reiterate what he said: Four ships coming in for every one ship going out, four ships bringing in television sets and Toyotas and electronic gear and computers, four ships coming for every one ship going out. What's our one ship going out taking - number one: scrap steel; number two: used paper. The Apollo showed up from Japan at the Seattle port a couple of weeks ago carrying 65 million dollars worth of computer and electronic gear, it left with 10 million dollars worth of gear, except our gear, which we were shipping out, was wood chips and animal hides. Shipping in six times as much electronics and finished products and shipping out wood chips, steel, paper, animal hides: this country can't exist that way. A 170 billion dollar trade deficit: we can't exist that way and we have to change it. Koreans want to ship their Hondas to America and, almost at exactly the same time, they geared up their campaign to ship Hondas to America they said no more beef will be imported from America, not a pound, they shut them off completely. Country after country around the Pacific rim and others, the EC (other countries) who are trading partners of ours, have systematically discriminated against us in the trading area. Our approach is not going to be, as we write this trade bill, to try and restrict what's coming in. Our approach is going to be to try and fill up those boats going out with finished products and, when we do that, they're going to scream because a lot of folks think we ought to sit back and keep taking it. We can't, we won't survive.

In conclusion, today, I'd like to say that, on a broader economic scale, one of the things I'm working on in Congress is to try and see if we can't change the incentive for those who are enterprisers and enterprising in our economy. We are creating, I'm afraid, a paper economic base in America and we have to change it. We've got to put in place public policies that reward those who create real new wealth in this country, not those who sell things they'll never get from people who never had it and make money on both ends. That motivation is not the right motivation to keep America strong and keep America number one. The rampant speculation is not strengthening this country. The genius of our scientists and engineers that come from an education system that is fully funded, that's what will ultimately strengthen this country. The President rhetorically said it in the State of the Union address. He said, "If not us, who, and if not now, when?" I think, in your session, and we in Congress in our session, in the 100th Congress of this country must answer that by saying it's us, it's only us, and it's now, right now.
