"SECTION 1. AMENDMENT. Section 11-27-01 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

11-27-01. Board of county commissioners authorized to sell property - Private and public sale. The board of county commissioners of any county may dispose of any property, either real or personal, which the county has acquired through purchase, forfeiture, or operation of law other than through tax sale proceedings, ~~in accordance with the provisions of~~ under this chapter. When the property to be disposed of is estimated by the board to be of a value of less than one thousand dollars, it may be sold at private sale upon the proper resolution of the board. In all other cases, ~~such~~ the property may be sold only at public sale or as provided under section 2 of this Act.

SECTION 2. A new section to chapter 11-27 of the North Dakota Century Code is hereby created and enacted to read as follows:

Transfer of real property by nonexclusive listing agreements. As an alternative to public sale under section 11-27-01, the board of county commissioners may by resolution describe the real property of the county which is to be sold; provide a maximum rate of fee, compensation, or commission; and provide that the county reserves the right to reject any and all offers determined to be insufficient. After adoption of the resolution, the board of county commissioners may engage licensed real estate brokers to attempt to sell the described property by way of nonexclusive listing agreements.

"SECTION 5. A new section to chapter 57-28 of the North Dakota Century Code is hereby created and enacted to read as follows:

Private sale between annual sales by nonexclusive listing agreements. The board of county commissioners may by resolution engage licensed real estate brokers to attempt to sell parcels of real estate not sold at the annual November sale. The resolution must authorize sale by way of nonexclusive listing agreements; describe the real property to be sold; provide a maximum rate of fee, compensation, or commission; and provide that the county reserves the right to reject any and all offers determined to be insufficient. Real estate that is subject to a special assessment lien for improvements made by a city shall first be offered for sale to the city."

WHEREAS, North Dakota's thirty-two million acres north and east of the Missouri River is the center of the prairie pothole region, containing most of the remaining wetlands in the prairie pothole region of the United States; and

WHEREAS, the Legislative Assembly recognizes that wetland issues are of significant controversy and importance, that between two and three million acres of wetlands remain in North Dakota, that North Dakota's wetlands produce from two and one-half million to six million ducks each year, depending on the wet and dry cycle, and that wetlands have various other values and functions; and

WHEREAS, the Legislative Assembly recognizes that the United States Fish and Wildlife Service has extensive fee title and easement holdings in North Dakota to protect wetlands; and

WHEREAS, the Garrison Diversion Unit was reformulated by the Congress of the United States in 1986, revising the project significantly and altering both the shape, size, and benefits to be received by North Dakota from the project; and

WHEREAS, it is necessary to have legislative study and oversight of issues relating to restoration and stabilization of Devils Lake, wetland issues, the

reformulated Garrison Diversion project, and related issues;"

The House is in receipt of your letter of March 13, 1987, indicating your desire to veto HB 1040. Section 9 of Article V of the Constitution of the State of North Dakota states: "If any bill shall not be returned by the governor within three days (Sundays excepted) after it shall have been presented to him the same shall be a law"...

Our records and the bill itself indicate HB 1040 was delivered to the Governor at 8:59 a.m., March 11, 1987. The record shows you vetoed the bill at 1:52 p.m. the following day, March 12, 1987.

Apparently typing your veto message and walking down the hall with it took over a day and a half.

MONDAY, MARCH 16, 1987

1905

The House desk was attended until 6:15 p.m., March 13, 1987. The desk force (as in every session) has always been available at night or weekends to receive messages from the Governor.

I interpret the Constitutional words "within three days" to mean three calendar days (Sundays excluded) including the day of receipt. Therefore, a bill received by the Governor on Wednesday should be presented to the House of origin by 9:00 a.m. Saturday.

The veto message on HB 1040 communicated to the House of Representatives and signed for was not in our receipt book until Monday, March 16, 1987.

Therefore, I am returning HB 1040 as passed by the House and Senate for your signature and filing with the Secretary of State.
