The information filed with the board must include a description of the property, the identity of the data acquired by gift, the date the property was acquired or received, any conditions on acceptance of the property if description of the property, the identity of the donor given by gift, and appropriate evidence of ownership. The information must also indicate whether the property is intended for permanent or long-term exhibition on the capitol grounds or in public areas in the state capitol. With respect to property intended for permanent or long-term exhibition on the capitol grounds or in public areas in the state capitol, the state historical board shall notify the state council on the arts. The council on arts shall advise the capitol grounds planning sion with respect to permanent or long-term the commission with respect exhibition of such property on the capitol grounds. The

- council on the arts shall advise the capitol arts and historic preservation advisory committee with respect to permanent or long-term exhibition of such property in public areas in the state capitol. Prior to transfer of ownership or other disposal of property documented and inventoried under this section, that property must be offered to the state historical board for inclusion in its historical collections."

  - d. Snowmobiles operated upon lands owned or leased by the snowmobile owner.
  - e. Snowmobiles incapable of speeds in excess of ten miles per hour and with an engine displacement of less than one hundred cubic centimeters."
