### STATEMENT OF PURPOSE OF AMENDMENT:

The amendment decreases the reduction in general fund appropriation authority for the period January 1, 1987, through June 30, 1987, for the following agencies and services by the following accounts:

Personal property tax replacement	\$ 125,000
State revenue sharing Department of Public Instruction	125,000 1,250,000
Predatory animal control	35,000
Total decreases	\$1,535,000

The amendment deletes the general fund reductions for the Secretary of State and the State Auditor of \$30,000 and \$50,000, respectively.

The amendment increases the reduction in the crime victims reparation appropriation authority by \$35,000.

The total general fund reduction is decreased from \$6,967,250 to \$4,637,250, or by \$2,330,000.

The total impact of the bill after the amendment on the general fund including transfers is \$5,137,250. The impact of the bill without amendment is \$8,217,250.

The amendment adds a new section which authorizes the Board of Higher Education to reduce the boards and institutions under the board's control appropriation authority by \$750,000.

The reduction in appropriation authority for tax distribution payments to fire districts is changed from a \$1,000,000 reduction to a \$250,000 reduction.

The transfer from the fire and tornado fund to the general fund is changed from \$1,000,000 to \$250,000.

Section 4 of the bill is deleted which reduced the funding from the coal development impact fund to the Energy Development Impact Office by \$250,000. However, the section transferring \$250,000 from the coal development impact fund to the general fund remains in the bill. Although the bill transfers \$250,000 from the coal development impact fund, at least \$1,000,000 of funding is anticipated for grants.

A new section is added appropriating up to \$2,000,000 to the Department of Human Services of collections from child support.

The section to amend the statute setting the amount of per-pupil payments is deleted to allow the Superintendent of Public Instruction flexibility in determining where the \$1,250,000 reduction is to be made.
