NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NORTH DAKOTA, THE SENATE CONCURRING THEREIN:

That Larry Weller Photography of Mandan, North Dakota, be and is hereby appointed official photographer for the Fiftieth Legislative Assembly of the state of North Dakota; and
