REMARKS

by

Colonel James Buchli

Thank you very much for allowing me to come here today and take a few minutes out of your busy schedule. I know everyone is working hard and, as a taxpayer, I like to see that.

I also apologize for the clothing I am wearing. We flew up from Texas this morning, myself and another astronaut, Mark Lee, who

is in the back over here listening to what I am about to say. These are the warmest clothes I have today. So this is what I'm going to live in while I am here.

I wish I could stand here today and tell you that we are very soon going to be flying our space shuttle again. Unfortunately, I cannot do that. This last year has been very difficult for us at NASA. We have all been working very hard to get back on track. It looks like we probably have about a year's more hard work in order to get the space shuttle back to where we can fly it safely. Many of us that knew the crew, and knew them well, have felt a lot of sorrow this last year and have very much felt the loss of that crew.

We have all dedicated ourselves to making sure that, when we do fly again, we are going to have a vehicle that we can fly as safely as possible and all of us have been working toward that goal this year. It looks as if we will probably be able to start flying the shuttle again early in 1988. We are now scheduled to have our first flight in February of 1988.

There are a lot of things that have to come together before that can happen. We are all very confident that, when we do fly, we will do so safely: that the fixes that we deem mandatory, both operationally and with the hardware, will be made and that we are going to do the best we can to continue in their legacy.

In that regard, there are about eighty of us now down in Houston training, in fact, there are three astronauts from North Dakota: myself, Doctor Tony England from West Fargo, and Rick Hieb who is from Jamestown.

- I think, if you look at the population of North Dakota and take astronauts per thousand people in a state, that North Dakota has the highest astronaut population density of any state in the union. I am not sure what that says, but I think what it says is that, whatever life style is going on up here and continues to go on living up here in God's country, I think, if you continue to do that and we all continue to do that, we are going to be able to put out young people who are well qualified to go wherever they might go and do the best they can and represent this state as the state should be represented throughout the world.
- I thank you very much for allowing me to come and speak to you. When we start flying again and I get a chance to start flying again, I hope many of you will be able to come down and watch one of our launches and watch us when we get back in space and get NASA back on track. Thank you.
