Prior to any acquisition under this Act, the acquiring entity must present a plan to the state department of banking and financial institutions. The plan must provide that the acquiring entity commits itself to the following conditions and procedures:
 - 1. To capitalize each bank to be acquired in this state to a minimum of seven percent capital, or if the acquiring entity intends to sell the bank instead of recapitalizing it to seven percent capital, the plan must include a procedure for offering the bank for sale to the members of the public in the community where the bank is located by public notice of offering for sale. The offer must be open for at least thirty days at a price

- allocated to the purchase of that bank based on the purchase price established in subsection 2, or at a price negotiated in good faith.
- 2. To disclose to the department of banking and financial institutions and minority stockholders of any bank in this state that is to be acquired, the purchase price attributable to each bank in this state that is to be acquired in proportion to the assets of that bank as those assets relate to all of the assets of the holding company and the total purchase price of the holding company.
- 3. To communicate to and offer to purchase the stock of all minority stockholders of banks or bank holding companies being acquired in this state pursuant to this Act at a price equivalent to the purchase price attributed to the bank in which the minority stock is owned. The offer must be made to the minority stockholders within thirty days after the purchase of the bank or bank holding company has been completed. The minority stockholders must respond within thirty days after receipt of the offer.
- SECTION 4. Grants requirement Commitment Reports to attorney general. Any charitable trust that divests itself of any interest pursuant to this Act shall file a commitment with the attorney general prior to any divestiture that the charitable trust will continue to make grants under the provisions of the trust to recipients within this state in the same proportion to the total grants made as the grants made to recipients in this state in 1986 bears to the total grants made by the charitable trust in 1986. The charitable trust must report annually to the attorney general describing the grants made by the charitable trust to all recipients in the previous year. The attorney general must ensure compliance with the provisions of this Act.
- SECTION 5. Designation of agent for service of process. Any charitable trust that divests itself of any interest pursuant to this Act shall designate the secretary of state as its agent for service of process in this state.
- SECTION 6. Acquisition of fifty percent interest. Any acquisition by any entity or entities by sale, assignment, merger, or transfer of at least fifty percent of the stock or assets of a bank or bank holding company is deemed an acquisition pursuant to this Act.
- any form of interstate banking and may not be relied upon by any seller or purchaser of a bank or bank holding

company other than is specifically described in this Act. The authority granted by this Act does not authorize the acquiring entity to resell, reassign, merge, or transfer stock or assets of any state or national bank or bank holding company acquired under this Act except as specifically authorized by the laws of this state."

This Act becomes effective on the date a charitable trust, as defined in this Act, is authorized by the enactment of similar legislation in Wisconsin and Minnesota, to sell, assign, merge, or transfer the stock or assets of any state or national bank or bank holding company located in Wisconsin or Minnesota, respectively, without regard to whether the entity acquiring the stock or assets is located outside of those states.

legislative assembly, and subsections 7, 8, and 9 of section 57-39.2-01, subsection 8 of section 57-40.2-01, and section 57-40.2-03.2 of the North Dakota Century Code, relating to the imposition of sales and use taxes on certain designated services, newspapers, periodicals, and magazines, and to the rate of use tax on alcoholic beverages; and to repeal sections 57-39.2-03.3, 57-39.2-03.4, subsections 16, 22, and 30 of section 57-39.2-04, section 57-39.2-04.1, subsections 10 and 13 of section 57-40.2-04 and section 57-40.2-04.1 of the North Dakota Century Code, relating to exemptions from sales and use taxes.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE STATE OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Subsections 7, 8, and 9 of section 57-39.2-01 of the North Dakota Century Code are hereby amended and reenacted to read as follows:

"Retail sale" or "sale at retail" means the sale, including the leasing or renting, to a consumer or to any person for any purpose, other than for 7. processing or for resale, of tangible personal property; the sale of steam, gas, cable television or other video programming services, electricity services, and communication service to retail consumers or users; the ordering, selecting, or aiding a customer to select any goods, wares, or merchandise from any price list or catalog, which the customer might order, or be ordered for such customer to be shipped directly to such customer; the sale or furnishing of hotel, motel, or tourist court accommodations, tickets, or admissions to any place of amusement, athletic event, or place of entertainment including the playing of any machine for amusement or entertainment in response to the use of a coin; and the sales of magazines and other periodicals. By the term "processing" is meant any tangible personal property including containers which it is intended, by means of fabrication, compounding, manufacturing, producing, or germination shall become an integral or an ingredient, or component part of other tangible personal property intended to be sold ultimately at retail. The sale of an item of tangible personal property for the purpose of incorporating it in or attaching it to real property shall be considered as a sale of tangible personal property for a purpose other than for processing; the delivery of possession within the state of North Dakota of tangible personal property by a wholesaler or distributor

to an out-of-state retailer who does not hold a North Dakota retail sales tax permit or to a person who by contract incorporates such tangible personal property into, or attaches it to, real property situated in another state shall not be considered a taxable sale if such delivery of possession would not be treated as a taxable sale in that state. As used in this subsection the word "consumer" shall include any hospital, infirmary, sanatorium, nursing home, home for the aged, or similar institution that furnishes services to any patient or occupant. The sale of an item of tangible personal property to a purchaser who rents or leases it to a person under a finance leasing agreement over the term of which the property will be substantially consumed shall be considered a retail sale if the purchaser elects to treat it as such by paying or causing the transferor to pay the sales tax thereon to the commissioner on or before the last day on which payments may be made without penalty as provided in section 57-39.2-12.

"Retailer" includes every person engaged in the 8. business of leasing or renting hotel, motel, or tourist court accommodations, and every person engaged in the business of selling tangible goods, wares, or merchandise at retail, or furnishing of steam, gas, cable television or other video programming services, electricity services, and communication services, or tickets admissions to places of amusement, entertainment, and athletic events including the playing of any machine for amusement or entertainment in response to the use of a coin, or magazines, or other periodicals; and shall include any person as herein defined who by contract or otherwise agrees to furnish for a consideration a totally or partially finished product consisting in whole or in part of tangible personal property subject to the sales tax herein provided, and all items of tangible personal property entering into the performance of such contract as a component part of the product agreed to be furnished under said contract shall be subject to the sales tax herein provided and the sales tax thereon shall be collected by the contractor from the person for whom the contract has been performed in addition to the contract price agreed upon, and shall be remitted to the state in the manner provided in this chapter; and shall include the state or any municipality furnishing steam, gas, or communication service to members of the public in its proprietary capacity. For the purpose of this chapter, retailer shall also include every clerk, auctioneer, agent, or factor selling tangible personal property owned by any other retailer.

9. "Sale" means any transfer of title or possession, exchange or barter, conditional or otherwise, in any manner or by any means whatever, for a consideration, and includes the furnishing or service of steam, gas, cable television or other video programming services, electricity services, or communication, the furnishing of hotel, motel, or tourist court accommodations, the furnishing of tickets or admissions to any place of amusement, athletic event, or place of entertainment including the playing of any machine for amusement or entertainment in response to the use of a coin, and sales of magazines, newspapers, and other periodicals. Previded, the words "magazines and other periodicals" as used in this subsection de net include newspapers ner magazines er periodicals that are furnished free by a nonprofit corporation or organization to its members or because of payment by its members

SECTION 2. AMENDMENT. Section 57-39.2-02.1 of the North Dakota Century Code as contained in section 1 of Senate Bill No. 2901, as approved by the fiftieth legislative assembly, is hereby amended and reenacted to read as follows:

57-39.2-02.1. Sales tax imposed.

- 1. Except as otherwise expressly provided in subsection 2 for sales of electricity services, mobile homes used for residential or business purposes and for sales of farm machinery, farm machinery repair parts, and irrigation equipment used exclusively for agricultural purposes and except as otherwise expressly provided in this chapter, there is imposed a tax of five percent upon the gross receipts of retailers from all sales at retail including the leasing or renting of tangible personal property as provided in this section, within the state of North Dakota of the following to consumers or users:
 - a. Tangible personal property, consisting of goods, wares, or merchandise, except mobile homes used for residential or business purposes and farm machinery, farm machinery

- repair parts, and irrigation equipment used exclusively for agricultural purposes.
- b. The furnishing or service of gas, <u>cable</u> television or other video programming <u>services</u>, communication services, or steam other than steam used for processing agricultural products.
- c. Tickets or admissions to places of amusement or entertainment or athletic events, including amounts charged for participation in an amusement, entertainment, or athletic activity, and including the playing of any machine for amusement or entertainment in response to the use of a coin.
- d. Magazines, newspapers, and other periodicals.
- e. The leasing or renting of a hotel or motel room or tourist court accommodations.
- f. The leasing or renting of tangible personal property the transfer of title to which has not been subjected to a retail sales tax under this chapter or a use tax under chapter 57-40.2.

g. Auctions.

- 2. There is hereby imposed a tax of three percent upon the gross receipts of retailers from all sales at retail of electricity services, mobile homes used for residential or business purposes, except as provided in subsection 35 of section 57-39.2-04, and of farm machinery, farm machinery repair parts, and irrigation equipment used exclusively for agricultural purposes, including the leasing or renting of farm machinery and irrigation equipment used exclusively for agricultural purposes within the state of North Dakota to consumers or users.
- 3. In the case of a contract awarded for the construction of highways, roads, streets, bridges, and buildings prior to December 1, 1986, the contractor receiving the award shall be liable only for the sales or use tax at the rate of tax in effect on the date of contract.
- 4. There is hereby imposed a tax of five percent upon the gross receipts from the following services enumerated in the standard industrial classification manual, 1972, as prepared by the

statistical policy division of the office of management and budget, office of the president: business services (major group 73), automotive repair (major group 75), miscellaneous repair (major group 76), legal services (major group 81), lawn care services (group number 078), laundry and cleaning services (group number 721), beauty and barber shops (group numbers 723 and 724), engineering, architecture, and surveying services (group number 891), and accounting, auditing, and bookkeeping services (group number 893).

5. There is hereby imposed a tax of three percent on farm machinery repair services.

SECTION 3. Two new subsections to section 57-39.2-04 of the North Dakota Century Code are hereby created and enacted to read as follows:

Gross receipts from the sale of food purchased after September 30, 1987, with vouchers issued under the School Lunch and Child Nutrition Act of 1966, as amended, in compliance with the school lunch and child nutrition amendments of 1986 [Pub. L. 99-591, section 342].

Gross receipts from the sale of food or food products purchased for human consumption after September 30, 1987, with food coupons issued by the United States department of agriculture under the Food Stamp Act of 1977, as amended, in compliance with the Food Security Act of 1985.

SECTION 4. AMENDMENT. Subsection 8 of section 57-40.2-01 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

- 8. "Tangible personal property" means:
 - a. Tangible goods, wares, and merchandise, and gas, cable television or other video programming services, and electricity services, when furnished or delivered to consumers or users within this state.
 - b. The leasing or renting of tangible personal property, the sale, storage, use, or consumption of which has not been previously subjected to a retail sales or use tax in this state.

- c. The purchase of magazines or other periodicals. Provided, the words "magazines and other periodicals" as used in this subdivision do not include newspapers nor magazines or periodicals that are furnished free by a nonprofit corporation or organization to its members or because of payment by its members of membership fees or dues.
- d. The severance of sand or gravel from the soil.

SECTION 5. AMENDMENT. Section 57-40.2-02.1 of the North Dakota Century Code as contained in section 4 of Senate Bill No. 2901, as approved by the fiftieth legislative assembly, is hereby amended and reenacted to read as follows:

57-40.2-02.1. Use tax imposed.

- 1. Except as otherwise expressly provided in subsection 2 for purchases of electricity services, mobile homes used for residential or business purposes and for purchases of farm machinery, farm machinery repair parts, and irrigation equipment used exclusively for agricultural purposes, an excise tax is imposed on the storage, use, or consumption in this state of tangible personal property purchased at retail for storage, use, or consumption in this state, at the rate of five percent of the purchase price of such property. Except as limited by section 57-40.2-11, an excise tax is imposed on the storage, use, or consumption in this state of tangible personal property not originally purchased for storage, use, or consumption in this state at the rate of five percent of the fair market value of such property at the time it was brought into this state.
- 2. An excise tax is imposed on the storage, use, or consumption in this state of electricity services, mobile homes used for residential or business purposes, except as provided in subsection 19 of section 57-40.2-04, and of farm machinery, farm machinery repair parts, and irrigation equipment used exclusively for agricultural purposes purchased at retail for storage, use, or consumption in this state at the rate of three percent of the purchase price thereof. Except as limited by section 57-40.2-11, and except as provided in subsection 35 of section 57-39.2-04, an excise tax is

imposed on the storage, use, or consumption in this state of electricity services, mobile homes used for residential or business purposes and of farm machinery, farm machinery repair parts, and irrigation equipment used exclusively for agricultural purposes not originally purchased for storage, use, or consumption in this state at the rate of three percent of the fair market value of such electricity services, mobile homes used for residential or business purposes and of such farm machinery, farm machinery repair parts, and irrigation equipment used exclusively for agricultural purposes at the time it was brought into this state.

3. In the case of a contract awarded for the construction of highways, roads, streets, bridges, and buildings prior to December 1, 1986, the contractor receiving the award shall be liable only for the sales or use tax at the rate of tax in effect on the date of contract.

SECTION 6. AMENDMENT. Section 57-40.2-03.2 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

57-40.2-03.2. Use tax on alcoholic beverages and tobacco products. Notwithstanding any other provision of law, the use taxes imposed by this chapter apply to the storage, use, or consumption in this state of alcoholic beverages as defined in section 5-01-01, whether mixed or unmixed at the time of sale or thereafter, and whether sold for consumption on the premises or through off-sale outlets for consumption off the premises, and cigarettes, cigars, and other tobacco products, provided that gross receipts from the sale thereof shall mean and include any other taxes imposed on such merchandise or its use or on the retail or other sale thereof. Notwithstanding any other provision of law, there is imposed a tax of five six percent on the storage, use, or consumption in this state of alcoholic beverages, which is in lieu of and not in addition to any other tax imposed by this chapter.

SECTION 7. Two new subsections to section 57-40.2-04 of the North Dakota Century Code are hereby created and enacted to read as follows:

Gross receipts from sales of food purchased after September 30, 1987, with vouchers issued under the School Lunch and Child Nutrition Act of 1966, as amended, in compliance with the school lunch and child nutrition amendments of 1986 [Pub. L. 99-591, section 342].

Gross receipts from sales of food or food products purchased for human consumption after September 30, 1987, with food coupons issued by the United States department of agriculture under the Food Stamp Act of 1977, as amended, in compliance with the Food Security Act of 1985.

SECTION 8. REPEAL. Sections 57-39.2-03.3, 57-39.2-03.4, subsections 16, 22, and 30 of section 57-39.2-04, and subsections 10 and 13 of section 57-40.2-04 of the North Dakota Century Code, and sections 57-39.2-04.1 and 57-40.2-04.1 of the 1985 Supplement to the North Dakota Century Code are hereby repealed."
