SECTION 1. AMENDMENT. Section 20.1-07-03.1 of the 1985 Supplement to the North Dakota Century Code is hereby amended and reenacted to read as follows:

20.1-07-03.1. Use of snares for taking coyotes - Restrictions - Identification - Snare standards.

- The governor shall establish by proclamation an upland snaring season for the taking of coyotes.
- No person may set or lay any snare for the purpose of taking coyotes on land belonging to another private person without receiving written permission from that person.
- 3. A person using a snare for the purpose of taking coyotes shall permanently affix with a metal or plastic tag that person's name, address, and telephone number to each snare being used.
- 4. The commissioner shall establish and publish in pamphlet form safety standards for snares used for the taking of coyotes, which will prevent the accidental holding of deer and other appropriate animals. These standards must be followed by any person using a snare pursuant to this section.
- 5. Any person who violates this section is guilty of a class A misdemeanor."

### POINT OF PERSONAL PRIVILEGE

SEN. ADAMS: Mr. President: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

Mr. President, last week the senator from District 27 rose to a point of personal privilege and addressed this body as to the votes cast by certain senators on major revenue measures. The senator from District 27 explained to this body his difficulty in voting "yes" on those major revenue measures. I certainly can empathize with that feeling.

He then stated that there are certain senators who voted "no" on all major revenue measures who have institutions in their legislative districts that require state money. Further, the senator from District 27 placed us on notice that when these institutions' budgets come over from the House, he will be voting "no" on those institutions represented by any senator who continues to vote "no" on every major revenue measure offered to the Senate. The senator explained his reasons for doing so and then identified this as a logical method of identifying what institutions the Senate can do without in absence of sufficient revenue to support them all.

If the statements of the senator from District 27 were not direct, at least the implication was there. If senators, such as myself, who have institutions in their district vote in favor of major revenue measures, he would, in turn, support those institutions' budgets. This is my fourth session as an elected senator from my district. As do all of you, I take very seriously the trust placed in me by my constituents. That trust requires me to represent the views and wishes of the people of my district. Further, that trust requires me to adhere to the law as an elected senator.

I want the members of this Assembly and my constituents to know that I will not give my vote or influence for or against any measure pending before this body in consideration that another member of this body will give his vote or influence for or against any other measure. Article IV, Section 9, of the North Dakota Constitution prohibits me, as well as all legislators, from doing so. It is my intention to adhere to the spirit and the letter of the law.

In summary, members of the Senate, we have difficult decisions ahead in regard to the budget and revenue measures. During these deliberations, I will strive to do what is in the best interest of the state, including my district. I will also strive to conduct those deliberations within the confines of our State Constitution.
