REP. MURPHY: Perhaps the explanation used in committee best explains my understanding of this bill.

It seems Murphy borrowed \$1,000 from Banker Stenehjem and had to put up as security everything he owned in this world - that 17 acres down in the Badlands - then he borrowed a few dollars from Rep. Ulmer and had to give a second mortgage. Then Rep. Aas felt sorry for Murphy and loaned him an additional sum and took a third mortgage.

What with the high cost of higher education for his ten children, drastic cuts in federal farm subsidies, and his wife's high-flying lifestyle being what it is, he just couldn't keep up the payments.

In due time, shylock Stenehjem became dissatisfied with the interest he wasn't getting - he wanted the 17 acres, too - and he proceeded to foreclose his mortgage.

Under present law, the legal foreclosure notice must contain the names of all second and subsequent lenders being foreclosed on. In this case, Murphy, Ulmer, and Aas – though Ulmer and Aas didn't owe shylock a cent – in fact, were creditors themselves.

Well, you know what happens, people pick up the paper, "Well, would you look at that, they are foreclosing on Ulmer and Aas – and I thought they were wealthy. Their wives are always running around, putting on the dog."

This bill would repeal the requirement that second and subsequent creditors' names be listed in the legal foreclosure publication.

Your committee seemed very sympathetic toward Ulmer and Aas. They voted unanimously, "DO PASS".

They didn't seem to care what happened to Murphy.

Reps. Flaagan, V. Olson, Marks introduced:

HB 1315: A BILL for an Act to create and enact a new section to chapter 4-12.2 of the North Dakota Century Code, relating to notice of apiaries located near public highways.

Was read the first time and referred to the Committee on Agriculture.

Rep. J. DeMers introduced:

HB 1316: A BILL for an Act to amend and reenact subsections 1 and 4 of section 47-16-07.1 of the North Dakota Century Code, relating to security deposits.

Was read the first time and referred to the Committee on Judiciary.

Reps. Graba, Skjerven, Carlson introduced:

HB 1317: A BILL for an Act to amend and reenact subsection 23 of section 57-15-10 and section 57-15-48 of the North Dakota Century Code, relating to limitations on city tax levies for emergency purposes; and to provide an effective date.

Was read the first time and referred to the Committee on Political Subdivisions.

Reps. Oban, Tokach, Hokana and Sens. Richard, Ingstad introduced:

HB 1318: A BILL for an Act to amend and reenact section 57-36-10 of the North Dakota Century Code, relating to the discount allowed to licensed distributors on purchases of tobacco products tax stamps.

Was read the first time and referred to the Committee on Finance and Taxation.

Reps. Skjerven, Graba and Sen. Lodoen introduced:

HB 1319: A BILL for an Act to provide an effective date for laws enacted by the legislative assembly which fiscally affect political subdivisions. Was read the first time and referred to the Committee on Political Subdivisions.

FIRST READING OF HOUSE CONCURRENT RESOLUTIONS Reps. G. Berg, Peterson introduced:

HCR 3018: A concurrent resolution urging the Board on Geographic Names to recommend that the Secretary of the Interior change the name of Lake Audubon to Lake Sivert Thompson.

Was read the first time and referred to the Committee on Natural Resources.

Reps. Marks, Knell introduced:

HCR 3019: A concurrent resolution for the amendment of sections 3 and 4 of article IV of the Constitution of North Dakota, relating to the terms of legislative assembly members; and to provide an effective date.

Was read the first time and referred to the Committee on Joint Constitutional Revision.

Reps. G. Berg, Kingsbury, Shockman and Sen. O'Connell introduced:

HCR 3020: A concurrent resolution directing the Legislative Council to study the interbasin transfer of biota, waterfowl diseases, waterfowl wastes, and the possibility of moving Missouri River water to the James, Sheyenne, Souris, and Red Rivers.

Was read the first time and referred to the Committee on Natural Resources.

Reps. Rydell, Sorensen introduced:

HCR 3021: A concurrent resolution urging employers to provide employment opportunities for older workers.

Was read the first time and referred to the Committee on Industry, Business and Labor.

Rep. Goetz and Sen. Tallackson introduced:

HCR 3022: A concurrent resolution to create and enact a new section to article X of the Constitution of North Dakota to provide that the resources trust fund is a constitutional trust fund; to provide for

Was read the first time and referred to the Commmittee on Joint Constitutional Revision.

- SB 2091: A BILL for an Act to repeal sections 61-03-07 and 61-03-09 of the North Dakota Century Code, relating to the state engineer's duty to investigate coal-bearing lands and to investigate bridges and culverts.

- SB 2092: A BILL for an Act to repeal chapter 61-19 of the North Dakota Century Code, relating to the construction of revetment works by the county commissioners.

Was read the first time and referred to the Committee on Political Subdivisions.

- SB 2107: A BILL for an Act to amend and reenact subsection 5 of section 61-28-02 of the North Dakota Century Code, relating to the definition of person in control, prevention, and abatement of pollution of surface waters.
- Was read the first time and referred to the Committee on Natural Resources.
- SB 2132: A BILL for an Act to amend and reenact subsection 25 of section 39-01-01 of the North Dakota Century Code, relating to the definition of house car.
- Was read the first time and referred to the Committee on Transportation.
