The office of the budget, upon receipt of the transfer from the contingency fund; shall pay the claim and submit the claim to the office of the budget for processing. The expenditure for the claim must be drawn from the state institution's appropriation authority.
- 3. The office of the budget shall forward any claim exceeding two thousand five hundred dollars to the emergency commission with the office's recommendation. If the claim is approved by the emergency commission; it shall be conclusively presumed that an emergency exists; and the commission shall direct the transfer of the approved amount to the office of the budget from the contingency fund. The office of the budget upon receipt of the transfer from the contingency fund; shall pay the claim.

STATEMENT OF PURPOSE OF AMENDMENT:

This amends the 1987 Session Laws to provide that the Secretary of State does not have to deposit the proceeds from the sale of the Blue Book Centennial edition in the state general fund as required by Senate Bill No. 2523 passed by the 1987 Legislative Assembly. Changing the language in the Session Laws will provide that the language is compatible with the bill so that the proceeds from the sale of the Blue Book can be deposited into the Blue Book fund. The amendment also provides that the unobligated moneys in the Blue Book fund as of June 30, 1991, do not have to be transferred to the state general fund.
