DEPARTMENT 101 - GOVERNOR'S OFFICE

The salaries and wages line item is reduced by \$9,680 from the general fund to delete funds for an increase for the Governor. The executive budget provided funding for a salary increase for the elected officials of five percent for the first year and four percent for the second year. Other compensation adjustments reflect House salary policy contained in House Bill No. 1005.

### DEPARTMENT 106 - LIEUTENANT GOVERNOR

The salaries and wages line item is reduced by \$7,952 from the general fund to delete funds for an increase for the Lieutenant Governor. Other compensation adjustments reflect House salary policy contained in House Bill No. 1005.

### DEPARTMENT 108 - SECRETARY OF STATE

The salaries and wages line item is reduced by \$7,633 from the general fund to delete funds for an increase for the Secretary of State. Other compensation adjustments reflect House salary policy contained in House Bill No. 1005.

### DEPARTMENT 125 - ATTORNEY GENERAL

The salaries and wages line item is reduced by \$8,271 from the general fund to delete funds for an increase for the Attorney General. Other compensation adjustments reflect House salary policy contained in House Bill No. 1005.

The salaries and wages line item is also increased by a total of \$200,664 from the general fund for three FTE positions. The amount of \$40,108 was added from the general fund for one FTE clerk proposed in the executive budget to be funded in the Tax Department related to revenue collection responsibilities. The House defeated House Bill No. 1216 that would have transferred the responsibilities to the Tax Department and therefore these amendments restore the position to the Attorney General's office. Also, \$160,556 from the general fund was added for two FTE positions deleted in the executive budget, a drug enforcement agent (\$69,832) and the Bureau of Criminal Investigation Director (\$90,724).

In addition, these amendments reduce the court monitor line item by \$192,000 from the general fund to provide \$8,000 for the biennium, \$400/day for 20 days.

### DEPARTMENT 117 - STATE AUDITOR

The salaries and wages line item is reduced by \$7,633 from the general fund to delete funds for an increase for the State Auditor. Other compensation adjustments reflect House salary policy contained in House Bill No. 1005.

SECTION 6. LEGISLATIVE INTENT - FAMILY SUPPORT ACT OF 1988. Provided within the general fund moneys appropriated under section 1 of this Act is \$2,462,740 to defray the state's estimated share of the costs to implement the mandatory features of the Family Support Act of 1988 [Pub. L. 100-485; 102 Stat. 2343] during the biennium beginning July 1, 1989, and ending June 30, 1991. The legislative assembly recognizes the need to comply with the mandatory provisions of the Family Support Act of 1988 and the uncertainties inherent in estimating the money necessary to comply with the new program requirements. SPEAKER KRETSCHMAR THEN REQUESTED that the Senate Messenger read the final vote on SB 2028 that was taken by the Senate. The Senate Messenger read the final vote as requested.

### RULING BY THE SPEAKER

SPEAKER KRETSCHMAR RULED that the House cannot accept SB 2028 and the Senate Messenger was instructed to take the bill back to the Senate with the following message which the Chief Clerk read to the House.

MESSAGE to the SENATE from the HOUSE (Roy Gilbreath, Chief Clerk) MR. PRESIDENT: The Senate Messenger has informed the House that he was delivering SB 2028 to the House. He was requested to and did read the title to SB 2028, Section 1 of the bill and the final vote by which it passed the Senate.

SB 2028 amends and changes the effect of sections of Chapter 57-38 of the North Dakota Century Code which were approved by the electorate at a special election in March 1987. Further, the number of affirmative votes which this bill received in the Senate was not two-thirds of the members-elect.

Pursuant to Senate Rule 315(4)(a) and House Rule 315(4)(a), which read substantially identical as follows:

- 4. The following questions require a two-thirds vote of the members-elect of the Senate (House):
  - a. Initiated and referred measures amended or repealed within seven years after enactment or approval, as provided in Section 8, Article III, of the Constitution and Senate (House) Rule 333.

SB 2028 does require a two-thirds vote of the members-elect of the Senate for approval.

Since SB 2028 did not receive a two-thirds vote of the members-elect of the Senate, it fails to meet the provisions of Senate Rule 315(4)(a).

It appears that SB 2028 was inadvertently messaged to the House, and because it has not been properly passed by the Senate, it cannot be accepted by the House.

REP. KLOUBEC MOVED that the title, Section 1 and the final Senate vote on SB 2028, as read by the Senate Messenger, be printed in the Journal, which motion prevailed.

TITLE, SECTION I, AND FINAL VOTE AS READ BY THE SENATE MESSENGER A BILL for an Act to create and enact a new section to chapter 57-38, and to create and enact chapter 57-38.5 of the North Dakota Century Code, relating to income tax on individuals, estates, and trusts; to provide an effective date; and to declare an emergency.

### BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 57-38 of the North Dakota Century Code is hereby created and enacted to read as follows:

The provisions of chapters 10-30.1 and 10-30.2, sections 40-57.1-04, 40-57.1-04.1, 54-03-20, subsections 0.1, 1.1, 3, 4.1, 8, and 9 of section 57-38-01, sections 57-38-01.1, 57-38-01.2, 57-38-01.7, 57-38-01.8, 57-38-01.13, 57-38-01.14, 57-38-01.15, 57-38-01.16, 57-38-02, 57-38-03, 57-38-05, 57-38-06.1, 57-38-29, 57-38-30.3, 57-38-30.4, subsection 2 of section 57-38-31, sections 57-38-34.1, 57-38-34.2, 57-38-67, 57-38-68, 57-38-69, 57-38-70, 57-38-71, 57-38-72, 57-38-73 and 57-38-74, shall not be effective as they apply to the taxation of income for individuals, estates, and trusts for taxable years beginning after December 31, 1988.
