STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 602 - AGRICULTURE DEPARTMENT

This amendment deletes the \$500,000 general fund appropriation for noxious weed control since there are other bills providing for noxious weed control and amends current law to provide that state appropriations for leafy spurge control cannot be used on land that is owned or leased by a nondomestic corporation. House Bill No. 1001, Agriculture Department, contains a \$540,000 general fund appropriation for noxious weed control and Senate Bill No. 2274 contains a \$1.2 million special fund appropriation for noxious weed control.

The state shall reimburse on a pro rata basis the county or counties for whom a county judge provides judicial services the salary paid to the judge by the county or counties during the period the county judge serves as temporary judge in a district court following appointment under section 27-24-01.

The presiding judges' salaries are \$1,516 more than the district judges' salaries, the same difference as provided in ourrent law.
