JOURNAL OF THE SENATE

Fifty-first Legislative Assembly

Bismarck, January 9, 1989

The Senate convened at 1:00 p.m., with President Omdahl presiding.

The prayer was offered by Rev. Arland O. Fiske, Bethany Lutheran Church, Minot.

Father in Heaven, we thank You for Your mercies upon this good land of America, and especially for this state called North Dakota. Dotzenrod, Chairman) to which was referred SB 2148 has had the same under consideration and recommends by a vote of 7 YEAS, 0 NAYS, 0 ABSENT AND NOT VOTING that the same BE AMENDED AS FOLLOWS and when so amended, recommends the same DO PASS:

Page 2, line 4, after "employees" insert ", subject to a minimum period of participation of twenty-four months. If the board of county commissioners of a participating county or the governing body of any participating city, school district, or any combination thereof, withdraws from participation in the uniform group insurance program, that entity may not subsequently renew participation for a period of at least twenty-four months from the date of withdrawal"

SB 2132: A BILL for an Act to amend and reenact subsection 25 of section 39-01-01 of the North Dakota Century Code, relating to the definition of house car.

SB 2284: A BILL for an Act to create and enact a new chapter to title 43 of the North Dakota Century Code, relating to the authority of health professional licensing boards to establish agreements with peer assistance entities.

Was read the first time and referred to the Committee on Human Services and Veterans Affairs.

Sens. D. Meyer, Langley and Rep. Timm introduced:

SB 2285: A BILL for an Act to amend and reenact subsection 1 of section 53-06.2-02 of the North Dakota Century Code, relating to senate confirmation of members of the North Dakota racing commission.

Was read the first time and referred to the Committee on State and Federal Government.

Sens. Yockim, Waldera, Maixner and Reps. Gerhardt, Schmidt introduced: SB 2286: A BILL for an Act to create and enact a new chapter to title 6 of the North Dakota Century Code, relating to oil and gas development loans by the Bank of North Dakota.

Was read the first time and referred to the Committee on Industry, Business and labor.

The Senate stood adjourned pursuant to Senator Maixner's motion.
