REMARKS OF THE HONORABLE JAMES E. DOWNEY

Mr. President, Honorable Senators, citizens of the United States, and good neighbor, North Dakota, to us in Manitoba; let me first of all say how pleased that I am to be here today to have the opportunity to say a few words to such a distinguished body. Let me as well bring greatings from our premier, Premier Gary Fillman, and his Cabinet ministers. I particularly, Mr. President and members of the Senate, want to say how pleased I am today to have been invited to North Dakota by Orlin Hanson and his good wife, who have been excellent neighbors and friends of ours, just across the border, for many years. There are a couple of other things - and I will promise to be very short - that was one of the prerequisites, of course, of being able to give this address, is to be sure that I was very short - being that it was on a Friday afternoon, but I have a short fishing story to tell, being that I am the minister responsible for northern and native affairs, where some of the best fishing holes are in all of this country.

Let me say that I am pleased to be here on the occasion of the meeting of the North Dakota-Saskatchewan Commission. I am particularly pleased that Manitoba has been proposed to be a member of the Boundary Advisory Commission. Having a Riding in which the Souris River flows, many of you may be more familiar with it as the Mouse River, which originates in Saskatchewan and flows through Minot, and, when it enters Canada, flows entirely through the constituency which I represent, that being the southwest corner of the province. I believe we would have had a lot less controversy and a lot more cooperation over the past few months and years if Manitoba had been a part of that Advisory Committee, and it would have been more of an objectively viewed project in Manitoba, and I say from my position it is objective, and we are pleased with it, rather than the way in which it has turned out.

Let me congratulate you as well on your Centennial celebrations. It is an extremely important event in any jurisdiction's life - a hundred years is a major milestone, and a time for friends and family to gather and congregate, and reinstill in our families the importance of our roots before we challenge the future, or take on the challenge of the future, which is so important to our young people of our nation.

Let me say as well I am pleased to be here on the historic date of the inauguration of your new President, and I am pleased to see that the people of the United States are again going through a system of supporting the

freedom and the opportunities that our country enjoys, of free election and the democratic process.

I am here as well to say to you that I am here for a little bit of other additional work, I am also responsible for a seed company out of Brandon, Manitoba, and I have the chairman of the board and the general manager here to look at some market opportunities, and of course that brings me to free trade, which I was a strong supporter of, as was Mr. Hanson, and look forward to many good trade opportunities for our nations to enjoy, and say that I am pleased to be here to be with them as the minister responsible.

Now I will conclude, Mr. President, and say thank you with a short story. I was up fishing last year - as I have the responsibility for two-thirds of Manitoba, the northern portion of it, where there are some of the best fishing holes, and it truly is true - I was fishing last year in a small lake up north of Flin Flan, where they were biting so good that I had to lie in the bottom of the boat to bait the hook. I appreciate the Reverend's comments today, that we do have to have and enjoy life and have a little levity, because that is what it is all about.

Thank you, the best to you, Senators, and to your country, and we look forward to the passage of a bill where we can further adopt and work together on matters of mutual interest and concern. Thank you, and have a good Centennial.
