Information to accompany city or county applications for funding. The governing body of any city or any county weed board that applies for state contributions under this chapter shall furnish, within two years after publication of county soil and groundwater maps, a map illustrating plans to protect groundwater from contamination within the city or county and shall furnish a map showing location of noxious weed problem areas to be controlled.

SECTION 3. APPROPRIATION. There is hereby appropriated out of any moneys in the noxious weed control fund in the state treasury, not otherwise appropriated, the sum of \$1,200,000 or so much thereof as may be necessary, to the commissioner of agriculture for noxious weed control under chapter 63-01.1 for the biennium beginning July 1, 1989, and ending June 30, 1991."
