- Every motor vehicle liability insurance policy, as that term is defined in section 39-16.1-11, covering private passenger motor vehicles must provide that all of the obligation for damage and loss of use to a rented vehicle will be covered by the property damage liability portion of the policy. The obligation of the policy must not be contingent on fault or negligence of the insured.
- A vehicle is rented for purposes of this section if the vehicle is rented under an agreement for thirty continuous days or less.
- The policy or certificate issued by the insurer must inform
 the insured of the application of the insurance policy to
 rental vehicles and that the insured may not need to purchase
 additional coverage from the rental company.
- 4. If an insured has two or more vehicles covered by a plan or plans of liability insurance containing the rented motor vehicle coverage required under subsection 1, the insured may select the policy that the insured wishes to collect from and the insurer that issued that plan is entitled to a pro rata contribution from any other plan or insurers based upon the property damage limits of liability. If the person renting the motor vehicle is also covered by that person's employer's insurance policy or the employer's automobile self-insurance plan, the insurer or obligor under the employer's policy or self-insurance plan has primary responsibility to pay claims arising from use of the rented vehicle.
- 5. A notice advising the insured of rental vehicle coverage must be given by the insurer to each current insured with their first renewal notice following the effective date of this Act. The notice must be approved by the commissioner of insurance. The commissioner may specify the form of the notice.
- A rental car company may not require as a condition to its rental contract that the renter make a deposit for a prior payment of damage to the rented vehicle or loss of use of that vehicle.

7. For each day a damaged vehicle is out of service because of damage to the vehicle while rented to others, the rental car company is entitled to collect sixty percent of the daily rental fee applicable to the contract in force when the car was damaged."

- "Commercial aircraft carrier" means a provider of advertized scheduled passenger or cargo air transportation services holding a federal aviation administration part 121 or part 135 certificate.
- 3. "Commission" means the North Dakota aeronautics commission.
- 3. 4. "Commissioner" means the North Dakota tax commissioner.
- 4. 5. "Dealer" means aviation fuel dealer.
- 5. 6. "User" means aviation fuel user.

SECTION 2. AMENDMENT. Section 57-43.3-02 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

- 57-43.3-02. Imposition and collection of tax. An excise tax of eight cents per gallon $\{3.79 \text{ liters}\}\$ is hereby imposed on the sale or delivery of aviation fuel by a dealer to a user as follows:
 - Nine cents per gallon [3.79 liters] on all sales or delivery of aviation gasoline and other motor fuel, except jet motor fuel, used in aircraft.
 - 2. Eight cents per gallon [3.79 liters] on all sales or delivery of jet motor fuel to a noncommercial aircraft carrier.
 - 3. Four percent on the sale of jet motor fuel to a commercial aircraft carrier.

The dealer shall collect the tax from the user and pay the tax to the commissioner.

- SECTION 3. AMENDMENT. Section 57-43.3-03 of the North Dakota Century Code is hereby amended and reenacted to read as follows:
- 57-43.3-03. Refund of tax. Any user aerial applicator of agricultural chemicals shall be reimbursed the tax levied by subsection 1 of section 57-43.3-02 pursuant to the refund provisions of chapter 57-43.1 for fuel used in an aircraft or helicopter which qualifies for the reduced aircraft excise tax rate in section 57-40.5-02. Upon refund of the tax imposed under subsection 1 of section 57-43.3-02, a special excise tax of four percent is imposed on the sale of aviation gasoline or other motor fuel, except jet motor fuel, used in a qualified aircraft or helicopter, which tax must be deducted from the refund.
- SECTION 4. AMENDMENT. Section 57-43.3-05 of the North Dakota Century Code is hereby amended and reenacted to read as follows:
- 57-43.3-05. Administration of tax. The commissioner shall administer this chapter and is empowered to adopt reasonable rules and regulations relating to administration and enforcement. The commissioner shall audit returns and make assessments pursuant to section sections 57-43.1-17 and 57-43.2-14. The commissioner shall be authorized and empowered to determine the purchase price of aviation fuel used by aircraft and at the time of approving a refund of the taxes imposed by section 57 43.3-02 on such fuel; he shall deduct the tax imposed by section 57 43.3-04 from the amount of such refund. Claims for refund of taxes imposed by section 57 43.3-02 shall be in such form and subject to such conditions and requirements; including time for filling; as are provided in the refund motor fuel tax law, chapter 57 43.1.
- SECTION 5. AMENDMENT. Section 57-43.3-06 of the North Dakota Century Code is hereby amended and reenacted to read as follows:
- 57-43.3-06. Distribution of revenue to state aeronautics commission construction fund. The Fifty percent of the tax collected by the commissioner pursuant to section 57-43.3-04 57-43.3-02 shall be deposited by the commissioner in the office of the state treasurer, who shall must deposit such moneys in a special fund known as the state aeronautics commission construction fund. These funds are hereby appropriated to the commission and shall be disbursed by warrant-check

prepared by the office of management and budget upon vouchers submitted by the commission and approved by the office of management and budget for the purpose of matching of any funds made available by political subdivisions or airport authorities of this state, the state, or the United States, only if the political subdivision or airport authority is not qualified for or does not receive any funds under section 2-05-06.5. These funds shall be used for airport construction or improvement projects including airport administration and terminal buildings, hangars, landing strips for aircraft, and purchase of sites for airports or landing fields and easements; and for maintenance, clearing of sites, marking, lighting, and engineering and navigational aids, all related to aeronautics in amounts as the commission may determine and upon projects as the commission may approve.

SECTION 6. AMENDMENT. Section 57-43.3-07 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

57-43.3-07. Allocation of unclaimed refund revenue commission of revenue to state aeronautics commission special fund. The Fifty percent of the tax collected by the commissioner pursuant to section 57-43.3-02, upon which no refund is claimed, and those revenues remaining as unclaimed refunds shall must be deposited in the office of the state treasurer, who shall deposit such moneys in a special fund known as the state aeronautics commission special fund. These funds are hereby appropriated to the commission and shall be disbursed by warrant-check prepared by the office of management and budget upon vouchers submitted by the commission and approved by the office of management and budget and shall be administered and expended by the commission for construction, reconstruction, repair, maintenance, and operation of airports near communities, recreational areas, or parks including the international peace garden airport and for necessary expenses and for the purchase of land and easements for such facilities.

SECTION 7. REPEAL. Section 57-43.3-04 of the North Dakota Century Code is hereby repealed."

Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to create and enact a new section to chapter 34-06 of the North Dakota Century Code, relating to the application of wage and hour standards to persons providing companionship services, personal care services, and family home care.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 34-06 of the North Dakota Century Code is hereby created and enacted to read as follows:

Exemption for companionship and personal care services and family home care.

- 1. Employees who provide companionship services for individuals who, because of age or disability, are unable to care for themselves are exempt from any minimum wage and hour standards that may be prescribed under this chapter, to the extent that those companionship services are provided by an employee from ten p.m. to nine a.m., up to a total of eight hours, during which time the employee is available to perform duties for the aged or disabled individual, but is free to sleep and otherwise engage in normal private pursuits in the aged or disabled individual's home. Employees who provide companionship services are not entitled to any overtime premium that may be prescribed under this chapter.
- Individuals who provide personal care services or family home care under written contract with a county social service board are exempt from any minimum wage and hour standards that may be prescribed under this chapter.

As used in this section:

- a. "Companionship services" means those services that provide fellowship, care, and protection for individuals who, because of advanced age or physical or mental disabilities, cannot care for their own needs. Those services may include household work related to the care of the aged or disabled person, including meal preparation, bed making, washing of clothes, and other similar services, and may include the performance of general household work if that work does not exceed twenty percent of the total weekly hours worked. "Companionship services" do not include services relating to the care and protection of the aged or disabled which require and are performed by trained personnel, including a registered or practical nurse, and do not include individuals who provide care and protection for infants and young children who are not physically or mentally disabled.
- b. "Family home care" means family home care as defined in section 50-06.2-02.
- c. "Personal care services" means personal care services as defined under the home and community-based waiver for the aged and disabled, secured by the department of human services pursuant to 42 U.S.C. 1396n(c)."

Renumber accordingly

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new subsection to section 57-02-08 of the 1987 Supplement to the North Dakota Century Code is hereby created and enacted to read as follows:

The portion of fixtures, buildings, and improvements, used primarily to provide early childhood services by a corporation or organization licensed under chapter 50-11.1. For purposes of this subsection, property is used primarily for early childhood services when more than seventy-five percent of the time the property is used is devoted to licensed childhood services. However, this exemption is not available for residential property.

SECTION 2. EFFECTIVE DATE. This Act is effective for taxable years beginning after December 31, 1988."

Each pupil enrolled in a public, private, or parochial school or a day care center, child care facility, head start program, or nursery school must be registered in that pupil's legal surname, and all records maintained by the school, center, facility, or program with regard to a pupil must be maintained in that pupil's legal surname. All officials, teachers, administrators, and other employees of a school, center, facility, or program shall use the legal surname in all communications in which a surname of a pupil is used."
