35-20-11. Lien for repair, protection, improvement, safekeeping, or carriage of personalty personal property. Every Any person, excepting those unless entitled to a specific lien under other chapters of this title, who, while lawfully in possession of an article of personal property, renders any service to the owner thereof of the article by labor or skill employed for the repair, protection, improvement, safekeeping, or carriage thereof has of the article is entitled to a special lien thereon, dependent on possession, for the compensation; if any, which is due to him the person from the owner for such the service. In addition to other remedies available for the enforcement of liens, the holder of such the special lien may foreclose the same and acquire ownership in himself of such the article of personal property, provided the holder of such a special lien has obtained the address of the owner at the time such article was left; by causing sending a notice of intention to foreclose such special lien to be sent acquire ownership of the article to the owner thereof; by registered or certified mail; to the address obtained from such the owner at the time such the article is was left; which. The notice shall must be in substantially the following form:

To -----, owner of (describe the article upon which lien is claimed.)

You are hereby notified that the undersigned claims a special lien upon the above-described article by virtue of under section 35-20-11, and the undersigned hereby further advises you of his the undersigned's intention to foreclose such special lien and acquire ownership of such the article, unless the sum of (insert amount claimed) is paid within sixty days from the date hereofror unless you shall notify the undersigned within such period of your election to challenge the amount claimed due for services rendered thereon this notice was mailed to you. You may contest the amount claimed due only by serving and filing with the appropriate court an action to determine the amount due for services rendered. If you neither pay the sum claimed due nor serve and file an action to determine the amount due within sixty days, ownership of the article will vest in the undersigned.

If, at the expiration of sixty days from the date of mailing such the notice, payment the claimant has not been received of the amount claimed to be due; or an election the owner of the property has not filed and served an action to challenge the amount claimed due has been received, the lien claimant is deemed to have succeeded entitled to ownership of the article of personal property upon which the special possessory lien is claimed.

If the owner of such the property causes an election has served and filed an action to challenge the amount claimed to be delivered to the lienholder, then the summary foreclosure procedure set out herein

is not available to the lien claimant; and the lien must be foreclosed by action due, the court shall determine the amount due and may order a special execution."

HB 1637: A BILL for an Act to create and enact a new section to chapter 15-40.1 of the North Dakota Century Code, relating to bonus payments to high schools for cooperative education programs; to amend and reenact subsections 2 and 3 of section 15-40.1-06, sections 15-40.1-07, 15-40.1-08, 15-40.1-16, and subsection 1 of section 15-40.2-03 of the North Dakota Century Code, relating to the foundation aid weighting factors and the per-pupil payment, the school district equalization factor, and transportation aid to schools; and to provide for transition.
