SEN. MARKS MOVED that a committee of two be appointed to escort United States Senator Kent Conrad to a special reserved seat in the Assembly, which motion prevailed. The Chair appointed Sen. Langley and Rep. Kunkel to such committee and Senator Conrad was escorted to a special reserved seat in the Assembly.

The Joint Session was called to order at 2:30 p.m. with Lt. Governor Omdahl presiding.

MESSAGE TO THE LEGISLATURE

by George A. Sinner Governor of North Dakota

Mr. President, Mr. Speaker, Governor Guy, Governor Link, citizens of North Dakota, officials of the executive and judicial branches of state government, ladies and gentlemen of the 52nd Legislative Assembly:

Along with the crisis in the Middle East, the United States faces another frightening crisis -- incredible fiscal problems threaten our nation in unprecedented ways.

190 years ago, a widely known Scottish jurist and historian, Sir Alex Frazer Tytler, offered a negative perspective on democracy. He wrote the following foreboding prediction.

"A democracy cannot exist as a permanent form of government. It can exist only until the voters discover that they can vote themselves largess from the public treasury. From that time on, the majority always votes for the candidates promising the most benefits from the public treasury, with the result that a democracy always collapses over loose fiscal policy, always followed by a dictatorship."

That prediction is shocking food for thought for all of us. But, 140 years later, a more positive forecast came from a great American.

Fifty years ago yesterday, President Franklin D. Roosevelt, in his famous "Four Freedoms Speech," on January 6, 1941, President Roosevelt said the following:

"Since the beginning of our American history we have been engaged in change -- in a perpetual peaceful revolution -- a revolution which goes on

steadily, adjusting itself to changing conditions -- without the concentration camp or the quick-lime in the ditch. The world order which we seek is the cooperation of free countries, working together in a friendly, civilized society."

President Roosevelt continues: "This nation has placed its destiny in the hands and heads and hearts of its millions of free men and women; and its faith in freedom under the guidance of God. Freedom means the supremacy of human rights everywhere. Our support goes to those who struggle to gain those rights or keep them. 'Our strength,' he said, 'is in our unity of purpose.'"

Our strength is in our unity of purpose.

Today, in North Dakota, to be sure, our strength is in our unity of purpose. Our people are uniting for quality growth of our state's economy and for greater maturity in our social structures.

Without question, North Dakota is on the grow.

Our state, our people and our economy have weathered difficult and challenging times.

We have been buffeted, battered and bruised by drought, by damaging macro-economic forces, and by debilitating trade and monetary policies.

The bloated dollar, oil dumping by OPEC, long periods of moisture shortage followed by devastatingly low prices for grain crops have worked great damage upon our people, as well as our economy.

But, our state and our people have persevered.

We have turned the corner. Despite the hurt that remains in the crop sector, the rest of the economy is on the road back.

Despite the cloud of a national recession, North Dakota -- our state, our people, and our economy -- is on the grow.

A milestone along the path to positive thinking was the celebration of our state's Centennial.

United, the people of our state had a great Centennial.

There were spectacular events all over the state: community celebrations of all types and sizes, a visit to the State Capitol by the President of the United States, the beginning of a national tree planting effort here in North Dakota, and, the highlight for many, the Party of the Century.

The first Centennial Commission, chaired by Phil Davison, was appointed by Governor Olson That commission gave the process a good start, including the important task of choosing the official symbol for the Centennial.

The symbol represented North Dakota's people, our state's pioneers and their hopes for the future. It also represented all of us, the descendants of those pioneers.

The subsequent commission was chaired by former Gov. Arthur A. Link.

The commission, its staff and volunteers from all over the state, worked together to plan and carry out the best celebration our state has ever had.

The spirit and pride of the Centennial live on in our united efforts to strengthen our state's economy.

And our economy is growing and becoming more diversified.

Although farm-related employment has declined, off-farm jobs in North Dakota are at a record level.

North Dakota's average unemployment rate for 1990 is estimated at 4 percent. That's the lowest annual rate in 10 years.

The national unemployment rate continues to rise, to over 6 percent, while here in North Dakota, in November, the unemployment rate dropped to an amazing 3.2 percent.

Manufacturing is one industry that has contributed significantly to the increase of jobs.

Total manufacturing employment reached record highs during 1990.

More than half of the 400 manufacturers we have visited in our state said they were eager to expand. Many already have.

They told us their greatest needs are help with financing and marketing assistance.

We are taking major steps to meet those needs.

The state's most significant job growth has come in the services industry.

That industry includes a large mix of jobs, running the gamut of wage levels from the medical professions, business services and computer services to home-based industries.

Tourism is booming.

Without question, 1990 was the best year for tourism in the history of North Dakota.

North Dakota's first statewide Tourism Master Plan was completed last year.

The plan documents that tourism in this state is now a billion-dollar industry annually, and that more than two million tourists visit North Dakota each year.

Recent data shows total Canadian visits to North Dakota skyrocketed 67 percent from 1987 to 1989. That trend continued through 1990.

The influx of Canadians was due in part to the stronger Canadian dollar, but it is also due to the aggressive marketing efforts by the state and by our North Dakota cities.

Canadian visitors are estimated to have spent \$100 million in North Dakota during 1990. That's almost four times 1986 spending.

To further enhance tourism and cultural exchanges, I have asked the Tourism Promotion Division to develop a sister-cities program with Manitoba and Saskatchewan.

Motorcoach travel to North Dakota has also risen dramatically. In the last two years, we've seen a 40 percent increase in spending by tour groups.

Any discussion of tourism, services or retail commerce raises the issue of our Sunday closing law.

Society has moved us to a place where we have, in fact, already relinquished Sunday closing. People simply need services on Sunday.

Current disparities between the states, and especially within our own law, cause harsh inequities that must be addressed.

I will, therefore, sign moderate Sunday-opening legislation that protects $\mbox{\it employees}\mbox{'}$ rights to time off.

Another significant service area is in exported services. Data information and telemarketing are examples. That industry has literally discovered North Dakota. From record keeping to reservations to telemarketing, industry leaders are moving to North Dakota.

To enhance all of this, the Growing North Dakota program calls for a series of initiatives that will provide this state with one of the most aggressive and comprehensive economic development and jobs creation programs in this country.

This program, an outgrowth of the Vision 2000 Report, was put together by a distinguished group of North Dakota leaders. I am proud to endorse it.

Our state is poised for progress. We must move boldly. We must adopt this visionary program.

The Bank of North Dakota has already expanded its lending programs to help North Dakota and its economy grow.

Our state has been recognized in the annual survey by the Grant Thornton Company as having the best manufacturing climate among all states of low manufacturing density.

A factor in North Dakota's favorable business climate is the unemployment compensation trust fund, which ended the 1990 fiscal year with a balance of \$49.3 million, the highest year-end balance ever.

We have been able to reduce unemployment insurance costs for four consecutive years, including a 25 percent cut in the average rate for 1991.

The rate is now the lowest ever since the program started 60 years ago.

North Dakota is nonetheless experiencing problems with its workers' compensation program. All other states are too. In spite of that, ours continues to be the lowest cost program in the nation.

To catch up, we have had to raise workers' compensation premium rates substantially, and we must continue to make sure the fund is stabilized.

It is amazing, however, that, taken together, the combined cost of workers compensation and unemployment insurance is significantly lower today than it was in 1983.

Even as it continues to grow and diversify, North Dakota's economy is still heavily dependent on agriculture.

The crop sector has been deeply wounded by drought and federal and international ag policies. It does not appear that the incredibly low prices for farm commodities will soon leave us.

If, however, the world gets short of food, people will come to their senses and grain producers will be appreciated.

Livestock prices, particulary cattle prices, on the other hand, are strong. They have been for over three years. Forecasters predict that they will stay strong.

Along with agriculture, energy is critical to our state's future.

As a result of new technology, oil exploration and production in North Dakota rebounded even before the Iraqi invasion of Kuwait. The Industrial Commission's attentiveness to industry problems and the incentives approved by this Legislature two years ago have been a significant help.

The advancement of horizontal drilling has indeed been an exciting major factor.

The number of horizontal wells drilled in North Dakota last year was second in the world only to the Texas Austin Chalk area. We are on the leading edge of this exciting technology.

In 1990, North Dakota was the only state with an increase in oil production over the previous year.

Coal production has reached all-time highs in North Dakota the last two years. So things actually look good on the business side.

Let's look briefly at some other ingredients needed for a future on the grow.

Education is even more critical for a state that wants to grow.

An Education Action Commission has worked for several months and in a few days will present its report.

The report will outline goals, recommendations and strategies for improving quality, structure and financing of elementary and secondary education in this state through the decade of the 90s.

The commission, chaired by Mark Purdy of Minot, represents a broad variety of leaders who have a stake in public education in North Dakota.

Included in its membership are five members of this distinguished body: Rep. Jim Brokaw, Sen. Layton Freborg, Rep. Moine Gates, Sen. Bonnie Heinrich and Sen. Dan Wogsland.

I sincerely hope that the report will guide us all in our continuing efforts to shape the future of elementary and secondary education in this state.

The school district restructuring program authorized by the 1989 Legislature in House Bill No. 1507 is making remarkable progress and now includes 16 consortia and a total of 92 school districts.

This represents one-third of all rural school districts and more than one-third of our state's rural children.

My budget contains money to continue this program and expand it. In addition, there is money to help small and large adjoining districts provide additional shared services and programs.

My budget for the next biennium includes another special initiative for children.

\$2 million has been recommended for several programs for children at risk.

If we solve children's problems at an early age, we help everyone.

As we provide children who have special problems the extra hand they need to live healthy and productive lives, we make huge savings for the future. We also save money that we would otherwise be forced to spend for out-of-home placements.

In addition to children, the needs of the elderly, the sick, the mentally ill and the poor all present special challenges.

The costs of medical services, nursing homes and programs for the developmentally disabled are some of the areas where costs are increasing dramatically.

While this message today is dedicated to development, all of these areas of health and human services are extremely important to our future. They are addressed at length in the written message as well as in the budget message.

The State Health Council has undertaken an especially important mission for the future. The Council has commissioned a Health Task Force to review priority health-related issues.

The task force is expected to outline some urgently needed solutions for the future and make recommendations by late 1992.

A Solid Waste Management Task Force comprised of state and local government and private sector members has been reviewing current solid waste management problems and is identifying solid waste management issues.

We have introduced important legislation to establish regional waste management authorities, and we are also introducing legislation to make certain that all landfill sites are geologically appropriate for waste before any expenditures are committed to a landfill project.

It becomes more and more obvious, as well, that local jurisdictions face huge responsibilities for cleaning up historic landfill sites. Our interagency groundwater group believes that many of these sites all over the state contain our major risk of groundwater contamination.

Addressing this pervasive problem promises to bring with it major hazardous waste disposal needs. The regional bill will help us work toward the solution to that inevitable problem.

Even as North Dakota is beginning to grow, in the December 1989 special election the people of this state told us something very forcefully. They told us to keep improving government efficiency at all levels.

We have tightened up spending in all areas of state government. We have taken actions to reduce the costs of travel and printing.

Lt. Governor Omdahl's Cost Reduction Commission made about 90 suggestions. Many of them will be presented to the Legislature.

Consistent with these efforts, a group of private and public leaders representing the Greater North Dakota Association, the North Dakota Association of Rural Electric Cooperatives, the AFL-CIO, the Legislature, the judiciary and my office recognized the need for a major effort to establish a broad consensus in North Dakota on key areas of government structure and services.

The North Dakota Consensus Council identified the following areas for review: public education, higher education, local governments and the three branches of state government.

Legislative members on the council are two of your outstanding members, Sen. Jim Yockim and Rep. Gerald Gerntholz.

The council assisted in establishing the Education Action Commission.

And now, the Consensus Council brought together representatives from the Association of Counties, the League of Cities, Township Officers Association, the legislative leadership and my office for discussions to identify the future direction of local governments in North Dakota.

Town meetings will be held around the state before recommendations are made.

In working on improving the efficiency of state government, we surveyed state employees too.

About 70 percent of the surveys distributed were completed and returned, a phenomenal response. Included was a great deal of important advice for us.

Survey results show that state employees generally are proud to be state employees.

There is no question that they deserve and could use better salaries, and they know that. But they place a high value on their current benefits package.

As $\ I$ said in my budget message, every day that I work with our employees, I gain a greater appreciation for their dedication, their expertise and their knowledge.

 ${\rm I}$ have introduced legislation that will make it easier for state agencies to hire women, an area in which we must do better.

The bill would amend the state veterans' preference law to provide equal status for women in jobs where women do not hold a fair share of the positions. Currently, affirmative action plans are often in conflict with state law.

In regard to overall fairness for state employees, I have also agreed to support collective bargaining if it includes a meaningful resolution process.

I want to publicly commend state agencies and their leadership. They have managed under the toughest of times to provide good service, and in many areas have even strengthened programs, despite a shortage of money.

I won't belabor the details, but I urge all of you to review the comprehensive written State of the State report for a more complete picture of the accomplishments by state agencies and departments.

A major area of concern in North Dakota is agriculture. A healthy agriculture is critical to maximum economic growth.

My office has worked closely with Agriculture Commissioner Vogel's staff, legislators, North Dakota State University, farm organizations and commodity groups to develop a program that supports and stimulates livestock production.

During my term as chairman of the Western Governors' Association, I have also led the work for groundwater protection, and we have an agency group working on farm and urban water supply problems.

Which brings me to another major issue: the Garrison Diversion Project. We are encouraged by apparently strong federal support for municipal, rural and industrial water development out of Garrison. Admittedly, we are angered by the unfairness of another federal reneging on commitments for irrigation funding.

Nonetheless, we must move forward wherever we can.

Already, pipe for the Southwest Pipeline Project has been placed from Lake Sakakawea to Dickinson, and the last stretch through the city of Dickinson will be completed this summer.

Pump stations are being completed to allow the delivery of water to Dickinson by this fall.

Planning for the treatment of the water and design for the next priority reach of the pipeline, west to Medora, has begun.

The federal Environmental Protection Agency has recently determined water in several Southwestern North Dakota communities to be unsuitable. Heavy fines may be levied unless we move the Southwest Pipeline forward rapidly. And we must do that.

In addition, the Northwest Area Water Supply Study has been completed.

It shows that Missouri River water can be delivered to seven counties and about 70 communities, including Minot, in northwestern North Dakota to supply municipal, rural and industrial water needs.

The system can satisfy the needs of most of the Fort Berthold Indian Reservation as well.

Detailed studies on means to stabilize Devils Lake are also underway.

Surface water supplies for cities along the Red River and its tributaries are unreliable, and groundwater resources near those cities are already extensively developed.

Missouri water appears to be the only answer for the Southwest, for Devils Lake, for Minot and the Northwest, and for the communities along the Red.

The ability of North Dakota communities to grow is tied directly to good quality water.

In addition, preservation of our long-term water rights, on the Missouri River, demands that we move aggressively and use those rights to prevent losing them to down-stream states.

In pursuing what we must do, the timing may be nearly right to establish long-term funding commitments for water development.

If the next few months of review prove fruitful, we must develop a long-term state funding commitment beyond our current revenue sources.

As a state we must put a larger oar in the water.

In all probability, it will take a commitment of new revenue in the area of \$10 million to \$15 million annually. I will work with you to determine how and when to establish this new and larger, long-term funding vehicle.

It could be that we won't be ready to make this decision until this fall.

In the meantime, there are other problems on the Missouri.

A review of the Corps' Master Manual for Missouri River operation has shown that upper basin recreation provides in excess of \$60 million of economic benefits per year compared to only \$12 million per year from navigation, which takes away the vast majority of our water.

A strong coalition of the upper basin states -- North Dakota, South Dakota, Montana and Wyoming -- has been formed to coordinate efforts to preserve our water rights.

While we continue our efforts to work together with lower basin states, we are prepared to again engage in a legal challenge.

We will continue to work for fairness and equity in Missouri River management, and we will continue to work to protect North Dakota's water rights for present and future generations. And we will do it with vigor.

Like water, coal is a precious resource in our state. Last June the voters of North Dakota approved the use of money from the Coal Development Trust Fund for lignite research.

As I announced in the Executive Budget, the Industrial Commission staff is working with legislators and the Lignite Research Council to develop a financial plan to leverage the revenue available to help us address immediate, urgently needed lignite research.

We have problems to solve, and we can solve them if we move boldly.

As you can see, we have many resources: Our lakes and rivers, our grasslands, our ruggedly beautiful badlands, our unique forest areas, our fertile croplands and wetlands, our incredible energy resources. These are all rich and valuable essentials of our heritage that we must protect and properly manage for tomorrow's people as well as for today's.

These resources contribute to our quality of life and our economic diversity. To preserve them must be our top priority.

And yet our state is not an island. That means we must keep our airports and highways and railroads in good condition.

It means also that we must fight for our fair place in a national and a global society.

We must speak out, and we must work with other like states to make our voices heard.

With the dramatic turnaround in the state's economy, we are in a position to take the lead in a changing world.

We have the resources, we have the business climate, we have the people, an extraordinary people, a people more and more appreciated by those weary of growing urban problems.

I have worked extensively with national and regional organizations on behalf of our state and its people. We have hosted many major meetings here in North Dakota.

In every case, visiting dignitaries have been positively glowing in their appreciation of the warmth, kindness, honesty and just plain class of North Dakota people.

As I outlined at the beginning of this message, the Centennial was a special time when the people of our state came together in a spirit of unity that will carry North Dakota forward into our state's second 100 years.

The Centennial, was, even in its looking back, a prologue to the future.

Now, and into the future, North Dakota is growing. It is moving to the forefront.

But, we must write the rest of the story.

A healthy society with quality life and a strong, broadened economy is the epilogue we promise.

The Centennial Trees Program was started as a lasting legacy of the Centennial.

 \boldsymbol{I} have begun planting a tree in the hometown of each of North Dakota's former governors.

Like the nurturing of these trees, we must take pride in our people, our communities, our economy, and our state.

A proclamation will be issued designating 1991 "The Year of Economic Growth" in North Dakota.

United, we will expand that budding strength that we are all seeing today.

In due time, the flowering of this strength will bring the jobs and a quality of life that we all treasure.

Among the activities that will be undertaken to promote The Year of Economic Growth will be a program to honor deserving companies and individuals with a new state Economic Growth Award.

I am pleased to announce today that the first recipient of the award will be Mr . Hal Rosenbluth.

Hal, in addition to expanding his own company, Rosenbluth Travel, into North Dakota, has enthusiastically campaigned to inform others of the benefits of

doing business and creating jobs here. He has been extraordinarily successful.

He has become a wonderful, true friend and corporate citizen.

 ${\bf I}$ am planning to make a formal presentation to him at a later time. But it is our good fortune to have him with us today.

Would you join me in expressing our gratitude to Hal, his wife, Renee, and their dear children.

If we follow their lead, if we build together, we will build with a lasting foundation.

If unity is blessed with openness and the knowledge that the best of ideas come from listening and sharing, we will keep our quality of life, we will keep our zeal for good education, we will keep our caring for the less privileged among us, we will keep our integrity, and our beloved state will grow in a sound way.

A couple of years ago I had the honor of giving Judge Ronald Davies the Theodore Roosevelt Roughrider Award. Judge Davies opened a new era in American history when, in Little Rock, Arkansas, he opened the schools to all children, regardless of race.

As I sat with him at the banquet, he said to me: "You know, George, I was not a great civil rights activist. I didn't even know all of the problems nor all of the issues. I was simply asked to deal with a difficult legal question."

And, he then said somewhat brokenly: "I was no hero. I just did my job."

The noble men and women who in the past, in unity of purpose, have sacrificed immeasurably to serve this nation in the armed services, and those who sacrifice again today for all of us, are the real heroes.

What a job they have to do!

The best support we can give them, in addition to our prayers, is our unity of purpose and our commitment that we will do our jobs the very best we can.
