SB 2197: A BILL for an Act to create and enact a new section to chapter 15-39.1 of the North Dakota Century Code, relating to postretirement benefit adjustments under the teachers' fund for retirement; to amend and reenact subsection 2 of section 15-39.1-10 and sections 15-39.1-12.1 and 15-39.2-01 of the North Dakota Century Code, relating to computation of benefits, partial service retirement, and the benefit formula for college teachers under the teachers' fund for retirement; and to provide for application of this Act.

Was  $\mbox{ read }$  the  $\mbox{ first time }$  and  $\mbox{ referred to the Committee on State }$  and  $\mbox{ Federal }$  Government.

SB 2216: A BILL for an Act to amend and reenact subsection 12 of section 47-30.1-01, section 47-30.1-18, and subsection 1 of section 47-30.1-19.1 of the North Dakota Century Code, relating to the definition of "person", publication requirements for abandoned property, and abandoned property lists.

Was read the first time and referred to the Committee on Finance and Taxation.
