Mr. Speaker, fellow Representatives, and visitors in the Chambers today, I am in no way trying to establish any precedence in doing this. I feel not only for these 7 astronauts who perished in their Challenger, but also for those astronauts who perished in their Appollo capsule on the launching pad at Cape Canaveral.

These and all other members of the space program, including North Dakota's own astronaut Buchli, and others can stand tall today for their contributions to the space program.

Today, as in the past, concerned Americans everywhere pose the question over and over again, during and after each Apollo shot, each Challenger shot, and each Columbia shot: "What are we doing in space anyway? It's too expensive!" These people, as well as many other citizens, should realize the effectiveness of the "spy satellites", enabling the Patriot missiles to knock

out and destroy the Scud missiles, saving numerous human lives and causing vast property damage in the Persian Gulf.

I think it behooves each and every one of us to remember those astronauts who gave their all in the space program.
