STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 801 - DOT TRANSPORTATION OPERATIONS

This amendment makes the following changes to the Transportation Operations Division of the Department of Transportation:

Salaries and wages are reduced by \$79,611 from the highway fund relating to the reduction of the following two FTE positions which have not been filled since 1989:

1 FTE auto service worker in district operations	\$ (40,016)
1 FTE auto service worker in district operations	(39,595)
Total	<u>\$ (79,611)</u>

Salaries and wages are reduced by \$661,316, of which \$251,300 is from the highway fund and \$410,016 is from federal funds, and operating expenses are reduced by \$155,545, of which \$25,665 is from the highway fund and \$129,880 is from federal funds relating to the elimination of 12 of the 14 FTE engineering positions added in the executive budget. Section 4 of the bill adds legislative intent which provides that the department, through employee turnover and vacancies in areas other than engineers, may hire up to 14 additional engineering positions.

The capital improvements line item is increased by \$22,500,000 of federal funds for the Lake Oahe bridge project. The state's matching funds for the project (10 percent or \$2,250,000) are to be from funds appropriated from the highway fund included in the capital improvements line item and may only be spent by the department when the federal funds are available to be spent for the project as provided in Section 5 of the bill.

The capital improvements line item is also increased by \$1,800,000. Section 6 of the bill authorizes the department to sell the Fargo district headquarters. The estimated income from the sale is \$2,500,000, of which \$1,800,000, subject to Budget Section approval, is for the purchase of land and construction of a new headquarters in the Fargo district as provided in Section 6.

The funding source for \$26,297 of administrative costs relating to the railroad improvement program is changed from the general fund to the highway fund.

The total change to the DOT-Transportation Operations executive budget recommendation is a reduction of 14 FTE positions, from 1,005.6 FTE to 991.6 FTE; the elimination of the \$26,297 general fund appropriation; an increase of \$1,469,721 from the highway fund, from \$166,033,078 to \$167,502,799; and an increase of federal funds of \$21,960,104, from \$220,404,946 to \$242,365,050.

Notwithstanding section 54-01-05.5 of the North Dakota Century Code, the department of transportation may sell the current Fargo district headquarters in accordance with section 54-01-05.2 of the North Dakota Century Code and may, upon approval of the budget section of the legislative council, purchase land and construct a new headquarters building for the Fargo district in an amount not to exceed \$1,800,000, as included in the capital improvements line item in subdivision 1 of section 1 of this Act."

The capital improvements line item is also increased by \$1,800,000. Section 6 of the bill authorizes the department to sell the Fargo district headquarters. The estimated income from the sale is \$2,500,000, of which \$1,800,000, subject to Budget Section approval, is for the purchase of land and construction of a new headquarters in the Fargo district as provided in Section 6.

The funding source for \$26,297 of administrative costs relating to the railroad improvement program is changed from the general fund to the highway fund.

The total change to the DOT-Transportation Operations executive budget recommendation is a reduction of three FTE positions, from 1,005.6 FTE to 1002.6 FTE; the elimination of the \$26,297 general fund appropriation; an increase of \$1,723,588 from the highway fund, from \$166,033,078 to

\$167,756,666; and an increase of federal funds of \$22,454,981, from \$220,404,946 to \$242,859,927.

DEPARTMENT 802 - DOT FLEET SERVICES

This amendment reduces funding from fleet services collections for new vehicle purchases by \$253,867, from \$9,860,086 to \$9,606,219.

#### REMARKS OF REPRESENTATIVE JENSEN

This bill does not belong before the Legislative Assembly. This is an issue that involves the very foundation of individual liberty and Constitutional guarantees of personal freedom that Americans enjoy.

Let me share two examples of Governmental policy on abortion with you.

In 1966 in Rumania, Nicolae Ceausescu outlawed abortion, banned contraception, forbade sex education. Terrible penalties were imposed on anyone who assisted a woman to obtain or recover from an abortion. Women were given production quotas to bear five children; pregnancy was demanded as a patriotic duty. Only women who had Community Party connections could have a safe and legal abortion. Women who did not become pregnant--even those who were not able to bear children--were required to pay a celibacy tax of up to ten percent of their salaries. Ceausescu decreed that the fetus was "the property of the State." Why did these dictates exist in Rumania from 1966 to Ceausescu's death in December 1989? To increase the Country's army and the work force. The population was ordered to grow by seven million persons.

In China, government officials are facing the opposite problem. There the population is anticipated to increase by ten percent every seven years. The Government has imposed strict family planning laws. Families are restricted to one child. In this hour, today, two thousand five hundred babies will be born in China and many of those who are female, because of the one child per couple government rule, will be murdered. In 1984 in Chungking the killing of more than two thousand eight hundred female babies was reported.

Local authorities keep dossiers listing women's menstrual cycles. Chinese women in rural areas who bear illegal children (an illegal birth is a second child) are given orders to submit to abortion--repeatedly if necessary. If they do not submit, second and third children are denied land in the village; parents are also forced to give up a portion of their contracted farmland. City dwellers who defy the one child rule are fined, sometimes lose their jobs, lose access to education, housing, and health care. A child-raising tax is imposed on families with more than one child. Furthermore, women are ordered to submit to sterilization. There is a very high failure rate for contraception.

I am sure you would all agree these two situations--Rumania and China--are outrageous. We are all aware of other extensive civil rights abuses and restrictions on personal freedoms in totalitarian regimes. Never mind that one regime outlawed and the other imposed abortion. The point is--in both regimes--the governments curtailed basic human freedoms in any and all forms. Abortion policy is just one example.

This issue does not belong before this assembly. Freedom to choose whether or not to bear a child is an individual right. While it is not explicitly a Constitutional guarantee, the right to physiological autonomy is inherent and the information I have given you on Rumania and China demonstrates this.

The fact that some churches have taken leadership roles in restricting a woman's right to choose to bear or not to bear children contributes greatly to the thought that this now becomes a religious rights issue. How can it be that persons, through the dictates of law, must be made to conform to what

certain churches say about the abortion issue? What has happened to our guarantee of the right to worship according to the dictates of our own consciences?

I challenge you Republicans--who profess to believe that "good government is based on the individual and that each person's ability, dignity, freedom and responsibility must be honored and recognized"--to live up to that expression of your belief. I charge you Democrats--who consistently risk your political reputations in a conservative State by voting your consciences--to once again vote to protect civil liberties. Let us not be seduced by the power we hold as lawmakers into believing that this is the proper concern for government involvement.

Every public leader in America has the moral duty to defend zealously the platform of Constitutional freedoms that we enjoy in this Country and that for over two hundred years has been a shining and productive example for other nations to follow.

As well-intentioned as we all are in our desire to do what we believe is right, as conscious as we all are of our responsibilities to those we represent, we must not overstep our authority; too often we can see and understand only one side of the equation. We cannot be divided in our commitment to uphold the tenets of individual freedom that this Country and our State were built on. I beg you, resist the temptation to impose a particular value system on our people. "One of the indispensable foods for the human soul is liberty. Liberty...consists in the ability to choose." (Simone Weil)

Please vote NO on HB 1515. A NO vote is not a vote for abortion. A NO vote is a YES vote for personal freedom.

SB 2551: A BILL for an Act to amend and reenact subsection 5 of section 15-47-38 of the North Dakota Century Code, relating to the standard of review to be implemented by the district court in reviewing and ruling upon litigation involving nonrenewals of teachers' contracts.  
Was read the first time and referred to the Committee on Education.

SB 2556: A BILL for an Act to provide for fuel cost adjustment clause inclusion in any construction contract entered by the state or a political subdivision.  
Was read the first time and referred to the Committee on Political Subdivisions.

SB 2570: A BILL for an Act to create and enact a new section to chapter 44-05 of the North Dakota Century Code, relating to oaths of office; and to provide an effective date.  
Was read the first time and referred to the Committee on State and Federal Government.

#### FIRST READING OF SENATE CONCURRENT RESOLUTIONS

SCR 4025: A concurrent resolution urging the Congress of the United States and the United States Army Corps of Engineers to assume responsibility for Missouri River bank erosion downstream from all Pick-Sloan plan dams, including the Garrison Dam to Oahe Reservoir reach in North Dakota, and to begin an annual program of appropriating funds for the maintenance and construction of bank protection projects.  
Was read the first time and referred to the Committee on Natural Resources.

SCR 4038: A concurrent resolution directing the Legislative Council to investigate and recommend a program or programs for funding and financing water resource development throughout the state.  
Was read the first time and referred to the Committee on Natural Resources.

The House stood adjourned pursuant to Representative Kloubec's motion.
