SB 2126: A BILL for an Act to create and enact subsection 15 to section 57-01-02 of the North Dakota Century Code, relating to authorizing the tax commissioner to require payments of twenty-five thousand dollars or more due on a return, report, or other document to be paid by a method in which the funds are immediately available to the state, requiring a taxpayer to provide the tax commissioner with evidence of the payment, providing for penalties and interest on late payments, authorizing the tax commissioner to establish later due dates, authorizing the tax commissioner to promulgate rules necessary for the administration of this payment method; to provide a penalty; and to provide an appropriation.

SB 2146: A BILL for an Act to create and enact a new section to chapter 65-01 of the North Dakota Century Code, relating to the establishment of an information fund for the workers compensation bureau; to provide a continuing appropriation; and to provide an effective date.

SB 2168: A BILL for an Act to create and enact a new section to chapter 54-16 of the North Dakota Century Code, relating to emergency commission authorization for acceptance and expenditure of funds received between legislative sessions; and providing an appropriation.

SB 2259: A BILL for an Act to establish a North Dakota real estate appraiser qualifications and ethics board; to provide for the licensure and certification of real estate appraisers; to provide a penalty; to provide authority to obtain a loan from the Bank of North Dakota; and to declare an emergency.

SB 2312: A BILL for an Act to provide an appropriation to prepare master plans for the Fort Totten state historic site, Fort Buford state historic site, and Fort Seward state historic site; and to declare an emergency.
