OR. WAYNE SANSTEAD: Mr. Speaker and members of the Assembly. Technology has become an important facet of education in North Dakota. As we struggle with reduced funds, fewer kids and more miles, technology has offered a way to address some of the issues of quality education in North Dakota.

Representative Myrdal served in the 1989 session on the House Education Committee. She took a keen interest in technology and played a key role in passage of legislation that created the Educational Telecommunications Council. After the legislative session, she was appointed to the Council and became its first chairperson. She served as a school board representative on the Council.

During her tenure the Council developed a statewide technology plan for North Dakota--a plan that unifies planning in higher education and elementary and secondary education. That plan envisions having a statewide compatible network of all educational institutions in five years--the North Dakota legislature willing, of course.

Through Representative Myrdal's leadership, we have come a long way in the past two years and on behalf of the Department of Public Instruction and the State Educational Telecommunications Council, I would like to recognize her leadership.
