COMMUNICATION FROM GOVERNOR GEORGE A. SINNER

March 13, 1991

HB 1371 limits the authority of the Board of Higher Education to make funding reductions, in the event of revenue shortfalls, to programs undertaken by agreement with institutions of higher education in other states.

When such shortfalls occur, the Board, like all state agencies, needs as much flexibility as possible to manage higher education programs effectively and efficiently. I believe that flexibility needs to be preserved.

Therefore, I veto HB 1371.
