The rate applies to the sale price of the special fuels less any discounts for any purposes allowed and taken on the sales. The tax levied under this section does not apply to state or political subdivisions when that fuel is used for purposes set forth in section 57-43.1-08. The special excise tax applies to all sales of special fuels taxed under section 57-43.2-02 for which taxes are later refunded to a special fuels user. For purposes of this section, "use" means the consumption of fuel for heating, agricultural, or railroad purposes, or for industrial purposes other than in the performance of a contract with any unit of government. If any fuel subject to tax by this section was subject to tax in any other state or its political subdivisions, the tax in this section applies but at a rate measured by the difference between the rate imposed in this section and the rate imposed by the other state or its political subdivisions. If the tax imposed by the other state or its political subdivisions is the same or greater than the tax imposed by this section, no tax is due. The provisions for credit in this section apply only if the other state or its political subdivisions allow a credit with respect to the tax imposed by this section which is substantially similar in effect to the credit provided in this section."

STATEMENT OF PURPOSE OF AMENDMENT:

The amendments increase the per-pupil payments for the 1991-93 biennium from \$1,531 to \$1,552 for the first year of the biennium and from \$1,587 to \$1,608 for the second year of the biennium. The amendments also provide a new section to the North Dakota Century Code providing that beginning with the 2000-2001 school year a school district with 25 or fewer high school students will not be eligible for state aid relating to these students unless the school district is cooperating with another school district in a plan approved by the Superintendent of Public Instruction.

SB 2169, as reengrossed: Committee on Appropriations (Rep. Thompson, Chairman) recommends AMENDMENTS AS FOLLOWS and when so amended, recommends DO PASS (20 YEAS, 1 NAY, 2 ABSENT AND NOT VOTING). The proposed amendment was placed on the Sixth order on the calendar.
