The **Committee on Senate and Joint Rules** be changed from nine members to ten members.

The Inaugural Planning Committee from three members to four members.

The $\ensuremath{\mathsf{Communitee}}$ on $\ensuremath{\mathsf{Correction}}$ and $\ensuremath{\mathsf{Revision}}$ of the Journal from three members to four members.

The Committee on Arrangements for Senate Committee Rooms from three members to two members.
